The time quickly sped by while those present were engaged in games of various kind; one contest, in which Mrs. E. E. Mass Meeting Nominates City Officers.

The mass meeting called by the city council for Tuesday evening at Rudolf opera house organized by electing Mayor L. Barnum as presiding officer; F. E. Fagan secretary; and Mrs. O. A. Ramsey and Miss Pierce as tellers.

On motion it was voted that the order of business should be the nomination of a mayor; the nomination of three councilmen to serve for two years; nomination of councilman to serve one year. As many nominations to be entertained as desired, the ones receiving the three highest or the highest in case of the one year term to be declared the nominees.

J. C. Freeman gave a short resume of the city finances; stating that about \$1000 in warrants were still outstanding as well as the bonded indebtedness, amounting to \$10,000.

J. C. Freeman and L. Barnum were nominated for mayor; Mr. Barnum declined and on motion Mr. Freeman was the unanimous choice.

Before the nominations for councilman were made it was stated that the qualifications for city office were that the nominee must be an owner of property or have \$250 worth of personal property.

Nominees for councilman for two year term were L. Barnum, O. A. Ramsey, F. A. Sayers, W. C. Rutledge, Mrs. P. H. Buxton, Mrs. O. B. Messinger, M. S. T. C. Lee, W. S. Powell, Mrs. Harry Kunsman, Mrs. N. P. Hansen. The last four declining the office. On balloting the first three were declared nominated.

Nominees for the one year term were W. C. Rutledge and Mrs. O. B. Messinger; Mrs. Messinger declined the office and Mr. Rutledge was nominated by the secretary casting the ballot.

The largest number of the voters ever at a mass meeting in Moro were in attendance. There being approximately 200 votes cast, half being by the women of Moro.

The High School Minstrel Show.

The minstrel show put on at Rudolf opera house Saturday evening by the Moro high school boys was a financial success, \$83 being the receipts of the house. When the curtain rose every seat was occupied by an interested auditor.

The jokes sprung by the boys were original and of local color and all present seemed to understand them, with the possible exception of those who were made the victims of the raillery.

As part of the entertainment of the evening special mention should be made of the orchestra; E. E. Barzee, violin and leader, Elmer Barzee, cornet, W. D. Wallan slide trombone, and Miss Marjorie Rose piano; their playing was as good as some theatre orchestras we have heard and better than many, it had that indefinite quality to it known as rhythm; which many musicians who keep perfect time never attain.

It is expected that the minstrel troupe will show at Wasco at some date in the near future.

A Reminder of the Days When Crinolines Was the Vogue.


Fifty-one private letters of Dr. E. Barthez, physician to the prince imperial, have been translated by Bernard Miall to form "The Empress Eugenie and Her Circle." A letter from Barthez (1838) describes the empress personally and discusses the fashionable amplitudes of the dress she wore. "All this stuff is supported by a sort of skeleton of flexible iron. The empress is greatly attached to this cage, which to us seems very ungraceful and inconvenient. She sticks to it in spite of the quips of the emperor, to whom she simply replies that she does not know how she lived so many years without a cage."

"I can only find two excuses for this fashion. One is that women who wear it have their legs free in walking and are not hampered by skirts and petticoats hanging on their calves and thighs and impeding their movements; the other, in her case, is that there is a sort of harmony between the amplitude of the woman and the size of the apartments in which she lives. * * * Here a dozen women adorn the salon admirably and are in harmony with the wide spaces, the ample seats, the width and height of the doors.
