The Silo as a Potential Money Maker

Missionary work is not always appreciated by those it is generally designed to reap the profit sown and grown from the experience and labor and loss of the originator and the pioneer user of a newer method of advanced business conditions.

Silos and feeding of ensilage has been advocated at different times by the Observer, in both the reading and the advertising sections of the paper. At first it was thought by those whom it could be made most profitable to be impossible of adapting to the average county farm and the expense of attaining that end was too expensive for the probable returns and benefits.

From a careless disregard of the subject the Sherman county farmer has begun to study the silo and its known benefits from the view of an interested possible future user of this modern conservator of farm food products, and we are sure that this time next year will see several silos in use in Sherman county.

It is to be regretted that as a farm building in Sherman county the silo is conspicuous for its absence, yet the success of the silo wherever tried has been remarkable. Farmers of western Oregon and Washington, where a few years ago a silo was unknown, are rapidly adopting it as a means of storing green, succulent feed for beef as well as for dairy cattle.

For dairy cows, ensilage is about the only practicable substitute for green grass and the importance of having green feed for milch cows in winter, when dairy products are scarce and high, can easily be appreciated. Instead of having green feed for his cows for a few months only the silo easily gives the farmer this much coveted article the year round.

Sherman county is a natural cattle country and from the standpoint of profit, stock raising and dairying will bring much greater returns for the time and money expended than almost any other type of farming. The more there is of good horses, the more beef cattle, dairy cows, and hogs there is in Sherman county the more money will stay in the pockets of the farmer.

It does not require special or technical knowledge to handle a silo. D. E. Stephens, superintendent of the experiment farm at Moro, will help any one to a better understanding of the subject. Corn is recommended as the best crop to grow for ensilage, and a good yield per acre is possible and has been proven. Wheat and other grain crops can be used profitably in a silo and even weeds.

Farmers in Wyoming and adjacent states are using the russian thistle and other farm weeds with which to fill their silos, using 30 pounds of russian thistles, 10 of hay and one of grain and obtain the same result as when they fed 24 pounds of hay and one of grain. A result that show a weed can be made useful.
