Old buildings are being torn down and ground cleared by the Tumalum Lumber Company preparatory to building a model handling system for coal, lime, plaster and cement. When completed the building will be 16x100 feet, having five bins for coal, each with a holding capacity of more than a car load, and one bin for lime, plaster and cement.

The Tumalum Lumber Company will sell the old barn building at the foot of First street cheap to anyone wanting to tear it down for rough building purposes. The barn is 46x60 feet, has corrugated iron roof, heavy flooring and best of manger construction. During the last week there has been nine bank failures in the state of North Dakota and the suspension of a large news paper in Aberdeen. The banks failed because farmers had refused to sell their wheat and thus forced the banks to fail to meet their obligations. The paper was run in the interest of the non-partisan league. It would appear that there is a lack of cooperation in the Dakota states.

The collection of interest due this government from foreign treasures, the collection of back taxes due from corporations in this country, and the collection of reasonable import duties on wheat, eggs, and other farm products, will produce a sum close to one billion five hundred million dollars a year and make possible the elimination of the excess profits tax, a reduction of the income tax, and obviate the necessity of devising new tax levies to take their places.

Cards have been received announcing the marriage of Miss Ida Myrtle Montgomery to Mr. Charles Irven Blair at the home of the bride's parents at Sifton, Washington, on Sunday, November 21st. The bride is a daughter of Mr. and Mrs. S. D. Montgomery, former residents of this city, now residing in Clarke county, Washington. The family have a large circle of friends and relatives in Sherman county who join in wishing the young couple a prosperous and happy life.

According to the office of the secretary of state, between January 1st and October 31st, 1920, Sherman county has registered 964 automobiles and five motor cycles. In addition there has been 76 transfers of old machines to other drivers during the license period. There are 15 registered dealers in the county, 19 chauffeurs, and a total of 1127 regular and special operators licensed. A total of \$20,947 has been collected by the state during the same period as license fees, of this amount Sherman county will receive, under the auto license law, an apportionment of \$1124 to be placed with the county road funds.
