## Farm Bureau Meetings

The Sherman County Farm Bureau will begin its membership campaign for 1922 with meetings at Wasco, Moro, Grass Valley and Kent. It is planned to hold afternoon meetings in the theaters and show the famous Farm Bureau film "Spring Valley." A speaker from the State Farm Bureau office will be on hand to explain the relationship of the Sherman County Farm Bureau to the Oregon and American Farm Bureau Federation.

The dates of these meetings are not definitely set yet as we must wait our turn for the film and speakers but it is hoped that they can be held January 25-6-7-8. You may expect a letter from the County Agent in time to notify you of the date.

The "Spring Valley" film is a dandy and you will be sure to enjoy it. Some good music will be provided for these meetings. The programs are free to every one. All are cordially invited. Tell your neighbors.

## Returns from State Convention

The latter part of the past week Supt. Zevely returned from the Superintendents Convention held at Salem. She reports a most successful meeting. Problems of vital interest to every superintendent were discussed, with State Superintendent J. A. Churchill presiding.

The matter of granting permits to teachers came up for spirited discussion. It was agreed that the war conditions that made permits necessary had passed and that there would be a decided tightening up on the issuing of permits throughout the state.

The questions of consolidation, institutes and records were among others that were given time in the discussion.

One session was given to the discussion of the County Unit Plan of school administration and taxation by Superintendent J. E. Myers of Crook county. Crook has the distinction of being the first county in the state to adopt this plan. Superintendent Myers gave an outline of the campaign in putting the matter up to the vote of the county and of the success of the system thus far. He reported the outstanding advantages up to date as being a general improvement in the uniformity of equipment of the rural schools and especially their ability to manage supplies for the schools in a more business like manner than under the old system.

## The Play of An Age

The religious motion picture, "Behold the Man," which was presented after noon and evening on January 17th in the opera house to exceptionally large audiences, might be termed a triumph of artistic genius. The picture, shown in natural colors, followed closely the life story of Jesus Christ incorporating all the high points of His existence upon earth, and in doing so gave in detail the habits and customs of the people of that time. It is well for the morals of the world that such a story finds its way to the screen. Some argue against the commercialization of the story of the Christ. It is granted that some one is making money in presenting this film. But the harm done is negligible beside the good that comes from imbedding the spirit of Christ in the hearts of thousands who might otherwise not have known Him as well. Many people do not go to church. Many do not go often enough to retain a connected and concrete picture of the life of Christ. Visual education is the most lasting. The screen reaches millions that the Church does not. It is possible for the screen to be a powerful evangelist. "Behold the Man" is an indestructible pillar in support of Christianity.

A college romance came to a happy climax last Saturday, January 14th, when Edward L. Ward of Dufur and Miss Clara Thompson, daughter of Mr. and Mrs. Hars Thompson living east of Moro, were quietly married at high noon at the home of Mr. and Mrs. Roy Kunsman, in the presence of witnesses only. The nuptial knot was tied by Rev. Henry G. Hanson of the Presbyterian Church. The bridegroom was a graduate of the University of Oregon last spring, a member of the Phi Delta Theta fraternity, majoring in Sociology. The bride who was brought up on the farm near Moro, was a graduate of Albany High School in 1916, of Monmouth Normal School in 1918, and of the University of Oregon in 1921. In college she was a member of the Chi Omega sorority, her major study was English. They will make their home on a farm near Dufur, where the bridegroom has already been at work for a few months laying the plans for their future home. ## Imports Blooded Stock

There are some men who make their money in Sherman county who spend it for the advancement of that county. They do not move to Portland. Their interests lie with their fellow men, with the home town and the community in which they live. The continued propagation of pure blood stock in this community is a step forward. J. N. Landry has purchased two 2-year-old sorrel Belgian mares, these three averaging 1900 pounds each; and a 3-year-old sorrel Belgian stallion, weight 2260 pounds, shipping them from Sunny Side, Washington, January 12th. The original Belgian color was sorrel with a lighter mane and tail, so this is one of the many fine points that distinguish three of Mr. Landry's new horses as being doubly worthy of their pedigrees. Already Mr. Landry has a small stable of Shire stock, but it is his intention to maintain two separate breeds, possibly eliminating the Shire within a few years.

Further plans will be announced later, but all young people of the community should reserve that evening and be on hand with a sociable disposition. The Christian Endeavor prayer meeting next Sunday evening at 6:45 will be led by Miss Iala McCain, on the theme, "The Golden Rule in Business" or Christian principles applied to buying and selling.

The usual service of worship and preaching will be held in the Spalding Chapel next Sunday morning.

Next Sunday afternoon a special service for men only will be held at the M. E. Church. Time 3:00.

To add interest in the special meetings various organizations have at times been responsible for the service with the exception of the preaching. Last week the Ladies Aid society, the Dorcas society and the public schools were the special guests as well as furnishing a part of the program. Wednesday night of this week the men were in charge. In all cases there were large increases in attendance, and special numbers helped greatly.
