**COUNTY COURT DOES MUCH
WORK AT TWO-DAY SESSION**

February 7th is Date Set for Convening of Next Month's Court

The following business was transacted at the term of county court held January 3 and 4, 1923.

Bill of A. H. Barnum for indemnity claim for cattle condemned and killed. Continued to March term.

Application of the Sherman County Observer for appointment as official county newspaper for 1923. Granted.

A warrant was ordered drawn for \$1642.30 from the highway bond fund to reimburse the general road fund, account material and fencing for the Sherman highway.

Report of the Board of the DeMoss Springs memorial park. Material, \$240.20; labor, \$528.25; balance on hand, \$231.55. Committee: R. C. Byers, Roy F. Dean, Willford Belshie. Accepted.

In the matter of the establishment of a road in districts No. 1 and 13, known as the Medler road. Board of county viewers ordered to meet March 14th, view the road and report at March term.

In the matter of the resignation of the Sherman county fair board and their recommendation that the budget appropriation of \$2000 for the maintenance of the county fair for 1923 be applied to county agent work. Resignations accepted and recommendation rejected. The secretary and treasurer of the Sherman county fair board were notified to furnish the county court with a report for the year 1922.

In the matter of the location of a road in districts No. 5, 6, 7 and 15. The county court upon its own motion declared a public necessity exists for the opening, laying out and establishing of a road in said districts, beginning at the terminus of the recently constructed macadam on the Monkland road near the residence of J. C. Hockman, thence easterly by way of Monkland a distance of approximately six and one-half miles to the southeast corner of Section 9 Township 1 South Range 18 East.

In the matter of the location of a road in district No. 2. The county court upon its own motion declared a public necessity exists for the opening, laying out and establishing road in said district, beginning at a point in the Sherman highway 435 feet west and 400 feet north of the quarter section common to Sections 30 and 31, Township 2 North Range 17 East, thence in a northerly direction a distance of approximately one and one-quarter miles to a point 600 feet north and 150 feet east of the quarter section corner common to Sections 19 and 20, Township 2 North Range 17 East.

In the matter of the location of a road in district 11. The county court upon its own motion declared a public necessity exists for the opening, laying out and establishing of a road in said district, beginning 500 feet north of the quarter section corner common to Sections 22 and 23, Township 4 South Range 16 East, thence in a westerly direction following the high ground as nearly as possible to the west line of the northeast quarter of

Section 22, said township and range, thence in a southwesterly direction to the quarter section corner common to Sections 27 and 22, Township 4 South Range 16 East.

Petition of Grace M. Zevely, county school superintendent, for change in school districts 20 and 21. Continued.

Petition for establishment of road in districts 1 and 13, known as the Medler road, was read the second time and continued until March term.

Application of C. E. Johnson to audit the county records for the year 1922 for the sum of \$200. Accepted.

Petition for a road from Condon, Oregon, to Kent, presented by Gilliam county parties. Not allowed.

Ordered that the road between Sections 21 and 22 Township 4 South Range 17 East be closed.

Report of Sheriff Hugh Chrisman dated November 10th and January 2nd. Accepted.

A list of 200 names was drawn for duty as circuit court jurors for 1923.

P. C. Axtell and G. C. Vinton were appointed county road viewers.

Dr. W. N. Morse was appointed county health officer, salary \$100.

Dr. C. L. Poley was appointed county physician, salary \$270.

H. S. Wall was appointed county road master, salary \$3000.

Road master H. S. Wall's report for 1922 was accepted.

A. M. Zevely was appointed deputy county school superintendent; salary, \$1.00 per year.

James Stewart was appointed stock inspector.

Hugh Chrisman was appointed treasurer.

Report of county clerk. Accepted.

Court was adjourned to February 7, 1923.

Henrichs' Set in Moro Brings in Music and Voices from Far Points

Stories, addresses, orchestra and vocal selections were heard distinctly, coming from transmitting stations at Portland, Oregon, Los Angeles, California, and Calgary, Canada.
