Paragraphs on State, County and Community's Events

Ben Tomlin and family are now at home in the living rooms over the Brisbane furniture store.

Roy Powell is concluding arrangements to begin seeding 700 acres of summer fallow next Monday.

W. C. Campbell is building a house for Wm. Ross on his farm east of Moro, replacing the residence recently destroyed by fire.

For the one day only next week the Moro Theatre will advance the Tuesday show to Monday. This was made necessary to permit showing at this time "The Third Alarm."

Mrs. P. J. Stadelman, wife of Mayor Stadelman of The Dalles, died at The Dalles hospital Tuesday morning just as an operation for ulcer of the stomach was being concluded.

Mrs. C. H. Ellsworth is having the Ellsworth Hotel building repainted a soft brown-trimmed with cream. A new brick chimney has also been built to take care of the kitchen range.

The electrical storm of last Monday evening frightened three horses owned by T. B. Searcy in the Boardman district, driving them through the wire fence. One was injured to such an extent that it will not be used during harvest.

C. J. Thompson and family will visit in Eugene the week of July 19th, later making the trip to Belknap springs near Eugene. Mr. Thompson is a delegate from Moro Presbyterian church to the meeting of Synod at Eugene.

Mrs. W. B. Johnston is at the Perry Johnston farm in Gilliam county near Condon, where she has charge of the work during the absence of Perry Johnston and wife who were called to Portland last week by the death of Mrs. Perry Johnston's father.

C. V. Campbell was taken to The Dalles this week by Dr. Poley for the purpose of having an x-ray examination made of his injured leg. The injury was caused when a truck, driven by W. C. Campbell, son of C. V., was backed off the highway grade near Mosier. The top of the cab caught his leg, pinning him to the ground.

Dr. Poley was called to Wasco Tuesday night to attend Wallace Fields, cousin of I. E. Fields. Because of the serious nature of the illness, Fields was taken to the hospital at The Dalles about midnight, where he died about ten minutes after arrival. An aggravated case of diabetes was said to have been the cause of death.

"The Third Alarm"

"The Third Alarm" is a story of home and home life. It is a story of the dangers of a fireman's life; of the fine traditions of the American Fire Department in the larger cities of the United States.

The theme of the story is woven around the life story of Dan McDowell, twenty years a driver of Engine 27, who becomes a discard of the fire department in his old age.

For twenty years Dan McDowell had sat on the driver's seat of Engine 27 and urged his three horses on to the flames. Then came the motor apparatus. The horses were sold—as so much junk. Dan's hands were too old to master the steering wheel. He was a discard, retained at a small pension.

Johnnie, his son, was studying medicine. To keep him in college required money. Dan, after a weary search, was reduced to digging in the streets. Johnnie learns of this, quits college, and joins the fire department—as his father did twenty years previous.

In his work on the streets, Dan meets "Bullet"—his old favorite fire horse—pulling a dirt cart; man and horse discarded as useless.

One day "Bullet" disappears. Dan's humiliation is complete when he is accused of stealing the old fire horse, that he loves so well. He is released from jail when a newsboy tells how he found the horse wandering on the street and had put him in Dan's small barn.

Dan is released from jail in time to go to a "Third Alarm" fire. He meets "Bullet" who has again broken loose when the "Third Alarm" sounded. At the fire Dan and the old horse rescue Johnnie and his sweetheart from the flames.

Things end happily for the McDowell family. The son is able to finish his medical studies and old Dan spends his last days caring for the discarded fire horses, who have been pensioned by the fire department.

The horse which takes part in the stirring episodes of "The Third Alarm" is none other than "Bullet" oldest horse of the fire department of the City of Los Angeles, from which he was borrowed especially for the fire scenes in "The Third Alarm."

"Bullet" has been to more than a thousand fires in his day. He is now more than twenty years old and has been retired and pensioned on an old farm for almost five years. When he was required to plunge through a wave of flames with a rider on his back and then haul and tug with a rope about his neck until he pulled a huge safe out of the blazing ruins and liberated a boy and a girl from their peril, he went right about the job and no questions asked.

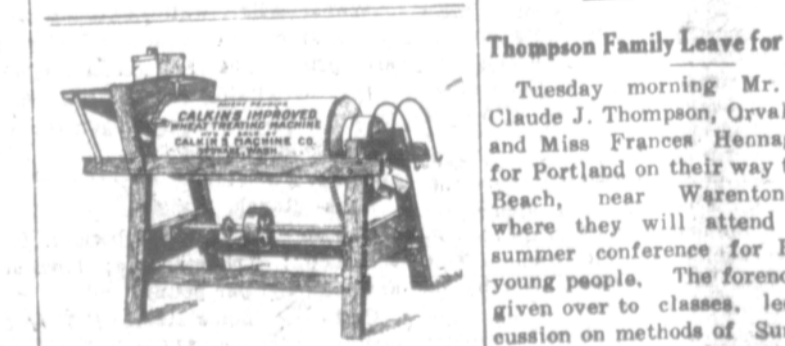
Church Plans Sacred Concert Sunday

Christian Stops Absconding Debtor

C. H. VanHutton, operator of a dairy farm near Wasco, was arrested in The Dalles Wednesday evening on a warrant issued to Sheriff Hugh Christman charging larceny by bailer. The warrant was based on a charge of selling mortgaged cattle. It is said that VanHutton hired a truck to come to Wasco from The Dalles, into which he loaded his personal belongings and left at noon on Wednesday. His creditors ascertained that he had gone, had the warrant issued, and VanHutton was apprehended that evening in a rooming house in The Dalles where he and his three children were located for the night. When arrested he had \$1435 in cash and some change on his person.

Sheriff Christman brought VanHutton back to Sherman county Thursday morning. Paul Childers, of The Dalles, was retained as attorney by VanHutton and Ira M. Peterson acted as attorney for those interested in the arrest of VanHutton. Trial of the case was to come before Justice A.M. Young that afternoon, but before court was called VanHutton, through his attorney, settled all claims out of court, the action was dismissed and VanHutton released from custody.

Too Much Tampering With U. S. Mail
