Supt. Stephens Tells About 6-foot Wheat

Supt. D. E. Stephens, of the Experiment Station, returned Thursday morning from Pendleton where he was called by the Pendleton commercial club to discuss the advisability of establishing an experiment branch station near that place. It is proposed to inaugurate the station with private funds and later be assisted by state appropriation. Crop rotation instead of summer fallow is the ultimate desire of those interested in having the station established in Umatilla county. Mr. Stephens reports having seen wheat fields in Umatilla county with standing grain six feet high and thick enough on the ground to please any farmer. He also said that there was 100,000 acres of federation wheat in that county of which about 30,000 acres was hard federation, all of which is looking fine.

When visiting over night in Moro this week, two ladies from the Willamette valley had their tresses neatly trimmed by Joe Truitt at the Main street tonsorial parlor. They said they had been always so well satisfied with Mr. Truitt's painstaking efforts to please that they waited until they reached Moro before having the work done.
