George Belknap, of Moro, was one of the 17 members of the Sherman county class at the U. of O. to be elected to Phi Beta Kappa, national honorary scholastic fraternity, in recognition of outstanding scholastic achievement.

Including seven persons elected this fall, a total of 24 students have been chosen from the senior class this year, or eight per cent of a class of more than 300.

Rules of the organization prevent election of more than 10 per cent of the seniors. Belknap, who is a major in philosophy, was initiated Thursday, May 6, when joint ceremonies were held by Phi Beta Kappa and Sigma Xi, honorary science fraternity.

Mrs. H. Rexroad, in a letter to the secretary of state, has appealed to the state authorities to assist in the protection of rhododendrons which grow abundantly in the vicinity of Devils lake on the Roosevelt coast highway a few miles south of Neskevin.

The formation of a new road district and the levying of a two-mill tax for improvement of the road between Halfway and Homestead has been proposed by William Doby, chairman of the state highway commission and endorsed by the Baker chamber of commerce.

Arnold Bennett Hall, professor of political science at the University of Wisconsin, unanimously was elected president of the University of Oregon by the board of regents. He succeeds the late president, Prince L. Campbell. Dr. Hall has accepted the position.

HOSPITAL NEARS COMPLETION

First contributions to the Doernbecher hospital fund campaign are coming in, according to an announcement by the U. of O. committee, the largest of which is maintenance fund which the state American Legion raised.

Chapters of the Legion in all parts of the state are cooperating in securing this money which was voted to assure operation of the hospital after the executive veto of the legislative session. Money is now needed, the committee announced, to allow opening of the hospital which is nearly completed. Citizens in various parts of the state, including Dallas, Bend, Eugene, Moro, and La Grande have contributed.
