

Two Days Grain Grading School Held at Moro

A grain grading school for elevator and warehouse operators and managers was held in Moro Wednesday and Thursday of this week. A complete equipment of grain grading apparatus was used, including motion pictures showing the proper method of sampling grain, the unloading and loading of cars, the method by which grain is sampled and tested when shipped for ocean transit, and a complete survey of inspection problems from country to terminal markets.

The purpose of the school was to better acquaint warehouse men with federal grain standards, the proper loading of cars, and other matters pertinent to the grain industry, by a thorough presentation of laboratory procedure.

This traveling school for grain men was made possible by the cooperation of Federal Grain Supervision, U. S. department of agriculture, Oregon State Grain Inspection department, which is under the direction of U. S. state market agent, and the extension service of the Oregon State College.

The school at Moro was conducted by R. E. White and G. K. Landers of the U. S. department of agriculture, C. W. Wright and A. V. Butts of the Oregon State Grain Inspection department, and D. E. Stephens of the Moro Experiment Station.

Bankers Meet at The Dalles

Saturday evening, May 3, a group of seventeen bankers comprising all the banking interests of Klickitat county, Wasco county, Hood River county, the Arlington bank of Gilliam county, and the Moro State Bank and Wasco State Bank of Sherman county, met at The Dalles to discuss various business matters that would place banking on a better basis, induce more cooperation between customers and the banks, and develop greater ability to serve the public in an effort to improve banking facilities that would result in greater benefit to their customers. Those attending the meeting as representatives from Moro State bank were J. L. Searcy, P. C. Axtell and R. H. Coppock.

Six Cent Gain Noted

The grain stabilization corporation May 8 reported it had completed the sale of all wheat owned by it at sea-board and gulf ports.

"The sales were made at continual advancing premiums as compared with the May futures," said George S. Milnor, president. "In fact, last sales are on a basis six cents higher than a few weeks ago."

"Sales of wheat to millers for export in the form of flour have in no case been on a lower basis than export wheat sales," he added.

United States meat production declined slightly in 1929, says the bureau of agriculture, reporting total production of dressed meat, not including lard, at 16,803,000,000 pounds in 1929, against 16,955,000,000 pounds in 1928. Per capita consumption of meats, excluding lard is placed at 136.8 pounds in 1928.

Politics Is a Business and Business is Politics

Two things stand out in the news of the nation in the last ten days that is of much importance to every farmer in Sherman county and in the nation at large as well.

One is the fight made on the federal farm relief board by the national United States Chamber of Commerce at its annual meeting where 1500 members protested vehemently and passionately that the federal farm board was undermining private business through its system of applied relief to the farming industry in its effort to bring as much comparative industrial returns to farmer operators as is granted to the railroads, the large labor unions, and other organized business systems through national laws.

Another is the notice served upon the members of the national congress from western states that they would be opposed for reelection if a tariff tax on lumber and shingle products was not included in the tariff bill about ready for the consideration of President Hoover.

Both of these movements were sponsored by both republicans and democrats. Their pocket books were the factors that caused these men to oppose party interests in favor of their own selfish interests and regardless of what loss that may cause to the farming industry of the United States.

A third matter of news was the meeting of the congressional committee to examine the expense accounts of candidates for national office.

In former years there was always much said in partisan papers about the good effects that would ensue to the rank and file of the various parties if they would only stand by their party nominees for office. Yet the congressional committee on campaign expenditures was brought into prominence because it was found that large groups of business men were buying favors from both parties at the same time in the same campaign by means of contributions to the funds of the opposing parties.

The Sherman County Observer sincerely believes that if the farmers as a business unit in the industrial scheme of the nation want to be considered when the favors are passed around they should vote for the candidate who would be most likely to listen to their spokesmen leaders after they are elected to office.

There are ten candidates for the office of governor for the state of Oregon at the primary election to be held next week. Two of these candidates will oppose each other in the election next November. It is just as important for the farmer to work and vote for his own interest as any other business man. Just as the lumber industry and the large wheat dealers made plain they would do in the news of last week.

Politicians and business men analyze the mass vote of a section in practically the same manner as a doctor diagnoses a patient before prescribing.

If the mass vote follows what is said to be "regular" party interests, all the protesting after election is never seriously considered by the politician leaders. This was brought to national attention during the time of making the platforms of the two major parties at the start of the campaign previous to the election of Hoover as president of the United States.

The farmers of Oregon need a man in high place who will fearlessly stand with them in their efforts to combat the private business grasping greediness now manifest in the sometime open fighting and the underhand methods of combat engaged in to wreck the federal farm board and restore conditions to former grinding back breaking uncertainties.

The Sherman County Observer believes that the farmer would best serve himself if he, when voting next Friday, mark his ballot for George W. Joseph for the republican nomination for governor. He has a great deal better chance for nomination than the newspapers of the state are willing to make known. He is a fighter for what he believes to be the right than any other candidate for the office. When in Portland last week we saw a bet made between two men in a cigar store of four to one on Joseph against the field. The Joseph man taking the big end of the bet. There was nothing said in the papers about this bet being made.

There is a considerable sentiment being made in Sherman county in favor of a certain candidate for the republican nomination because he is "not high hat" and that his wife is a good cook and he himself is a fairly good man with a pack train. Any man in Sherman county can measure up to office holding requirements on this kind of a platform, but will such qualifications for office increase the price that may in the future be paid for wheat produced on the farm of the man who holds that to be sufficient endorsement for election to high office.

At the age of six months, the family moved to Butte county, California. In January, 1882, Mr. McDaniel moved to Sherman county, where he filed on a homestead and farmed until he was appointed deputy county clerk and later elected county clerk for five successive terms.

He was married February 15, 1891, to Mary Cushman. The family moving to Portland about 18 years ago. He was a member of Moro Eureka lodge 121 A. F. & A. M., and Moro lodge 113 L. O. O. F.
