to a vote of the electors of said town at a special election, and such proposition shall receive a majority of all the votes cast at such election.

12. To prescribe fire limits and prohibit the erection and repair of wooden buildings within such limits, and prescribe the requirements and character of all buildings to be thereafter erected within such limits, and provide punishment for the violation of such requirements; and to provide for the removal of any and all buildings erected contrary to such requirements at the expense of the owner or owners thereof; to cause the owners of all buildings to keep them in a safe condition as to fire and danger of falling, and condemn the same when unsafe, and to cause the same to be repaired or removed at the expense of the owner thereof; to regulate and control all public halls and buildings used for public gatherings and prevent public gatherings in the same when they are unsafe or dangerous or have not sufficient or convenient means of exit in case of accident or fire.

13. To regulate and establish the fees and compensation of all the officers of the town; to provide fire engines and other apparatus for the extinguishment of fires, establish fire companies and regulate the same, and to appoint officers of such company or companies and prescribe their duties.

14. To lay out, establish, vacate, widen, open and extend streets or parts of streets and alleys or parts of alleys in said town; and to lay out, establish, erect, construct and maintain any and all public parks, public grounds or public works provided for in this Act.

15. To provide by ordinance for having domestic and other animals found running at large within the town limits restrained, impounded and forfeited, and may sell the same when forfeited, as provided by law for execution sales of personal property, and apply the proceeds as it deems expedient; and in the case of dogs may, when they are found running at large without a license, cause them to be killed or disposed of after such period of detention as may be prescribed.

16. The town of Central Point may recover from any person or persons and their estates the expense for care and treatment when sick, which may have been provided by the town and for which the town may have incurred liability or been put to expense in their behalf of any person or persons whom by law they are bound to support, and an action therefor may be brought and maintained in any court of competent jurisdiction.

17. To maintain and improve cemeteries and sewer farms, to regulate the same and to exclude cemeteries from the limits of the town or any portion thereof and to discontinue the same. The common council shall have full jurisdiction over all cemeteries belonging to the town, whether within or beyond the town limits.

18. The common council shall approve all official undertakings and all bonds running to the town, and all such bonds shall be filed with the recorder, except the bond for the recorder, which shall be filed with the town treasurer.

19. At the close of each fiscal year, which shall be on the 31st day of March in each year, the common council shall cause to be published in some newspaper published within the town, if there be one, a full and detailed statement of all money received by the town government during the preceding twelve months, and on what account received and expended, classifying each receipt and expenditure under its appropriate head.

20. No member of the common council shall, during the term of his office, be interested in any contract with the town; and all jobs or contracts for constructing, repairing, ornamenting or improving any public place in the town, improving streets or building sewers, the expenses of which are to be paid out of the town treasury, and the probable cost of which will exceed \$250.00, it shall advertise for ten days for bids therefor, to be done according to the specifications approved by the common council and made public at least ten days before the closing of the bids for such job or contract; Provided, that the council shall have the right to reject any and all bids without incurring any liability for such rejection; and Provided further, that whenever, under any ordinance or resolution of the town, the common council shall have failed to obtain a satisfactory bid for the performance of the labor and the furnishing of the material embraced in any projected improvement of the streets or alleys, the building of sewers, or for the execution of any other public improvement, for which proposals have been invited, by public advertisement, the common council may, by a two-thirds vote of the council, undertake and perform such improvement and furnish the material therefor under the direction of any competent person selected by the council for such purpose.

ARTICLE VIII.

Section 1. The mayor is the executive officer of the municipal corporation and must exercise supervision over the general affairs of the town and over appointive officers. He shall, at the last meeting of the council in March of each year, communicate to the council by message a general statement of the condition of the affairs of the town and make such suggestions and recommendations as he may deem proper, and make such special communications to the council from time to time as he may deem proper.

Section 2. He shall sign all orders and warrants drawn on the treasurer by the recorder for claims that are audited and allowed by the council, and not otherwise.

Section 3. He shall perform such other duties and exercise such other authority as prescribed by this charter or as may be prescribed by any ordinance of the town, and any law of this state or any law of the United States.

Section 4. The mayor shall not be allowed to vote on any ordinance or measure before the council, except in case of a tie vote, in which case he shall have power to vote, and must vote either in the affirmative or in the negative.

Section 5. The mayor must, within five days after the passage of any ordinance or resolution, either approve or veto the same, and an ordinance or resolution shall go into effect until approved by the mayor or passed by the council over his veto.

Section 6. The mayor shall, in case he vetoes any ordinance or resolution, file such veto with the recorder, together with the reasons for his disapproval, which veto and message of disapproval shall, at the next meeting of the council, be read, and such ordinance or resolution be put upon its passage again, and if two-thirds of the councilmen shall vote in the affirmative it shall become a law without the mayor's approval, but not otherwise.

Section 7. In passing all resolutions and ordinances the yeas and nays must be called and a permanent record made of the vote thereon.

Section 8. The mayor shall have and receive such compensation as shall be determined by the council from time to time for any onerous or special services required of him.

Section 9. In the absence of the recorder at any meeting he shall appoint a recorder pro tem, and in case of the absence of the recorder to perform his duties at any time, or in case of a vacancy in the office of the recorder, the mayor shall perform such duties and shall have full power and authority to try and determine all offences for violation of the town ordinances, the same as might be done by the recorder in case he were present and acting.

ARTICLE IX.

Section 1. The recorder is the judicial officer of the town and shall hold his court in the town hall or such other place as may be provided by the council. His court shall be known as "Recorder's Court, Town of Central Point, Oregon." He is also ex-officio town auditor and clerk of the council and shall keep a plain and correct record of all business and proceedings and of all judicial business when the town is a party thereto. It is his duty to take and file all papers presented to him officially, and take charge of and safely keep all files, records and papers of the corporation.

Section 2. The recorder shall have full and exclusive jurisdiction within the corporate limits of the town in both civil and criminal matters, and shall be subject to all the general laws of the state prescribing the duties of Justice of the Peace and the mode of performing them; but in any proceeding for violation of a town ordinance, which does not constitute a crime within the trial jurisdiction of a Justice of the Peace, the trial shall be without a jury, unless the defendant, on demanding a jury, shall deposit in court a sum sufficient to pay the per diem of each juror for one day, and not otherwise, but any jury chosen shall be chosen from the residents and legal voters of the Town of Central Point.

Section 3. All fines collected for violations of ordinances shall be paid to the town treasurer, who shall receipt therefor, and the recorder shall make monthly report thereof to the council.

Section 4. The recorder shall issue all licenses authorized by town ordinances or by any special order of the council upon payment to him of the amount required therefor. He must draw all orders for the payment of money, after having been allowed and appropriated by the council and against the proper funds, and together with the mayor, sign the same.

Section 5. The recorder must keep full and accurate books of account, showing moneys collected and appropriated, the date and amount of all orders and warrants drawn and to whom and for what purposes, and all such other matters and things as may be required of him by the council, and he shall report at each regular monthly meeting of the council the collections made by him in the different funds, accompanied by the receipts of the treasurer for the amounts so collected.

Section 6. He shall, as soon as the council shall make a general levy of taxes for the town, certify the same, together with any and all special benefit assessments and penalties as may be due and unpaid, to the clerk of the County Court.

Section 7. The recorder shall record in a book, to be kept for that purpose, all ordinances and resolutions passed by the common council, and the same shall be signed by the recorder and signed and approved by the mayor therein, and shall state the date of such approval, and the record thereof so made shall be received in any court of this state as "prima facie" evidence of the passage of such ordinance. And when the ordinances and resolutions of the town are printed by authority of the council the printed copies thereof shall be received as "prima facie" evidence that such ordinances and resolutions were duly passed.

Section 8. In pleading the existence of the Town of Central Point, it shall be sufficient to state in such pleading that the same is an existing town, duly incorporated and organized under the laws of the State of Oregon. And in pleading any ordinance or resolution of said town it shall be sufficient to state the title or such ordinance or resolution, and the date of its approval by the mayor or passage by the council, whereupon the court shall take judicial knowledge of the existence of such ordinance or resolution and the facts and effect thereof.

Section 9. All persons shall be required to attend the recorder's court, upon being duly subpoenaed, and for refusal or upon neglect to attend, may be punished for contempt under like proceedings, and to the same extent as in a justice's court, and no witness summoned within the town to attend on any trial before the recorder's court for the violation of any town ordinance shall be entitled to any witness fees or compensation.

Section 10. The willful absence of the recorder from the town for more than thirty days, without the consent of the council, and gross carelessness and willful inattention to the duties of the recorder, shall be grounds for the council to declare the office vacant, but he shall not be removed from office without notice.
