



THE THAW CASE.

The jury in the Thaw murder case returned a verdict of not guilty, on the grounds of insanity on the defendant, and Thaw is now an inmate of the asylum for the criminally insane. It is probable his detention there will be but for a short time, as it is expected he will be able to convince the lunacy commission that he is not dangerous to the public if allowed his liberty.

Thaw's acquittal is less due to his money than to the character of the reprobate whom he killed, as the American people are getting good and tired of the antics and amusements of creatures of the Stanford White class. Thaw himself is nothing more than an addle-headed representative of the idle rich class and it is probable that the only act of his life that might possibly be termed a benefit to society was his "removal" of White. The public will be relieved to know that the case in all its nastiness is ended and that the curtain may now be permitted to drop.


