WHO BEARS BLAME?

It is certainly a poor indication that the "Bankers' Panic" is entirely over when men fight with each other for the opportunity to get work, as was reported from Cleveland last week.

But ought it not to be difficult for the law makers of this country to satisfactorily explain to their constituents how it is that they have permitted a system to remain in existence and are still doing nothing to prevent a recurrence of it or a betterment, that will make it possible for men to be so hungry or their families so hungry and work so hard to obtain, that they are willing to fight men perhaps equally hungry with themselves, or who may have families equally as hungry as their families and who need work as bad as they do, in order to get employment that will furnish the necessary food, clothing and shelter, to say nothing of the pleasures and enjoyments that every civilized man ought to be entitled to—and all at a time when the natural conditions for prosperity were never greater than they were when the panic struck the country or than they are right now with every line of production in the entire country, including production of the soil, of the mine, of the range, of the factory—production of every class whatever full to overflowing?

It is doubtless true that the common people cannot understand how those things can be. It is also doubtless true that most of their representatives in the legislative bodies of the nation and the states know but little, if any more, about it than the people themselves know, but many of them do know but are unwilling to apply the remedy under the belief that their political advantages lie the other way. And those who do not know have shown themselves so derelict in the performance of their duties, that the people owe it to themselves to retire them. If they cannot retire them from the party to which they belong they should retire them in the election by electing their political opponents—an operation which should be continued with absolute impartiality until some legislators are elected who will spend time enough to study the questions that voters have not the time to study out by reason of the fact that they have to work too hard to pay the taxes piled upon them by those same politicians.

BUILDING THE MACHINE.

Why should it be taken for granted, as is usually the case, that the senatorial delegation, the congressmen from their districts, the governors and state chairmen of political parties, should be the ones selected to attend the national conventions of their parties?

The impression always goes out from Washington that it is the proper thing to do to select those men as delegates to the national conventions. The reason given is that such selection is a sort of favorable recognition or indorsement of the work of the senator, congressman, governor or state chairman so selected. But there is generally more back of it than that.

Washington is the great political center of the country. Everybody there considers little else than politics, and this includes every person from the president

down, the president being the busiest of them all. Combinations are built, appointments are made, bills are passed, and all public business is transacted through some trade, political agreement or combine of some sort. The congressmen, the senators, and to a greater or lesser degree, the governors of states and state chairmen, are parties to these trades and agreements, so that the word is carefully sent out from Washington, and the people accept the suggestion without question, that these very men should be sent to the national conventions.

The real purpose is to carry out the agreements that have been made to deliver the public over as so many sheep, cattle, or other animals. Thus is a great, overpowering, political machine built up with but little effort at opposition from the people, who, alone, must pay the bills and suffer the consequences.

These men all have their influence exerted on public affairs; why would it not be better for the people to select other men to name the candidates and fix the platforms who are free from the influences which so strongly tend to machine politics? Are there not men in the republican party of the various states, or in the democratic party, aside from the officeholders, big enough, wise enough and patriotic enough for this duty and would it not be the part of wisdom for the people to see that different men are sent to the national conventions?—Boise (Idaho) Capital News.

H. M. Cake for Senator.

Prominent in Oregon as a champion of pure politics and an advocate of the eradication of the dangerous machine system is Hon. H. M. Cake, of Portland. Mr. Cake is seeking the Republican nomination for United States senator and is doing so in a way that appeals strongly to the people. He believes in the people and consequently believes in their election of United States senators.

Fortunately for those of us who have little admiration for a wearer of the senatorial toga who has achieved his exalted position by chicanery or political methods, Mr. Cake is nothing of a politician. He represents the other type; the reserved, conservative and able lawyer, who believes in the active policies of Roosevelt, and has unlimited hope for our state of Oregon.

Though his record is not a political one, Mr. Cake has probably done more towards the development of Oregon than any other private citizen. It was he who inaugurated the plans of development and advancement that are being so successfully accomplished by the Portland Commercial Club and the Oregon Development League. Mr. Cake was for several years president of the Portland Commercial Club and in that position brought it to its present state of efficiency.

Oregon at this time has sore need of proper representation in Congress. No one will deny that our growth and progress has been retarded by want of proper representation at the nation's capital.

Mr. Cake is an ardent admirer of President Roosevelt, believes in his policies and is convinced that it is to the nation's best interest that they be continued.
