LIQUOR LAW OF OREGON

District Attorney explains Oregon Liquor Law to People, which Takes effect January, 1

Medford, Ore., Dec. 6, 1915. Editor Central Point Herald, Dear Sir:

While all persons are presumed to know the law and abide by its provisions, the prohibitory law which becomes operative January 1st is so voluminous and far reaching in its provisions as to be the subject of much misconception. In the hope that a better understanding of the law may be had, and that we may all work together for a full and economic enforcement of it, I submit herewith a simple digest of its more salient features.

I desire also to announce that I intend to do all that is humanly possible to enforce its provisions fully, and to call upon all good citizens to help in the work. Public sentiment and fearless citizenship are the strong factors in law enforcement, and if the citizens of Jackson County will stand behind this law in the ratio that they voted for it I can assure them a complete and economic enforcement of it, but if they are careless in their citizenship in this particular they may expect law violation, employment of spotters and detectives, costly trials and consequent taxation.

I have discussed the enforcement of this law with the judges having jurisdiction of its violations and am assured that no clemency will be shown in the penalties imposed.

Registered pharmacists may sell ethyl (grain) alcohol for medicinal pharmaceutical, mechanical and scientific purposes and for external use and application, in the amount of not to exceed two quarts in a period of four successive weeks, to any one person, upon the filing of an affidavit by the purchaser showing the use for which the alcohol is intended, and the sworn statement of the applicant that he is not addicted to the use of intoxicating liquor or any narcotic drug. Every pharmacist engaging in the sale of alcohol as above stated must file with the County Clerk a bond in the penal sum of \$250.00 that he will not violate the provisions of this act.

Ethyl alcohol may be obtained for medicine only upon a physician's prescription, and druggists cannot carry in stock anything but ethyl alcohol. A doctor may administer other intoxicants to his patients, when necessary, but must give it himself from private stock, and he is not allowed to have any more than any other individual. The physician or pharmacist who is convicted of a second violation of the provisions of this act, in addition to a heavy fine and a jail sentence, loses his state license to do business in the state.

Any one person or family may receive not more than two quarts of spirituous or vinous liquors nor more than 24 quarts of malt liquor within a period of four successive weeks by making an affidavit setting forth the name of the common carrier, the point of delivery, the amount and kind received, the total amount of liquors of all kind received by him during the four weeks last past; that he is over 21 years of age, and not a habitual drunkard. This affidavit shall be sworn to before any agent of the carrier who is authorized by the law to administer the oath. These affidavits in blank form are furnished by the County Clerk to the agent of the carrier. Any person who makes a false affidavit is subject to prosecution for perjury, the penalty for which is two to fifteen years in the State Penitentiary. It is a violation of the law for any agent of a common carrier to knowingly deliver more than the above limit within four weeks, and any person receiving more than the limit within four weeks is also guilty of a violation of the act.

An express company, a railway company, street car companies, stage lines, drays; but not private individuals, unless wholly engaged in hauling freight or passengers, or both, for hire are common carriers within the meaning of the act. All packages of liquor accepted for shipment must be clearly marked in large letters, with the name of the consignor and the name and address of the package, and the place from which it was shipped. All deliveries must be made to the consignee in person.

Intoxicating liquors cannot be shipped through the United States mails. All places where liquors are manufactured, sold, or given away in violation of the law are nuisances. All resorts for drinking, and bottles, glasses, kegs, pumps, bars and other fixtures kept in and used in buildings, vehicles, boats or other places are nuisances and may be perpetually enjoined. Any landlord of any such place knowing or permitting such nuisance to be maintained is guilty of assisting in maintaining such nuisance, and in addition to the costs of suit in an action to enjoin the same may be compelled to pay an attorney's fee to the persons bringing the action. Where a tenant is convicted of maintaining such nuisance his lease is void.

No person can, either directly, keep or maintain, either alone or with others, any locker room, club room or similar place where liquor is kept for use, gift barter or sale, or for distribution among its members. It is unlawful to advertise liquor in Oregon by signs, bill boards, in newspaper, periodicals, or in any other way, either by the owner or an agent, and the mailing of circulars, price lists and order blanks is also prohibited. Owners of newspapers, or the property on which a billboard is located, if such advertisement appear therein or thereon are also in violation of the law.

It is unlawful to have liquor in one's possession at any dance, dance hall or public gathering. PENALTY First offense: By a fine of not more than \$500.00, or imprisonment in the County jail not more than six months, or both. Second offense: Not less than \$100.00 nor more than \$500.00 and imprisonment in the county jail not less than 30 days, nor more than one year. Third offense: Imprisonment in the county jail for two years.
