IT'S OVER, AND UNITY PREVAILS

This is a story once told by a Civil war veteran:

A foreign ambassador was in Washington, D. C., when the soldiers of the Northern army were marched through the streets of Washington and disbanded, at the end of the war.

He was worried over the possibilities of such a mass dispersal of soldiers at one point and intimated to officials of the United States government that rioting, looting, possibly even a coup d'etat against the government, would almost certainly result.

When his warnings were not heeded, and the parade of the Grand Army and its dispersal were carried forward, he took to the reviewing stand, shaking his head and fearing the worst—remembering how such things were ordered in Europe.

Hour after hour he watched the tremendous review roll by without sign of disturbance, or rioting, or any coup d'etat against the government.

To the cabinet member next to him he exclaimed, "What a people!"

America and the American way of expressing itself is still a hard thing for the old world to interpret. Day before yesterday, old-time friends were roaring and shaking their fists in one another's faces.

Today, no revolution, no coup d'etat, no more fist-waving.

America has spoken. The people abide by their own verdict.

Life picks up where the campaign banners were tossed away, and the whole nation marches forward again, shoulder to shoulder.

You can hear the wishful thinkers about division and disruption saying to themselves over across the water, shaking their heads in bewilderment and admiration, "Mein Gott! What a people!"—Oregon Journal.

A considerable number of them have died at their posts, that others might live and the seat of the Empire be saved.

Here in our own country there are no bombers to devastate our cities, no long-range guns to blast at our homes and industries and national monuments. But, all over the nation, firemen are doing a peace-time job that should be given far more recognition than it usually obtains. There has been many a jest concerning easy-living firemen, sitting about in their comfortable stations, talking and yarning and playing cards. But it isn't funny when an engine crew must enter a burning building that may collapse into an inferno of flame any minute. It isn't funny to have to fight a great fire when the temperature is twenty below and the spray from the nozzles turns at once to ice. It isn't funny to put on masks and asbestos suits and try to control an oil fire generating thousands of degrees of blazing heat.

The fire department is any town or district's first line of defense against an enemy that is as destructive as war. And a first-class fire department is any town's best investment. The fire-fighters of London are making the headlines with a service that is as vital in peace as in time of battle.

Make America strong by making Americans stronger! The health and strength of every person in our country is just as important as guns and airplanes in building our national defense. And the health and strength of an individual depend in large measure on the food he eats.

The National Defense Commission states that one third of the people in the United States are living below the "safety line" of proper diet. The Commission calls on the nation to strengthen its defenses by wiping out malnutrition and undernourishment.

Studies made in recent years of the food habits of people all over the country have shown that the diets of a great many people are deficient in milk and milk products, fruits, and vegetables. It is only when these foods are used generously in the daily meals that the health and vitality needed to stand up under severe physical and mental strain can be maintained and promoted.

Nevertheless, there is chronic famine among large numbers of Americans for want of precious vitamins and minerals. They are caused not only by insufficient food, but by continued use of the wrong foods together with too few of the protective foods—milk, fruits, vegetables and eggs.

Now that physical fitness is a patriotic duty, and no longer merely a matter of personal pride, every American should give particular attention to health thru improved nutrition. More milk and dairy products, balanced meals, diet to prevent disease—these will make Americans strong and make America stronger.
