IN THE NAME OF THE STATE OF OREGON: You and each of you are hereby required to appear in the above entitled Court and cause and there answer the complaint on file against you within four weeks from the date of the first publication of this summons, and if you fail to so appear and answer said complaint, for want thereof the plaintiffs will apply to the Court for the relief prayed in the complaint to-wit: that a decree be entered adjudicating each and all of the claims that may be made on the part of any or all of said defendants herein or to the following described real property located in Jackson County Oregon, to-wit:

Beginning at the center line of Evans Creek at a point 720 feet West of the Southeast corner of the Northwest quarter of the Southeast quarter of Section 4, in Township 35 South, Range 4 West of the Willamette Meridian, in Jackson County, Oregon; thence running East 720 feet; thence North 900 feet; thence West 790 feet; thence North 50 degree West 270 feet; thence West 220 feet to the center line of Evans Creek, thence Southeasterly, along the center line of Evans Creek (the course and distance being approximately South 25 degree East 1180 feet) to the point of beginning,

or any part thereof, to be null and void; that the plaintiffs herein be decreed to be the owners in fee simple of the said real property, free and clear of any right or claim whatsoever on the part of the said de-

endants herein and any and all persons claiming, or to claim, by, through, or under them, or any of them, be forever enjoined, restrained and barred from asserting, attempting to establish, or claiming any right, title, estate, lien or interest whatsoever in or to said real property, or any part thereof, and the plaintiffs' title to said real property be forever quieted and set at rest, and for such other and further relief as to the Court may seem just and equitable in the premises.
