Now, we'd be in a fine fix if you fellows figured that way and just let down. But that's what some folks do

When you come home, maybe things will be different. Maybe, just maybe, we can help clean up a mess before you come home. We hope so.

Tomorrow, May 16th, we vote in the primary election. We vote..some of us who remembered to register, do. (You can't draft people to vote!)
