

The Platform.

Resolved, By the Republicans of Oregon in convention assembled in the city of Portland, this 21st day of April, A. D. 1880, that we propose to maintain and administer the affairs of the government of this State by strict economy and faithful adherence to the constitution and laws thereof and of the United States.

16. That we hold that a well instructed people alone can be perfectly free, and that it is therefore essential that the public schools should be instructed in the duties of citizenship and the ordinary pursuits of life.
