Some of the boys employed at the state mill in this place struck for higher wages last week and Chinamen took their places.

John Snyder has retired from the Olive hotel at Coquille City and the house is now under the management of Mrs. C. W. Olive.

The Curry county republicans will hold their primaries to-morrow and their county convention at Ellensburg on the 18th inst.

Grandma Coe and her two sons, J. F. and Glena, have moved from Fresno, Cal., to Coquille City, where they will reside in future.

J. S. Jones, whiteman milkman of Marshfield, was on the bay yesterday. He looks well and as if reaching on the Coquille agrees with him.

A part of the democratic slate for next Saturday is said to be Siglin for senator, Capt. Harris for representative, Glen Aiken for sheriff and Lamb for clerk.

Parker's mill is shut down this week, undergoing improvements to increase its capacity and facilitate work at the ship yard below the mill. The mill will start up again next week.

Mrs. H. Huden is visiting relatives and friends on the Coquille. She intends going east on a visit soon after returning from the Coquille, and Huden will make a trip northward on business.

The Cons City postoffice has been discontinued and the business of that office has been transferred to the Marshfield office, at which the people of Isthmus slough and vicinity will now deposit their letters and receive their mail matter.

V. N. Perry is seeking a license to sell whisky at retail at Coquille City, and, as usual, the temperance men of that locality have sent over a remonstrance. They have pluck and perseverance that will prevail in the end, even if Perry should get away with them this time.

The republican primaries will be held next Saturday. There will be nothing cut-and-dried about them and it is the duty of all good republicans to attend and exercise an influence in selecting delegates to the convention to meet at Coquille City a week from next Saturday.

A rumor came from South Coos river this week that Mark Cutlip and Miss Mattie Hyskin were married at Burton prairie last Sunday. A gentleman who left the prairie last Tuesday says he thinks the wedding did not take place last Sunday, but that it will next Sunday.

The Myrtle Point literary society has elected C. H. Volkmar president, W. F. Volkmar vice president, A. J. Morrison secretary, Miss Charlotte Volkmar treasurer, C. C. Reed custodian, and C. W. Major marshal. The next regular meeting of the society will be next Thursday night, at which time the newly-elected officers will be installed.

The singing population of Marshfield met at Norman's hall last Tuesday night for practice for an old folks' concert. A goodly number were present and the evening was spent in singing the songs of "ye olden time." Another meeting is called for to-morrow night, at which time the date of the concert will be fixed upon and all matters of importance attended to.

There were three bids put in yesterday for keeping the county paupers: one by Dr. McCormack, one by Dr. Hunter, and one by Dr. Angell. There was nothing remarkable about this, but it was a little singular that all three of the bids should contain the same figures for keeping and caring for the poor. Dr. McCormack will keep them at Timmerman's place, across the bay, where suitable buildings will be erected for their reception.

Joseph Lighthouse, the young seaman who was arrested at Empire the latter part of last January and subsequently confined in the county jail on a charge of having stolen a watch from Andy Hartman's room at the Blanco hotel in this place, last week deposited \$200, the amount of his bail, and was liberated. The money was sent to Lighthouse by his relatives. No doubt he will ship and forfeit the bail, rather than incur the chances of going to the penitentiary, which would almost certainly be the result of a trial.

The democratic primary election in this place last Saturday was a tame affair. The ring had things so cut-and-dried that the Siglin slate was carried out without a scratch. Its opponents received no consideration at all. They were set upon and squashed by the b'boys, who have no use for Simon-pure democrats except on election day. Some of the best-looking democrats who got counted went away shaking their heads and vowing vengeance, but their wounds may heal in time to attend Siglin's political funeral next June.

There is now a daily mail between this place and Coquille City. It leaves Coquille City at 5 p. m. Returning, it leaves here about 3 p. m. and reaches Coquille City at 6 p. m. This is a service that was greatly needed and is one that will be appreciated by the community. For the convenience of business men of this place the service is good. Letters received in the forenoon can be answered in the afternoon. An extension of the service to Myrtle Point would make it still better. We hope that this may soon be done.

California hay is selling in this market at \$25 per ton.
Dean & Co. sell table fruit at 25 cents per can and pie fruit at six cents for \$2.

John Dillon moved his family to town, and into his new dwelling house last week.

Charley Deltis of Myrtle Point is on the bay, tuning pianos and organs. He contemplates a trip up Coos river this week.

J. D. Hawes of Monmouth has accepted the principalship of the public school in this place, which it is the intention to open next Monday.

Valentine Gout of Rowland left by last steamer for his ranch in Fresno county, Cal., where he proposes to dwell awhile if the weather does not get too hot.

We have had some beautiful moonlight nights lately, and on Monday night two vessels were taken across the bay by moonlight—an occurrence very rare in this latitude.

Schooners are now carrying Coos bay coal to San Francisco at \$3 per ton. After paying 30 cents tonnage, \$7 per day wharfage at San Francisco and 35 cents for discharging, it nets them about \$3 per ton.

A lot of stove bolts lately taken from the Siuslaw to San Francisco by the steamer Mary D. Hume amounted to \$13 per cord. The freight amounted to 50 per cord, leaving a margin of only 54 for all other expenses.

At the ship yard last Monday Billy Reynolds ran his hands under the planer and had some of his fingers severely shaved. He now carries his right hand in a sling and wears bandages on some of the fingers of the left hand.

The price paid for carrying lumber from this port to San Pedro, Cal., is \$6 per thousand. Ten cents per thousand is paid for tonnage at San Pedro and \$1 per ton for ballast on the return trip. The shippers say there is nothing very big in the business for them.

H. P. Whitney is recovering slowly, but nothing like as fast as he thought he would. The shake-down he received was a little too heavy for even his tough piece of humanity as he to shake off with impunity. A 240 gait in the woods is rather risky.

The same party that was trying to be all things to all men on the currency in 1876 is trying to be all things to all men on the tariff in 1884. It is absolutely without a policy except the policy of double dealing, and hence it has a right to look for defeat. The American people regard frankness as a great virtue. They do not take a dodging party.

Last Tuesday S. M. Bray left the bay for the Court d'Alene mines, going by way of Myrtle Point and Roseburg. He is a young man of sterling qualities and means business in going to the new diggings. After a residence of five years on the bay, Bray leaves behind him a host of friends who sincerely wish that he may strike the biggest bonanza in the new mines.

The wagon road between Coquille City and Aiken's landing on Isthmus slough is reported passable for teams. Whitney has men at work on this end at Shingle-house slough, under the ownership of Gay Holcomb. Whitney's illness at this time will be something of a drawback to the opening of this road, but it is hoped that he will soon be able to be about and put the work through on time.

Frank P. Norton, late of Gardiner, has succeeded Chas. Charnak in the tobacco and variety store adjoining Norman's hall. The new proprietor has displayed a taste and judgment in the rearrangement and improvement of the place that shows that he intends to keep up with the times and capture his share of the trade. He sells at wholesale and retail and has goods of the best quality manufactured.

Joseph W. Rose, late of Stewartville, Mo., last week purchased David Holland's ranch across the bay, paying therefor \$1500 cash. He returned to Roseburg this week to bring his family down and begin the improvement of his place at once. Rose is a wide-awake man who means business wherever he locates and always votes the republican ticket straight. He grew weary of the Missouri bulldozers, to whom he never surrendered, but he prefers a country in which there are and can always be two sides to political questions without the endangerment of a man's life by assassination.

The Herald says a call has been made for a meeting of citizens at Coquille City on the evening of the 19th inst. for the purpose of organizing a joint agricultural association for Coos and Curry counties and selecting a suitable place for fair grounds and a race course. Our agricultural resources are not unbounded, nor their development very great, but the formation of such an organization as that proposed is a worthy and important move that should meet with more encouragement than it probably will; but if a few men endowed with the proper spirit take the lead the day is not far distant when we will be holding fairs on the Coquille that will astonish the natives.

Last week J. K. Vanderburgh exhibited to us specimens of sorghum sugar and syrup that he made in Jackson county last fall by the process for which he recently received a patent. The syrup was clear and bright and the sugar shows that Vanderburgh's process will make it from sorghum without the use of chemicals of any kind. The almost total failure of the sorghum crop in Jackson county last year rendered it impossible for Vanderburgh to secure enough of it to demonstrate the practicability of his process to the extent that he wished to, but he expects better success this year in Fresno county, Cal., where Beckman Vanderburgh will cultivate a field expressly for reduction to sugar by the Vanderburgh process.

Some Chinamen have rented the room lately occupied by Border Bros. in the building south of Norman's hall, and are making arrangements to start a store there. Sue, the steward of the Arcata, is said to be the head man of the firm. There appears to be an impression among the Chinamen of the bay that a large force of their countrymen will be brought into this county this year to do some railroad work, and the establishment of this store looks as if the proprietors do anticipate an increase of the Chinese population, for there are hardly enough of them now here to sustain much of an establishment of the kind that Sue proposes to start; but yesterday a Chinaman said to us that the new house expects to pick up some business outside of the Chinese.

Professor St. Lawrence gave a free lecture and musical entertainment at Norman's hall last Saturday night. The lecture treated of the origin of schools for the blind, after which the professor treated the audience to some of his vocal and instrumental music. Then the hat was passed around, when the professor said the collection taken up was the best that he had received in southern Oregon. This pleased the audience, and every one who had contributed felt sorry that he had not doubled the amount. Next in order was the presentation by the professor of a handsome photograph album to the most popular lady present, the question being settled by three separate ballots, at 10 cents per vote, and the three ballots added up, the one receiving the largest total being entitled to the prize. This created considerable amusement and resulted in the professor receiving about \$20 for the album, which was awarded to Miss Edna Hall, who received 75 votes, being 15 more than the next highest bidder. The entertainment wound up with a free ball for a prize for the fastest man in the crowd. Harkness Dunham and Gus Bennett outstripped all others for this prize, and Dunham won it by two votes. The prize consisted of a pair of baby stockings, which the captain took and walked away with as proud as Lucifer. At St. Lawrence's concert at Empire Miss Georgina Cammann took the prize awarded to the most popular lady in the audience.

Smith Carried Away the Wrong Man.

Yesterday Henry Sengstacken, Wells, Fargo & Co's agent in this place, received the following: SAN FRANCISCO, April 9, 1884.—Henry Sengstacken, Marshfield: The man brought here by Rufus Smith is not Cleo Grims. J. B. Hume.

Hume is Wells, Fargo & Co's chief detective agent and the above is authentic. Hon. C. B. Watson, who always maintained that Alexander was innocent and had him released on habeas corpus at Empire before he was arrested on the regulation and taken away, no doubt will now be employed to prosecute those who persecuted Alexander because he resembles Cleo Grims. To be confined for weeks in such prisons as we have here, and then carried to San Francisco in irons, was not agreeable pastime for Alexander, and he may make it lively for some of those who made it so uncomfortable for him; but he will have to send a detective after Pierce.
