The Drain road is now in good repair and yesterday Jarvis, Cornwall & Co's stages commenced running through on time.

"Sunshine" South Coos river letter came to us away behind time last week. His next he had better send by a faster express.

A street, south of Sengstacken's store, is being graded down and leveled up, so that teams can soon approach the bay that way.

W. H. Tyrrel, recently so badly hurt by falling from the trestle-work at the Newport railway, is again on the street, looking quite as stout as he did before the accident.

Rev. W. Lund will hold Episcopal services at this place next Sunday at 11 a. m. and 7:30 p. m. In the evening there will be a collection towards paying for the stove.

Rev. C. P. Bailey closed his protracted meeting at this place last Sunday night. Miss Ella Endicott was the only convert and accession made to the church during the series of meetings.

C. H. Merchant left the bay yesterday for San Francisco, going by way of Portland, where he will tarry a week or ten days, and then proceed to San Francisco. He will be absent about a month.

The Coquille tug Katie Cook is on the ways at Parkersburg, to receive a new stern, have her deck raised 14 inches, be overhauled generally, and come off a better boat than when she was first launched.

The chinilla clothing for men that Nasburg & Hirst have just brought up and opened out is the very thing for this place; but if you don't like that, they can suit you in various other ways, as they have the best assortment of clothing on the bay.

Capt. Parker was on the bay last Sunday and left for home on Monday. At that time it was his intention to start his mill Monday on a run of two or three million feet of lumber, most of which will be stored under the sheds at the mill and allowed to season until there is an improvement in the lumber trade, but it is probable that the schooner Parkersburg will be kept carrying lumber to San Francisco.

Miss Lou DeLannay, who had been engaged by the trustees to teach the primary department at this term of the public school in this place, returned last Saturday from Mouthouth; where she has been attending the normal school for about a year; but owing to Miss DeLannay's delay in getting here she lost the engagement to teach, which was canceled by the trustees and then awarded to Miss Leville Clinkinbeard, a very worthy and competent young lady.

Mrs. Caroline Kuhl died at the residence of Fred Eckhoff, at Kentuck slough, last Tuesday morning, after a lingering illness from a pulmonary disease. She had been a resident of the bay for about 10 years; was a worthy woman, respected and loved by all who knew her, and was the esteemed sister of Fred and Charley Eckhoff, two of the pioneer residents of the bay, who, in their bereavement, have the sympathy of a vast circle of friends. Mrs. Kuhl will be buried at this place this forenoon, the funeral services to be held at the Baptist church, between 10 and 11 o'clock, immediately after the arrival of the steamer Coos from Empire.

FOUND.

The Fireman and the Engineer of the Sol Thomas.

The remains of Rasmus Toft, the fireman who lost his life by the explosion of the boilers of the tug Sol Thomas, were found at South slough last Saturday afternoon, taken to Empire and buried there last Sunday.

On Saturday Nicholas P. Sapp, Alex Scott, Fred Elliott, Milton Elliott and family and Nelson Lewis and family were at South slough on a sort of a picnic excursion. They left their boats at the government boat-house on the south side of the slough and roamed down the beach toward Coos head, gathering shell-fish, etc., as they went. After they were tired of the walk and concluded to return, Sapp took the lead while the others were resting, and on his way back, and when within a quarter or a half mile of the boat-house he discovered an unusual object partly buried in the sand, which, upon inspection, lying face down, clad in blue overalls, proved to be the remains of a large man, blue jumper and blue shirt, with a narrow leather belt around the waist, shoes on the feet, and a red or bright-colored handkerchief in the right hip pocket of the overalls. The hair was gone from the head, and the face and head, up to the ears, and the arms to the elbows, were buried in the sand.

After holding a consultation, the party concluded that it was their duty to leave the remains undisturbed and report their discovery to the coroner; so Alex Scott and Fred Elliott remained with the remains, while Sapp and Lewis crossed the slough and reported to Capt. Littlefield the finding of the body, after which they came on to Empire and reported to Justice Ploeger.

After the corpse was taken from the beach, it was found that the flesh had sloughed from the face until the features were no longer recognizable, but from the clothing on the body, it was conceded by all who knew him to be that of Toft, the fireman.

One report is that one of the arms was broken, but that aside from this the body was not badly mangled, though it was much decomposed and of course very disagreeable to handle, which deterred persons from making a close inspection of it.

Last Tuesday the body of Geo. J. Wadleigh, the late engineer of the Sol Thomas, was found floating in the bay, opposite Empire, near Jarvis' landing. It was discovered by Charley Johnson and Harry Somerville, and taken to Empire. The hair was gone from the scalp, but it is said that the features were not badly disfigured and that there was no difficulty at all in recognizing the remains. There was a hole in one temple, made by some part of the flying wreck, one jaw was broken, and some of his teeth were knocked out. Deceased was buried at Empire yesterday forenoon.

There was a report in circulation in town yesterday that the body of Louis Nielson had been found at Haynes slough, but we could not trace the rumor to a reliable source. A flock of sea-gulls were seen at the mouth of Haynes slough yesterday, acting as if they were devouring something, and it was surmised that it might be a corpse. From this seems to have started the report of the finding of the body of Nielson.

Many other interesting features of the concert our reporter failed to note, and we are therefore compelled to pass them by.

The evening's entertainment wound up with a social dance at Reichel's hall.

Great praise is awarded to the ladies of Empire for their skill in getting up this concert and rendering it such a complete success.

Capt. Parker of the Parkersburg mill has commenced the construction of a new yacht for his private use. It will be 40 feet long, 5 feet beam, flat-bottomed, draw only about 6 inches of water, propelled by a new-fangled engine to occupy the space of a half-bushel measure, and is intended to run in calm water like a streak of greased lightning; so the captain says, and he ought to know. The engine has just arrived at San Francisco and is expected up by the Parkersburg this trip.

The steamer Coos Bay sailed for San Francisco yesterday, with the following named passengers: Mrs. Capt. Peterson and child, Mrs. F. M. Phipps and son, Miss Rose Morris, E. Evans, Capt. H. R. Reed, T. J. Morrison, I. B. Cook and Miss Spain and two others from Yaquina bay.

In making up the house committees in the legislature, Hon. John H. Roberts was given the chairmanship of the committee on public buildings and W. W. Sulton was made chairman of the printing committee.

Fatal Accident at South Slough.

Matt Wikman, a resident of this place, accidentally shot and killed himself at South slough Wednesday last week.

About noon that day Wikman and Alex Salund left this place together and walked to Empire. Wikman took with him a 44-caliber Winchester rifle, contrary to the advice of Salund, who expressed the belief that it was foolishness to take the gun, but Wikman said he would pass through a region of country where there might be a chance to kill some game, and therefore insisted upon taking the gun along.

Lund stopped at Empire, while Wikman went on to Samuel Rozell's place at South slough, where he procured a skiff or small boat, with a sail, with which he started up the slough to visit his uncle, Jacob Wikman, who lives about four miles above Rozell.

Soon after Wikman had left Rozell's place, and when he had gone about half a mile up the slough, Rozell's boy and hired man heard him calling for help, while the boat he was in was seen to be drifting at will in a way to show that the occupant was helpless and in need of assistance.

The circumstance was at once reported to Rozell, when they went to Wikman's aid and conveyed him to Rozell's house.

At that time Wikman was perfectly conscious and able to talk and tell that he had accidentally shot himself while jibing his sail and shifting his seat in the boat, but exactly in what manner the accident happened, further than this, is only conjecture, as Wikman, if he himself knew, seems to have failed, perhaps from weakness, to have entered into any detailed account of it.

The accident happened about 5 o'clock in the evening, and immediately after Wikman was taken to Rozell's house a messenger was dispatched to Empire for medical aid, but owing to some derangement of the wires word could not be conveyed to the doctors of this place that night, and about 10 o'clock, some five hours after the accident, Wikman died.

The wound was mortal and surgical aid would have availed nothing.

When Wikman was first carried to the house his lower limbs were paralyzed and he was under the impression that he had shot himself through the legs.

A subsequent examination of the body showed two bullet holes in it—one in the right shoulder, near the collarbone, and another in the abdomen, on the right side, only a few inches above the groin.

The breast, near and below the wound in the shoulder, was considerably discolored by clotted blood, and it may have been somewhat powder burned. It is the presumption that Wikman, when he shot himself, was leaning forward and holding his gun by the muzzle, or that he was holding it by the muzzle in an upright position above his shoulder, when the hammer was in some way pulled back, the cartridge exploded and the ball sent into his body in a way that it struck the spine, by which it was so deflected that it came out through the abdomen.

On Thursday Forest Lang took a team and a light wagon and brought the remains of Wikman from Rozell's to this place, where they were buried last Friday, a very large number of friends following them to the grave.

For several months past, until within a few weeks, Wikman was employed at the Bayview brewery. Lately he and Alex Salund were making arrangements to take up some land at Ten-mile, and it is presumed that his intended visit to his uncle was in some way connected with this land business.

Wikman was 32 years of age, and a native of Kronoby socken, Wasa, Finland. He was a sober, industrious man and a good citizen, whose untimely death is lamented by all. In this place he leaves a wife and two children and a brother, Andrew Wikman, and at South slough an uncle, Jacob Wikman, to mourn his death. In their irreparable loss they have the sympathy of the whole community.

When Miss Wenla Granholm, aged 14 years, arrived from Pinland, about two years ago, she was suffering from hip-joint disease, which is considered a very serious disease, and it is but a short time since the mortality was put at 75 per cent. Since, however, the introduction of the immovable plaster-of-paris splint or dressing, this rate of mortality has been much reduced. At the time Miss Granholm was placed under Dr. J. T. McCormac's treatment she was unable to walk, even with the aid of a crutch, and she was fast succumbing to the wasting disease. On the diseased side, from the arm-pits to below the knee, the girl was enveloped in the plaster dressing, but as had symptoms soon arose, ing, and rapidly improved. At the end of three months all abscesses had healed and to all appearances the patient was cured. Then the dressing was removed several months ago, since which time Miss Granholm has been able to attend school and to her other duties with as much comfort as other girls of her age. The result of the treatment is what is known as ankylosis of the hip-joint, which is considered a good result of treatment in such cases.

Wm. Hansen, formerly of North Bend, is now and has been for some time past employed at Simpson Bros' new mill at Gray's harbor. He married up there, and last month, in the way of a Christmas gift, his wife presented him with a fine boy, "the very image of his father," they say.

Hon. John H. Roberts has introduced a bill in the legislature to encourage the destruction of noxious animals in this state. If it should become a law, county treasurers would be authorized to pay for scalps as follows: Wolf or coyote, \$3; black or brown bear, \$2; lynx or wild-cat, \$1.

The Newport coal company's new bunker at the mouth of Coak-bank slough has been covered with 20,000 redwood shakes that arrived by the last Arcata, and it now presents the appearance of being almost ready for vessels to load there.

Lately about 20,000 redwood shingles have been washed ashore between Coos bay and the Umpqua. Last week Fred Jarvis picked up five or six thousand of these shingles that were bunched intact.

The Plaindealer says District Attorney J. W. Hamilton of Roseburg and Miss Ollie Ostrander, formerly of Empire City, were married at The Dalles on the 10th inst.

We planted last spring a considerable number of Early Dwarf cabbages, which in due time headed up and were cut off and used. The stumps, which were left standing, commenced sending out sprouts soon after the rains set in in September, from three to five to the stump. These in due time developed into nice, plump heads, as available for table use as the first or single-head crop had been. From this experience we take it that it will pay to save the stumps of the early cabbages.—[Southwest Oregon Recorder.]

An unsuccessful attempt was made to burn Flook & Noble's grist mill at Roseburg on the night of the 17th inst. A match had been applied to a can of lubricating oil that had been poured upon some lumber and shavings that were on the floor of the mill, when Miss Laura Jones, who was stopping with Flook's family, saw the light and sounded the alarm, after which Flook rushed to the mill and soon subdued the flames.

A disease seems to afflict calves in this section which proves fatal in more cases than the unlucky losers relish altogether. They seem to be attacked with scours, when they grow weak and rapidly reduce in flesh, and then die.
