The administration is settling with John Roach for his liberal contribution to the republican national campaign fund last year.

The Methodist conference for this state is in session at Roseburg, Bishop J. M. Walden presiding. The conference will close next Sunday.

Ex-Senator Slater is reported to have let himself out with the administration by becoming the paid lobbyist of a lot of Portland democrats very hungry and thirsty for office. It is true, some good may yet come from Cleveland.

Col. Ike Hill of Ohio has been in Washington, growing at the administration for its tardiness in distributing the petty postoffices among the faithful. He says the possession of the cross-roads postoffices is the only tangible evidence of federal government to the people residing thereabouts. "As long as these offices remain unchanged," says Hill, "they [the people] can see no evidence of the change of political power." This is not the song sang before the election. Then the tune was that a change would flood the country with blessings too numerous to mention, and that the poor, dear people would be deluged thereby to a depth from which the most impetuous could not emerge in poverty. As a starter, Old Tom Hendricks was expected to declare a dividend at the United States treasury before this time and give every fellow his \$8; but since Old Tom got his paws into the public crib he seems to have forgotten the people who put him there, or his confidants compel him to hold back, for fear the cash will not hold out for four years for the men who can get at it; and now comes Col. Ike Hill of Ohio, begging for a six-bits postoffice. "How are the mighty fallen!"

Eastern cattle buyers have been thinning the herds of eastern Oregon and already the Portland people scent high-priced roasts and steaks next winter. There are plenty of cattle here and this is the region from which the people of Portland and vicinity should draw their supply of winter meat; but they can never do that cheaply without railroad connection. An unlimited number of cattle can be raised and kept in this section of the state, where very little feeding is necessary during the winter months, whenever a market is opened and sufficient inducements are held out for men to raise them for sale. It has long been a matter of surprise to us that money could be procured to waste on the Oregon Pacific, with next to nothing at Yaquina bay, when such extravagant inducements are held out for a railway from this place to Roseburg and an eastern connection. It would pay the Oregon and California road to run a branch line to Coos bay. This part of the state offers more and better inducements for cattle than any other place on the Pacific coast, or in the United States, for that matter. Our vast resources, in the way of coal, lumber, cattle, hogs, poultry, dairy products, fruit, vegetables, and many other things unnecessary to mention, will never be developed except by railroad connection with the interior, where so much is needed that we are so well adapted to supply whenever an outlet be opened.

Last month President Cleveland appointed some man to a judgeship, and immediately after the announcement of the appointment one of the men who had recommended the man wrote to Cleveland expressing surprise that he should be such a fool as to appoint such a rascal to such an important office. Cleveland replied, chopped the fellow up into mince-meat, and then sat down upon him heavily with his full avoirdupois and ponderous posterior, after all which the unfortunate wretch must have crawled into some hole and died, for since that time all efforts on the part of the quidnuncs of the party have failed to reveal who the appointee is or the name of the man who wrote to Cleveland. E. J. Dawne, of this state, appointed to a judgeship in Alaska, is supposed to be the judge referred to as unfit for the position, and ex-Senators Slater and Grover and other prominent democrats of this state have been suspected of being the president's apologizing correspondent; but the matter is still a mystery. The "senator from Coos and Curry, who came within three votes of being elected United States senator," is accredited with putting his name to Dawne's petition, and maybe he might, if he would, assist in clarifying this dirty puddle into which the Oregon democrats have tumbled and from which they are so industriously throwing mud at each other. The last dab is from Tony Noltner, late of the Standard, as follows: The New York Sun's Washington special says: The man to whom the recent scathing letter of the president was written is declared to be A. Bush, a banker and one of the wealthiest citizens of Salem, and the judge referred to is Dawne. For several reasons Bush is fixed upon as the man who wrote the letter addressed to "The President." Inspection of four letters written by Bush to President Cleveland shows every one to have been addressed "To the President" out of a hundred different styles of addresses. "We are friends and do business with one another," says the letter. Bush is the only man in Salem with whom Dawne had business dealings and who at the same time was on his paper. A Noltner, a prominent resident of Portland and a close friend of Senator Slater, said the statements regarding Bush's political career and his relations to Dawne are accurate, and that he believed Bush to be the author of the letter of July 21.

A Halt and a Retrospect.

Since the president called a halt, went into retirement, or took to the woods to recruit, the opportunity afforded has been improved to look around and inquire what has the democratic party accomplished for the public weal during the half year? It has enjoyed a restoration to power? If we were to accept the Cleveland organs, or what they say, we would be bound to conclude that this has been the most satisfactory administration the country ever had, and we might say, giving full credence to the exaggeration these papers indulge in, that it is the most salutary and satisfactory we ever will have. But when calm, dispassionate and unprejudiced inquiry is invoked and a thorough review of the administration is taken for the past six months, the conclusion must be inevitable that the administration has been very common-place and wholly without good results. Crediting the administration with all that the most admiring partisan may attribute to it, it must be confessed, in the first place, that it has been vacillating, even in distributing the offices. At first it denied the offices to its party, and that can hardly be assumed, even by Cleveland's warmest admirer, to have made the administration illustrious; then the term "offensive partisan" was invented and political espionage introduced to make it available to turn out republicans and put in democrats, and that can hardly be commended as courageous or manly; then the president seeks to avoid even the effect of the application of this term by retiring from before the face of his party, or by taking to the woods, and this can scarcely be said to reflect the courage or conviction or the courage to stand up to the political responsibilities with which his party has invested him. But aside from the spoils, the offices, as much as the president may have done in distributing them, or as little, or as much as he has vacillated about the mode of bestowing them, there are other searching questions, the truthful answers to which will go to show whether Cleveland's administration is entitled to commendation, or even a passing one of approval. Has the public service been improved since this administration was installed in power? No—the removal of experienced officials to be replaced by inexperienced partisans, democrats rewarded for party services, cannot and has not conduced to the good of the public service. Has our foreign service been improved by the politicians who have replaced the learned and scholarly representatives we had at the court of St. James and other foreign courts? Has our consular service been improved by the appointment of southern worn-out political hacks, ante-bellum representatives of the south, to replace the business men who occupied our consulates? Is the internal revenue collected more honestly than it was, or closer?—let the re-establishment of illicit distilling and "moonshining" in Kentucky and Tennessee answer. And so on the departments might be looked into, and the answer would be "no" to the question in every instance. Do you see any improvement in the public service? And when it comes to the general work of the administration, whenever in a degree it has signified or outlined any sort of policy which tends or may tend to affect the business and industries of the country, have we been treated to any revelation that encourages, or that entitles the administration to approval or say applause? The administration has driven two iron ship-building establishments of the country out of business. Is this encouraging to American industry, when with its destruction it deprives 2500 men of work, and their families of sustenance? The postmaster general, backed by the attorney general, has declined to give American lines of steamers the money congress found necessary and voted to them to require them for service in carrying the United States mails. Will this conduce to enterprise seeking to re-establish American shipping on the seas and to establish regular trade between our ports and those of foreign countries? The secretary of the interior, whose range of vision so far as the cattle interests of this country are concerned has been confined to his neighbor's cows, which have been accustomed to graze in the court-house yard, or along the grass grown street of the village of Oxford, Miss., has issued an order expelling herds from grazing grounds their owners had acquired in good faith and under sanction, the warrant of which, as yet, has never been passed upon by any court in the land. We ask if the business interests of the country are encouraged by any such action as this, that involves the sacrifice of millions of dollars, or jeopardizes them. If such great interests as those involved in the Roach arbitrary ruling and the decision regarding the cattlemen be taken as precedents, we ask if any and every business interest in the country is not subject to the caprice of the very capricious administration, capricious as it has always shown itself in everything it has done from the modes it has adopted and changed in appointing to office, to the means and excuses it has adopted in prostrating such business interests as it has been pleased to regard as "offensive"? We think the president for "the halt" he has ordered. It gives us time to reflect, and while reflecting to determine never to do so again—trust the democracy, let it come in any form or in its avoirdupois bulky enough to resist the struggles of the most sinuous trout in all the streams of the Adirondacks.

The Next Overland Monthly.

The leading article of the September number of the Overland Monthly is by Prof. Josiah Royce, of Harvard, late of California, upon "The Sacramento Squatter Riot of 1850." Flora Haines Appony furnishes a personal sketch of the late Helen Hunt Jackson, and Ina D. Coolbrith contributes a poem. These, with editorial comments upon Mrs. Jackson's literary work, give this number great value as a memorial of the author of "Ramona." There is also an article from Hon. S. S. Cox, minister to Turkey, on "The Thirty-Fifth and Thirty-Sixth Congresses." Dr. Henry DeGroot furnishes a graphic account of the ancient "Mining Camp of You Bet." Capt. Wright, of the confederate army and late lecturer of the California state grange, describes "How the Blockade was Run." The most important stories are: "A Plea before Judge Lynch," written by a well-known pioneer, and "The Doctor of Leidesdorf Street," a brilliant and exciting story of San Francisco. These are only a few of the attractive and valuable articles that appear in this number.

Battle Among Coal Miners.

SHENANDOAH, Pa., August 20.—The miners and laborers employed at Lents, Lilly & Co.'s colliery here were recently notified that a 5 per cent. reduction in all wages would go into effect at once. The men held a meeting and Tuesday Hungarian and Poles were put to work about the mine, and although the striking miners watched their movements closely, no disturbance occurred till late in the evening, when the foreigners were attacked. The excitement brought to the scene crowds of persons, and in less than ten minutes the fight became general and was participated in by 100 men and boys. All sorts of missiles were used—stones, clubs and fence rails. From fifteen to twenty-five persons were seriously, and several Hungarians fatally injured. As soon as one man became injured he was carried away and the battle renewed. The Hungarians fought desperately and showed a disposition not to leave the place. Yesterday morning they returned to the colliery and went to work, and have not been since interfered with. Another encounter is expected, however.

The British ship Haddingtonshire.

The British ship Haddingtonshire, from Astoria for Liverpool, was wrecked near Point Reyes, Cal., on the morning of the 10th inst. She left Astoria July 6 and proceeded on her voyage as far as the equator, where she encountered a heavy gale, in which she lost four seamen and her chronometer and was so disabled that the captain put back for San Francisco for repairs. Off the heads a dense fog was encountered, and when groping around in this the vessel ran on the rocks. All on board perished except a sailor and a cabin-boy and the vessel and cargo are a total loss. The cargo consisted of 12,000 barrels of flour valued at \$50,000, and 17,700 cases of salmon, valued at \$54,000. The officers of the Haddingtonshire were: J. Frazer, master; G. Cunningham, first mate, and Wm. Curtis, second mate. The vessel was owned by Thos. Low & Co., and is the second one that they have lost after leaving Astoria this year. The other was the Perthshire.

The following, from the Corvallis Gazette, expresses our sentiments exactly: The Hon. Geo. H. Williams is now and has been for some time the choice of 90 republicans out of every 100 for United States senator from Oregon. And had it not been for the confusion in the last legislature, on the question of senator, and the decided opposition of democrats to the election of Williams, he would have been elected at that time. He was opposed by democrats because, as they said, they preferred any other man to him, for the simple reason that Williams was a true republican, and with his ability, standing and experience, he could do their party great and irreparable damage. For these reasons they opposed him more than they would a rattle-snake. The same reasons which prompt democrats to oppose him, are the best reasons in the world, by all means, why he is the first choice of republicans.

The Ohio democracy met in convention at Columbus last Thursday and re-nominated Hoadly for governor, J. G. Warwick for lieutenant governor, Chas. D. Martin for supreme judge, Gibson Otherton for a vacancy on the supreme bench, Peter Brady for treasurer, Jas.

Lawrence for attorney general and Henry Welber for member of the board of public works.

All except Otherton were nominated by acclamation. The platform congratulates the people upon the election of Cleveland and Hendricks, and the revival of business prosperity and the increase in the value of property, but it does not tell where this prosperity and this increase are. They must be in Ohio. They have not come further west yet, that we have heard of. Cleveland and his administration were endorsed; also the Chicago platform of 1884. Licensing saloons is favored and a constitutional amendment to that effect is promised for submission to the people if the democracy win. Arbitration is favored as a means of settling differences between laborers and employers. This is sensible, and we were surprised to find it in a democratic platform, instead of a wholesale denouncement of men and monopolies, calculated to catch and control a certain class of votes that are always cast without sense or reason. The death of Gen. Grant is mourned, and this reminds us of the wonderful revolution wrought in the minds of the Ohio democracy since Vallandigham died. Had Grant died in Vallandigham's day, the first democratic convention that assembled thereafter would have passed a resolution the reverse of the one passed last Thursday. Hoadly is the administration candidate. Cleveland has voluntarily shied his star into the Ohio contest, with a leader of his own choosing, backed by all the power and patronage the administration can bestow, and when he comes out whipped we hope the democracy will not whine.

Believed to be a Miracle.

ALBANY, N. Y., August 21.—Considerable excitement has been caused in Cohoes by a strange sight at the residence of Mrs. Thomas Woods, whose infant child died on Wednesday. When the undertaker was preparing the body for burial one of the pastors present suddenly declared that the figure of a cross and chalice could be seen on the white cloth that covered the child's face. Otherton looked and saw the figures. Word went out and people flocked to the house until it became necessary to call on the police to keep back the crowd. The cloth was frequently wet with water, but the figures remained. The spots where the cross and chalice were outlined were of a glistening, whiter shade than the rest of the cloth when wet. About 12 o'clock yesterday the shadow disappeared. Many believe it to have been a miracle.

The body of a miner named Lehman.

The body of a miner named Lehman was found in a prospect hole near Independence, Umatilla county, a few days ago. Lehman disappeared over a month since, and all search for him failed until he was accidentally discovered in the hole; but a coat, hat and horse belonging to him were previously found, which were considered conclusive proof that he had been foully dealt with. Last fall Lehman sold a mining claim and water right to a company of Chinamen for \$500. After finding rich dirt the Chinamen made sluices, dug ditches and prepared for a season's work. The ground proving better than Lehman anticipated, he took other claims below the Chinamen, then robbed them of the water they had bought of him and paid for, and in three days he cleaned up \$75. The Chinamen kicked, but Lehman did not heed, and they departed, evidently leaving him dead and beyond the enjoyment of the worldly wealth that he had acquired by his double dealing with them.

The government refused to accept the one boat that John Roach completed and wanted to deliver, but it has accepted the half-finished craft. The Philadelphia Press would like to know, if a whole boat made by Roach is not good enough for the present secretary of the navy, how will the half boats suit him any better? The charm about the latter doubtless is that there is a good deal still to be done on them, which will make patronage for the administration.
