The legislature adjourned Tuesday night.

Up to Friday night last it had rained steadily throughout California for five days. The total rainfall for this month up to that time had been 8.07 inches, an amount never before exceeded except in 1849, when 11.80 inches fell during October and November. The probabilities are that the rainfall of 1849 will be surpassed this year.

The mails from San Francisco arrive at Portland six hours sooner over the Union Pacific Short Line and Oregon Railway and Navigation route than by the Oregon and California route. The time by the latter line is 4 days, 1 hour and 30 minutes, while by the round-about route they arrive in 3 days, 19 hours and 30 minutes.

Rev. W. W. Downs, a besmirched clergyman of Boston, was asked by his congregation to resign. He told them he was not that kind of a hair-pin, and if there was to be any resignation about his church they, as Christians, would have to display it. That settled the business; the congregation took water, and Downs went on again, as usual.

It is the size of the New Northwest and shows editorial ability and the handiwork of good practical printers. The Star has a large field exceedingly full of tares before it and we wish it success in the good work it has undertaken. A week ago yesterday the Oregon legislature elected Hon. John H. Mitchell to succeed Jas. H. Slater in the United States senate on the 4th of next March. To some this was a surprise to the editor of the Oregonian, for instance—and to some it was not. We were told several weeks ago, by a gentleman on the inside, that Mitchell would be the man in case an extra session should be called; but we were somewhat skeptical in regard thereto, for we did not believe the democrats would come to his rescue in sufficient force to elect him. Mitchell is decidedly the choice of the people, and as far as this part of the state is concerned he is almost the unanimous choice of all parties. But for the spirit of selfishness and merciless warfare of the Oregonian against Mitchell, there would have been no opposition to him worth mentioning. As it is, he will not go back to the senate under as favorable circumstances as if he had been returned by members of his own party, without the assistance of democrats. From the lights before us at this time we have no cause for Mitchell, for the Oregonian's warfare on him justified him in resorting to almost any means to circumvent it; but his political future will depend upon his conduct in the senate after he takes his seat. It is not probable that 17 democrats voted for him without a price. If they were paid in coin, Mitchell may recover from that; but if he sold his party to pay them, he can hang his political harp on the willows at the end of his senatorial term and take a seat among the muggwumps. Time will tell the price paid. We read of jobs with Tammany in New York, among the Buckeyes in Ohio, and the Hoosiers in Indiana, also in California and the rotten borough of Nevada, but here is one at home, in which members of both parties have participated, and it is so clearly a case of buying and selling that there is no dodging it at all. The democrats sold, as usual, and the republicans bought, but what they paid remains to be found out. Mitchell's success causes too much rejoicing in the democratic wigwam to suit us. If he tumbles into their camp, that will be the last of him, for they have no use for men of his political faith and the republicans will have no use for him after the democrats get through with him. At a justification meeting at Roseburg the other night, Hon. L. F. Mosher was one of the speakers. He boasted of his democracy and copperhead proclivities and said that he and his kind would never be content until "public affairs run in the groove of a quarter of a century ago." Mitchell needs protection from such men as Mosher. He is an erratic old chap, politically, who will never be satisfied, for affairs, public or private, will never go back 25 years in this country to suit him or any other man. The Oregonian thinks that Mitchell's election will bankrupt the republican party in this state, and that may be so. It is a sure thing that the party is not big enough to hold the Oregonian and Mitchell too, at the same time. One must go, and as Mitchell is now on top, and as the Oregonian is in with the Chinamen, it had better go, which it already manifests a disposition to do. The Oregonian's Salem correspondent says the details of Mitchell's bargain with the democrats are kept deeply secret, but points are gradually coming out. A prominent democrat, who protested against the job, told this correspondent that previous to the general caucus which ratified the deal the 17 who voted for Mitchell had met in another room, where he understood Mitchell had appeared before them and made promises as to his future conduct, both as to national and local matters. These promises are now in writing, though it is not possible to get at the paper. The gentleman added: "Already two or three of the democrats who voted for him would give their right arm to recall their votes."

The Fight Ended and Mitchell Wins.

[Oregonian Correspondence.]

SALEM, Or., Nov. 18, 1885.—If the results of this day have not been in line with the expectations and predictions of yesterday, it is because there was cowardice and shamelessness where there appeared to be courage and honor. The causes back of the final action were deeply secret, as was natural to a conspiracy of corruption. The election of Mitchell was brought about by the means of a bargain with the democrats. It could never have resulted from republican votes, and to those democrats who voted for him and to those who permitted and encouraged such action chiefly belongs its infamy. Mitchell's original support consisted of a squad of republicans who have been long connected with his mercenary system of politics. They were recruited by corrupt methods till a majority of the republicans was secured. At this point a few weaklings were whipped in and then as a finishing stroke the whole "plant" was sold out to the democrats. The consideration of this infamous bargain in a general sense was the promise of support by Mitchell of the national democratic administration. The contract also involved many counts respecting the distribution of patronage in this state, etc., etc. In its general scope the job was "given away" to-day by Representative Miller, who in changing his vote from Slater to Mitchell, explained that "He [Mitchell] assured me that he will do all he can for the advancement of the present administration, as we require it." This unintended exposure by a man who had not wit enough to hide his real meaning in verbiage, was complete. The details of the bargain have been reduced to writing, and the instrument is now in the hands of a well-known democrat, who proposed to read it in the caucus last night, and was restrained only by the protest of an ardent Mitchellite, who declared that a general caucus was not the "time nor the place" to divulge such a transaction.

It should not be understood that the action of those democrats who joined in this corrupt job was approved by all the democratic members of the legislature. On the contrary, there were earnest protests. At the caucus held last night, in which the resolution was passed permitting the Mitchell gang to join with the Mitchell republicans without censure, there was a strong feeling that the proposed action was wrong and that it would be a fatal mistake. Veatch, Pennington, Myers, Cuthbert, Cox and others took high ground against a course which they declared improper within itself, a violation of party usage and discipline and an abandonment of decent principles. The Mitchell gang and its morality were fitly represented by Siglin, who declared that in politics there was no such thing as principle; that it was a mere question of policy. In such politics as that which we have seen triumph to-day there is indeed no such quality as principle. Like its chief factor and beneficiary, it is infamous.

THE BALLOTING.

The proceedings of to-day were looked forward to with greatest interest. The Mitchell people declared in advance that their man would surely "go in," and this was the prevailing opinion during the forenoon. There were many, however, who had too much faith in the integrity and courage of those republicans who did not vote for Mitchell yesterday to expect a stampede in his favor. It is thought, too, by many, that the republicans would not permit an election by democratic votes. Others still thought the democratic movement only a feint for obstruction and delay, and that their votes would not be allowed to elect. Williams had practically given up the contest, but his name was still used as a means of organization. It was hoped that the Mitchell men would listen to reason and join in the election by republican votes of a republican, and in this connection Moody's name was most freely used, as indeed, it has been during the past week. Still, the general impression was that the final battle was to be fought, and this brought out a large attendance. The hall was not more densely crowded by spectators on the last night of the regular session last winter than to-day at noon. The first ballot was called and resulted as follows:

For Slater—Beall, L. Bilyen, W. B. Bilyen, Black, Burch, Burton, Cuthbert, Chandler, Coleman, Cox, Cyrus, Craven, Dick, Haines, Hayes, Kuykendall, Leinenweber, Lewis, Lockett, Chas. Miller, Montague, Myers, Morrow, Nelson, Peery, Pennington, Prim, Porter, Rinehart, Siglin, Taylor, Thompson, Wilcox and Will—28.

For Williams—Bird, Bourne, Cartwright, T. W. Davenport, Emmett, Hare, Henkle, Manning, Riddle, Smith, Storey, Therkleson, Voorhees, Waite, Williams, Woodward, Keady and Waldo—20.

Allen and Lee voted for Kelsey, Simon for C. W. Fulton, and Hirsch for Carson.

The only significant change was the increase of Mitchell's vote by 4, giving him 28—a majority of the republican members.

When the call was completed Hirsch took the floor. He recited the circumstances of his own candidacy last winter, already familiar, and said that he had not appeared this time as a candidate. He believed in organization and majority rule, and had claimed, when he himself had more than half the votes of his party in the legislature, that the rest should come to him. He now felt

it a duty to do himself what he had claimed to be the duty of others to do in a similar situation, and he therefore changed his vote to Mitchell.

Gilbert followed, reciting the circumstances of three years ago, when he, with others, held out against Mitchell, who was at that time a candidate. He obeyed what he thought to be the will of his constituents at that time. But he believed in majority rule, and he would not again join in a factional fight against a majority. He changed his vote to Mitchell.

President Waldo, without any explanation, directed the clerk to change his vote to Mitchell. And so the vote stood: Mitchell 31 and Williams 18, with others as above.

The next ballot—third of the series and second of the day—was called, and practically there was no change. Before the result was announced, Saunders took the floor and said that his desire had been and was to elect a republican senator. He had voted for the man of his choice (Williams) through one session and at this session till there seemed no chance of his election. He believed that majorities ought to rule, and he changed his vote to Mitchell.

Siglin (dem.) took the floor and explained his course at the session three years ago. He then voted for Mitchell, and his people had approved his conduct and returned him again to the senate. He did not hold party authority as binding where there was no chance to elect. He spoke highly of Mitchell's ability, and ended by changing from Slater to Mitchell.

Waite (rep.) followed, and then the whole democratic gang, like sheep. After enough democrats to elect had changed, Simon rose, and explaining that his course was prompted by a sense of duty; that he had not come there to vote for Mitchell, but that, under the circumstances, he should feel that he was unfaithful to his trust, ungrateful to the party which had honored him, if he did not vote for the candidate who had received a majority. He therefore changed to Mitchell.

Other democrats followed, among them Miller of Marion, who explained that he changed to Mitchell because Mitchell had assured him that "he will do all he can for the advancement of the present administration, as we require it." At this point Riddle took the floor. He thanked the democrats for taking this job into their own hands and assuming the responsibility of this election. He thanked God that he could go to his home with a conscience free from the shame and sin of having aided to elect so infamous a man as John H. Mitchell to a position of trust.

When announced, the ballot stood as follows:

Previous to this final ballot there was a proposition to adjourn, which was voted down.

When the result of the ballot was announced and Mitchell was declared elected, Miller of Josephine moved that he be invited to appear before and address the joint convention. The motion was carried unanimously and Mitchell appeared.

Mr. President and Members of the Legislative Assembly of the State of Oregon: In response to the vote you have just cast, and in response to your kind invitation within the bar, I am here to return my grateful acknowledgments for the great compliment you have just conferred on me. To be chosen as senator to the congress of the United States by the legislature of any state is a compliment of which any American citizen might well be proud; but when a state, through its legislative body, confers that distinguished honor a second time upon one of its citizens under the most adverse circumstances with which the recipient of that great honor is surrounded, then an obligation is imposed which never can be discharged except by the most faithful and efficient discharge of public duty, not only toward this state and all its people and the republican party, but toward our common country and all its cherished institutions and best interests.

When to a citizen of any state comes the prize of a seat in the senate of the United States, even though it come after a protracted contest and party strife and successful personal effort, it constitutes, in my estimation, a laurel wreath worthy the decoration of the proudest brow; but when it comes, as it has come to me at this time, not so much through my own personal solicitation or effort, but through the votes of both political parties of a great state which I have heretofore had the honor of representing once in those high councils, then and otherwise the laurel wreath becomes in my estimation a golden crown whose beauty and grandeur and unspeakable worth cannot but lend dignity and exaltation and power to the recipient, even though that honor had been conferred upon the most distinguished American within the limits of the republic.
