A crowd quickly gathered at the post-office, and the sack was carried in. While Postmaster Border unrolled the leather bag the anxious crowd peered through the boxes, impatiently waiting for some news from the world outside. Examination proved that the bag contained one, poor, little, damp, ragged postal card from Dora, and no more. People begged the postmaster to read that card, but he was deaf and dumb to all entreaties. We don't know what has become of the world outside; the Roseburg and Coos Bay railroad may have started off to some other sea port; the rest of this planet may have been washed off into star mist, but we cling to Dora. The rain of night before last did the business for all the forks of Coos river in fine shape. Yesterday all the old jams, beached logs, and piled up logs, of every nature and description on every tributary and fork of all the forks got a Waterbury movement on themselves and started for the boom at the mouth of the river. Yesterday the Bertha started up the river on her usual trip, but met such a procession of old growth, young growth, merchantable and unmerchantable logs with all brands, and mixed with piles and driftwood that she turned about, joined the crowd and came back. T. J. Davis was sleeping on his scow night before last, when the storm broke it from its moorings at Nasburg & Hirst's wharf and it drifted out on the stormy waves. After various vicissitudes the craft brought up on the beach near the mouth of Willanch slough, where the daylight found Davis sitting in the cabin on a drygoods box, with about three feet of water over the floor. He was taken out by Alf Butler and J. McDuff, who went out searching for him, and after being treated to a cup of coffee and getting warmed up he was all right.

The rock scow was swamped last week in Coos river and damaged considerably. After she was raised Andy Neal told the man in charge he could take her up, beach her by the windmill and cank her. So the scow was brought to Marshfield, and the only windmill in sight being that of Eugene O'Connell's, at his residence, the parties were terribly perplexed as how to get the craft up there; but when it was explained that the nautical windmill was the old grist mill opposite town, the whole thing was explained, and the whole crowd irigated.

He is more than an ordinary lecturer and in his examination of the heads of subjects it is said he described the characters of the possessors with great accuracy, and brought down the house with his happy hits. People have been compelled to look after their roofs as never before during the past few days. The water has been driven through every crevice, nail-hole and opening from the top of the peak to the last shingle on the eaves. The mail carrier reported three feet of snow, last Tuesday, on the mountain between here and Chetco.

Alf Gauntlett had the good fortune to capture two fat bear during the past week, in a trap which he had set near town.

At Eckley, Curry county, Oregon, a child was born to the wife of John W. Caldwell, which survived but thirteen hours.

Wm. S. Green, who fell from the wharf near the Bay View, on Thursday night last week, suffered a fracture of his right wrist. He was attended by Dr. Tyler, and is making good progress toward recovery.

Superintendent Winsor is showing a very commendable public spirit in having a good substantial walk built from the Bay View hotel to the store, which will be protected by a railing on each side. He also informs us that he has made arrangements to build a good bridge across the creek near Miss Gillespie's shop. If he does this he will deserve the thanks of the whole community, as this creek is a constant source of annoyance during the winter.

A correspondent of the Gold Beach Gazette describes the failure of the game laws as follows:

"At this time in less than fifty miles of Ellensburg there are plenty of hunters' camps provided with tents and pack horses. These are the kind who thin out the deer. And when they have procured hides enough to load their animals, away they go across the California line and sell them. There is a trail from Illinois river to Crescent City, which does not pass a half dozen houses till it reaches California, and one can travel through a sparsely settled country from here to Yreka. Besides such fellows now drive the business more fiercely, as they say themselves, in order to make enough to pay the fine if caught. What does an unscrupulous man care for a fine of ten or fifteen dollars for slaughtering a thousand deer? On the other hand a poor settler who must sometimes kill a deer to feed his hungry children, if he has some malicious enemy to inform on him—and few men are without enemies—he must hand out fine and costs from his meager resources or sweat it out in jail, while his family are left to live as they can. The law was not intended to distress settlers, but such has been the result according to most reliable information. It has missed entirely to operate on the class for which it was intended.

The Del Norte Record, of Crescent City, says: "From the mail carrier who arrived here Friday we learn further particulars of the severe storm in the mountains. Thursday five men with 11 head of horses were five hours making three-quarters of a mile. At the Shelly creek station there is over 20 feet of snow; at the 16-mile stake, seven miles above Gasquet the snow is 5 feet 2 inches on the road; where the chrome mines leaves the main road there is 8 inches of snow. Mr. Gasquet who has lived at his place for over 30 years says this has been the heaviest fall of snow he has ever seen along the road.
