The reason is very simple. As long as the boiler is kept full of water there is no room for steam. If you open the hot water cock, the water pours out, and steam rises from it because it then has a chance to escape into the air.

The cracking noise referred to is heard when the water is unusually hot and is nothing but the expansion of the boiler under the influence of that heat.
