It is usually reckoned that this otherwise waste product will pay for half the picking except in the case of scolded hens, when it does not pay to bother with the feathers. Dry picked hen and generally no more than 7 cents.

All feathers find a ready sale to jobbers and pillow manufacturers.

It is well to send samples to different concerns when you have them for sales and then will make the price according to quality as they see it. Oftentimes one mill will give more than another for the same goods.—Thomas H. Taylor in *Poultry World*.

If the early chickens are to lay before cold weather sets in, they should be well cared for at this season. Give them plenty of food, plenty of room and good air. Sell off the old hens before they begin to molt.

The Pastures

Eye may be used with good results for autumn pasturing of sheep, says C. P. Currier of the Iowa experiment station. I would suggest, however, that one-half the land be sowed to rape and the balance to sorghum. These crops will produce much more feed per acre than rye and they will come on much quicker. The sorghum and rape may be put in as soon as the ground can be prepared after the present season's crop of rye is taken off. When pasturing these crops, the sheep should have the run of a fine grass pasture at the same time, as there will be less danger of frost if the sheep are not confined to the sorghum crops exclusively. Then I would suggest as a means of securing rye for full feed that the seed be sown in a corrugated convenient for pasturing immediately after the last cultivation. It may be sown by hand, and a good deal of it will catch without covering. A better crop will be insured, however, by the use of a narrow harrow that will pass between the rows. We have sown rye at the experiment station at Ames as early as August and as late as Oct. 15, and produced good crops.
