

ORDINANCE NO. 179

An Ordinance to Provide for the Prevention and Removal of Nuisances, and to Declare what shall constitute a Nuisance.

THE CITY OF MARSHFIELD DOES ORDAIN AS FOLLOWS:

Sec. 1. No person or persons shall deposit or maintain, or suffer or allow to be maintained or kept at any place within the corporate limits of the City of Marshfield any putrid, unsound, unwholesome or refuse vegetable or animal matter of any kind whatsoever, or any stagnant or impure water, or any unsound, putrid or unwholesome substance, or any garbage or matter of any kind which shall be or may become of an offensive or unwholesome nature, and any of such matter or substance so deposited, suffered or permitted to be or remain within the corporate limits shall be, and the same is hereby declared a nuisance, and any person or persons depositing or suffering any matter or substance to be or remain in such condition within the corporate limits of said city for more than twenty-four hours after being notified by the Health Officer or City Marshal to remove or abate the same, whether such person or persons deposit such matter or substance or be the owner, agent or occupant of the premises on which the same shall be maintained or suffered to remain, shall be guilty of a misdemeanor.

Sec. 2. Any person who is the owner or occupant or agent for any house or building, or other premises, in which there may be any privy or water closet, stable or other place or thing, who shall keep or permit the same to be in such a condition as to cause a noisome or offensive smell or odor shall be deemed guilty of a misdemeanor and it shall be unlawful for any person or persons, whether the owner, a tenant or occupant of such premises, to construct, use, maintain or suffer any cesspool, sewer or other place or thing, or deposit or permit to be deposited any dirt, sludge, garbage or other impure, unwholesome or offensive liquid or matter of any kind or any matter or substance, which shall be or which may become noisome, impure, offensive or unwholesome upon any lot, place or premises within said corporate limits, or upon any street, alley, gutter or sidewalk adjacent to such lot, place or premises.

Sec. 3. It shall be unlawful for any person or persons, whether the owner, agent or occupant of such premises, to construct, maintain or suffer any sewer from such premises to empty into any street, alley, gutter, or under any sidewalk, or upon any adjacent lot or premises, within said corporate limits.

Sec. 4. Every owner, lessee, tenant or occupant of any stable or place in which any horse, cattle, swine or any other animal shall be kept, or of any place in which manure or any liquid discharge of such animals shall collect or accumulate, shall cause such liquid and manure to be collected in some suitable receptacle and removed as often as once each month to some suitable place outside the corporate limits of the city, and shall at all times keep, or cause to be kept, such stable and place and the drainage, yards and appurtenances thereof, in a cleanly and wholesome condition.

Sec. 5. Any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof before the Recorder's court shall be fined not less than five dollars nor more than one hundred dollars, or be imprisoned in the City jail not less than five nor more than twenty-five days, or by both such fine and imprisonment in the discretion of the court.

The foregoing ordinance was duly passed by the council the 18th day of February, 1902.

REPUBLICAN COUNTY CENTRAL COMMITTEE MEETS

Fix Dates of Primaries and Convention—Apportionment of Representation

The Republican county central committee met at the court house in Coquille City, yesterday. Those present were J. W. Bennett, L. Harloker, L. A. Roberts and Dr. Mingus, the last acting as proxy for Dr. J. T. McCormac. Committeeman Clark was unable to attend on account of Bandon quarantine and Hon. A. H. Black was also unavoidably absent.

L. A. Roberts acted as secretary and in the absence of Hon. A. H. Black, Judge Harloker was elected chairman.

The time for holding the Republican primaries was set for Wednesday March 19th, 1902, at 1 p.m. at the usual voting place in each precinct.

It was decided that the county convention be held at Marshfield on Wednesday, March 25th, at 2 p.m.

The apportionment for the various precincts was based upon the vote cast for Judge Wolverton for supreme judge at the election of 1900, one delegate being allowed for each precinct and one for each ten votes, or fraction thereof over five.

UNITED MINE WORKERS OF ILLINOIS DIVISION

Hold Convention and will Consult With Operators to Fix Wages

Peoria, Ill., Feb. 20.—Six hundred delegates and an equal number of other visitors, representing the local branches of the Illinois division of the United Mine Workers, assembled in annual convention here today, the purpose being to make the adjustment with the operators regarding wages and conditions of labor for the year beginning April 1.

The joint conference will be held next week. So far everything has moved smoothly, and it looks as if a satisfactory agreement will be reached. The majority of the delegates appear to consider the present working scale to be as well arranged as can be expected under existing circumstances.

The only cloud on the horizon lies in the possibility that the operators may attempt to introduce the double standard system in Illinois. The miners of this state are working under the gross weight, or better known, as the "run of the mine" system. In Ohio, Indiana and Pennsylvania the double standard system prevails.

Under the gross weight system the miner gets the benefit of the weight of the slack, the weight credited him being taken before the coal is weighed. The double standard system deprives him of this and it is this question, which it is rumored the operators will raise, which may cause trouble, as the miners are not disposed to stand for the double standard system on the basis of the present scale.
