Chicago, Mar. 4—Prince Henry and his suite had a busy morning of it in Chicago this morning, with bright skies overhead and a crisp temperature.

Following breakfast at the Germania club the royal visitor was taken in charge by the entertainment committee and for several hours was whirled about the city in a sightseeing trip to the banks, board of trade, prominent mercantile houses and other places of interest.

Returning to the hotel the Prince received Governor Vasant and staff, of Minnesota.

At 11:30 came the most interesting feature of the day's programme—a visit to Lincoln Park where the Prince deposited at the foot of the Lincoln monument a magnificent wreath as a personal tribute to the memory of the great American emancipator, saying as he did so, "I am proud to be able to do this."

The wreath was a beautiful affair made of laurel leaves and American beauty roses bound with the German colors—red, white and black.

The Prince was accompanied in his carriage by Robert Todd Lincoln, son of the martyred president, and Admiral Robley D. Evans.

At 2 o'clock the Prince and his suite departed for Milwaukee in a special train over the St. Paul road.

Milwaukee, Wis., Mar. 4—The geographic special train bearing Prince Henry and his suite arrived at Milwaukee on schedule time this afternoon.

It is estimated that 50,000 crowded about the depot and adjoining streets anxious to catch a glimpse of the distinguished visitor.

There was an official welcome by Mayor Rose and the citizens' committee, after which the visitors were escorted by cavalry and German societies to the exposition building where the afternoon's program was begun.

Arches had been put in place which made an electrically lighted colonnade of the streets down which the Prince passed on his way to the exposition building. Here there was a great choral festival by the United Singing clubs.

The big feature of the program is to be the banquet at the Pfister, at which covers will be laid for 250, in addition to the number of the Prince's party.

The scenes attending the passage of the royal train between Chicago and Milwaukee were the most enthusiastic yet encountered. The country traversed is largely settled by Germans and it seemed as if every man, woman and child was anxious to pay tribute to the distinguished visitor from the fatherland. Crowds at every way station cheered and waved to the passing train and every farmhouse and cross-roads had its group of eager watchers.

London, Mar. 4—The Central News' Harris Smith, Orange River colony, correspondent wires that General Dewar was shot in the arm in a fight near the Natal border.

New York, Mar. 4—A dispatch from Faval says the moving Cunard liner has been sighted in tow of the steamer William Calif four hundred miles west. The Etruria reported she had lost her propeller.

Washington, Mar. 4—The House by a vote of 138 to 109 approved the conference report on the Philippines tariff bill which now becomes a law.

It provides in the main a reduction of 25 per cent of the existing duties. The Senate committee on finance today considered the bill passed by the House providing for the abolition of the war revenue tax.

No conclusion was reached but it is believed that the committee will report the bill without change.

San Francisco, Mar. 3—Yokohama advices, dated Feb. 15th, state that but 12 survivors are living, out of 240 soldiers of the Japanese military expedition which was sent out to Awamuro to test the possibility of making long marches in the snow.

One hundred and eight bodies had been found when the search was stopped by a heavy snow storm.

Rome, March 3.—The Pope celebrated the 24th anniversary of his coronation and the jubilee of his pontificate today with great solemnity.

Great mass at St. Peter's this morning culminated in public ceremonies in honor of the Pope's silver jubilee.

Eighty thou and people were gathered at St. Peter's at 8 a. m. 50,000 were admitted.

The service was the most impressive in many years. The Sistine Chapel was crowded with cardinals, Bishops, and

other dignitaries of the Italian and foreign representatives, and thousands of lay spectators.

Several hundred Americans were present. The bright robes of the cardinals and the full dress uniform of pontifical Noble Guard gave brilliant coloring to this spectacle.

Cardinal Rampolla, as Arch Bishop of St. Peter's officiated at the celebration of the solemn Te Deum, assisted by numerous cardinals, bishops and inferior clergy.

The services culminated in impressive ceremonies attending the presentation of a triple crown to His Holiness. The crown is made of gold, and encrusted with diamonds and rubies, the cost (\$200,000) having been subscribed by Catholics throughout the world. The formal presentation was made by Cardinal Respighi, the Pope's Vicar General, and president of the international committee for the jubilee services.

Pope Leo XIII. (Nincento Gioacchino Pecci) was born at Carpineto, Italy, March 2, 1810, and was elected Pope February 20, 1878, after the death of Pope Pius IX., which occurred February 7, 1878. Pope Leo was crowned March 3, 1878.

Washington, March 1—A conference of the House and Senate committees were held this morning at which an agreement on the Philippines tariff bill was reached.

With the exception of a few unimportant changes the bill will become a law just as it passed the Senate.

In the Senate Turner in moving the reference to the committee on privileges and elections of his resolution denying the authority of the chair to deprive a senator of voice or vote, testified to his high appreciation of the compliments paid him by the recent apology of the chair, and disclaimed the existence of any hostility by the introduction of the resolution.

London, March 1—Lord Kitchener reports the following authentic list of the Boer casualties Thursday in the block house drive; fifty killed, ten wounded, seven hundred and fifty-nine captured over one hundred dead and wounded.

San Francisco, March 1.—There are 53 for the California Derby to be run this afternoon. It is expected that nearly all of the entries will start.

San Francisco, March 1—Chas. Slevart arrested as a suspect in the Fuller murder case was brought to this city today. He states that he did not know Nora Fuller, and is entirely innocent of the crime.

He has a facial resemblance to the suspect Bennett, but is lighter in weight. Chief Seymour thinks he is not the man wanted.

Portage, Wis., March 1—Prince Henry's special train is held here by a freight wreck two miles west and the railroad people are unable to say when he can get away.

The Prince has been riding in the cab today and bowed to the people who cheered as he sped by.

Berlin, March 1—It is semi-officially stated that the Kaiser is so pleased with the reception accorded Prince Henry that he will send a squadron of warships to the United States in 1903 under the command of the Prince, to represent Germany at the St. Louis fair.

Topeka, Kan., March 1.—Gen. Wilder S. Metcalf today assumed his new office of pension agent in this city. The general has refuted the charges brought against him in connection with his appointment.

New York, March 1.—The torch of M. Bartholdi's big harbor Statue of Liberty Enlightening the World, was permanently snuffed this morning by order of President Roosevelt, despite many protests from mariners who for years have used it as a beacon.

The occasion of the order was due to the failure of Congress to make an appropriation for its maintenance, which costs about \$200 per annum.

Rome, March 1.—The sacred college tomorrow will present to Pope Leo its congratulations upon the attainment of his ninety-second birthday. Cardinal Gregorio, the dean of the sacred College will read a long speech, to which the Pontiff will formally reply. Monday will mark the twenty-fourth anniversary of his coronation as Pope.

Manila, March 1.—The Seventeenth Infantry sailed for home today. The regiment is the favorite Columbus, Ohio, command.
