The number of hens which should be mated to one male varied with the different breeds. In Barded Plymouth Rocks fifteen females may be mated to one male and 95 per cent of fertile eggs be obtained. Twenty-four Brown Leghorns may be mated to one male and equally good results obtained. All hens should be perfectly healthy and vigorous and should be mated to males equally vigorous and healthy, for in the breeding pens the germs of disease liable to sap the life of the young chick, or a strong, vigorous constitution that will give him life and new strength with every day he grows older.

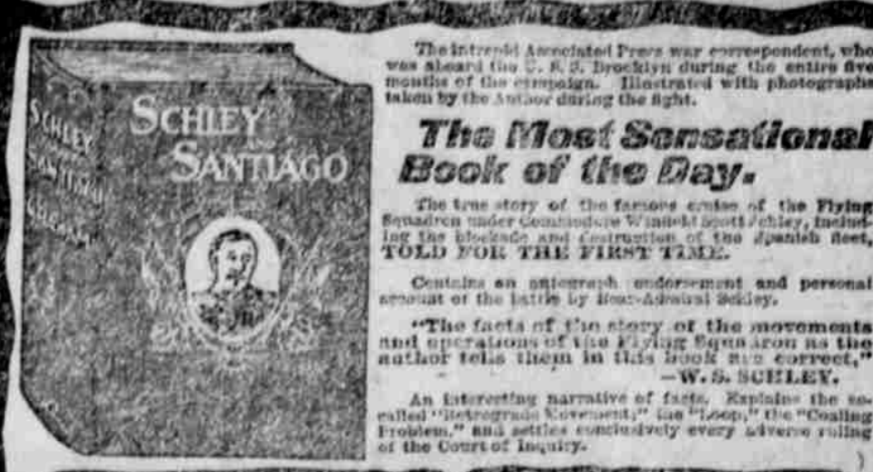
