

Late General News

Los Angeles, March 24—Anita Kelly, a New York society girl, has been awarded \$38,897.60 damages against the Hotel Potter Company, 61 Santa Barbara, for the loss of her leg in an elevator accident.

San Domingo, March 25—General Arias who gave firing order to the insurgents that caused the death of Engineer Johnson, of the American gunboat Yankee, was captured and shot by government troops.

New York, Mar. 24—With the dissolution of the Northern Securities Co., western railroad magnates it is believed have resurrected the community of interest plan, which provides for an interchange of directors, and by this means practically the same relations will obtain as when the Securities Co. was in force.

The tremendous buying of Union Pacific stock recently is said to have been by a magnate heavily interested in the Great Northern, who will be elected director in the Union Pacific.

San Francisco, Cal., Mar. 24—The following statements were made by the fighters this afternoon.

"I will go into the ring in better condition than ever before in San Francisco. I have built up for the weight and am at my strongest and expect to win with a knockout." Corbett.

"Never have felt more fit for battle. Have reached the weight without impairing my strength. Am active as ever and expect to add a decisive victory to my record."—Britt.

Tutill, Corbett's chief trainer, announced this afternoon that the champion weighed 123½ this morning.

San Francisco, March 23—The Botkin trial was marked this morning by a sensational verbal encounter between Attorney Knight and Mrs. Grace Tuchler, one of the chief witnesses for the prosecution.

Knight asked her a number of questions concerning her life before marriage. With tears in her eyes she vigorously denounced the questioning as cowardly, ungentlemanly and insulting. The court rebuked Knight, and refused to permit him to continue to pry into the witness' private life.

Mrs. Tuchler as Grace Harris was clerk in a dry goods store where Mrs. Botkin is alleged to have purchased two handkerchiefs one of which was in the candy box. Mrs. Tuchler identified the accused as the woman to whom she sold the handkerchiefs.

San Francisco, Mar. 25—The morning session of the Botkin trial was consumed by arguments over the testimony of Prof. Thos. Price, the poison expert. The defense claims there is no proof that the candy handed over to him for analysis was the same received at Dover. The court will pass on the question later.

Chicago, Mar. 25—One dead and fifteen injured is the known list of casualties, the result of a terrific tornado which swept the suburbs from Evanston to Indiana Harbor last night, causing a property loss of half a million. The latter town bore the brunt of the storm and houses were unroofed and buildings blown in.

Louis Baker was killed and a number injured by the collapse of a two story building in East Chicago.

Hammond, Thornton Dauphin Park and other towns suffered severely. Telegraph and telephone wires were prostrated and Chicago was practically isolated for twelve hours.

St. Louis, March 25—Half million dollars damage was done and two persons were fatally injured in last night's storm. In Alta suburb, the Pittsburgh Reduction Company's building was

blown down. Several buildings of the St. Louis Fireworks Company were destroyed, Dinzer's hotel and a number of residences were demolished, and a panic was created.

Naples, Mar. 26—King Victor and Kaiser Wilhelm lunched aboard the Hohenzollern today.

Port Louis, Mauritius March 26—Twenty-four were killed and immense damage was done on the 23d, by a tornado which swept the island.

Wichita, Kansas, Mar. 26—Editor Smith, of the Daily Beacon committed suicide today by hanging himself. The cause was an indictment for perjury, against which he had no defense.

Washington, Mar. 26—It is practically decided that Rear Admiral Coghlan, commanding at the Isthmus of Panama, will succeed Rodgers as commandant at the New York navy yard. Jewell is to relieve Coghlan.

Louisville, Ky., Mar. 26—It is believed that damage throughout the South due to the storm now raging will aggregate a million in property loss.

In this city fifty residences have been unroofed, and churches and distilleries damaged.

Washington, Mar. 25—The postoffice appropriation Bill was passed late this afternoon. The item raising the salaries of rural free delivery carriers to \$720 per annum and taking from them express and news agent privileges was retained after a sharp contest.

Washington, March 26—The House today adopted a resolution permitting the son of the late president of Nicaragua, Sealaya, to attend West Point. The House disagreed with senate amendments to the Indian bill and sent it conference. Then took up the Sunday Civil bill carrying 55 millions.

St. Paul, Minn. Mar. 26—A decision was handed down today that artistic work is not subject to the rules governing the work of artisans.

The Minnesota state capitol commission awarded to a New York firm a big contract for mural decorations. The painters union sought an injunction on the ground that no bids were asked. The court over ruled the motion on the ground that the work was purely artistic.

St. Louis, March 26—The day of the trial of Senator Burton, of Kansas, began with the rebuttal testimony, at the close of which the government's counsel made an argument dwelling principally upon the actual and implied influence attendant upon the use of the Senator's name by a corporation such as the Rialto Grain Company.

Burton's lawyers pictured the horrible consequence of mistaken justice. The Senator himself seemed collected.

Portland, Mar. 25—The Alliance sailed for Coos Bay today with the following passengers: Mrs. Bascomb, and family, J. A. Hinch, and family, M. J. Courry, C. R. Seeley and wife, Mrs. Kirenman, J. M. Foster, Mrs. F. B. Tichnor, Rev. J. A. Seerist, Mrs. D. Bonewitz, Geo. A. Taylor, L. L. Differbrech, Wm. Miller and wife, H. W. Nelson, L. D. Nash, Mrs. Jessie Kelley, S. S. Fresno, Jas. Collins, H. M. Averill, A. J. Paul, E. J. Kirkman, and wife, G. B. Osborne, E. W. Beeman, S. Kelley and six steerage.

Chicago, Mar. 26—Niedermeier, Vandine and Marx, the carban bandits, were today sentenced to hang. April 22. They betrayed no emotion when the sentence was passed upon them. A big crowd rushed to the railings when the condemned men passed out, and deputies fought the people back.

The mothers of Vandine and Nieder-

meier were present, the former bowing in grief, the latter apparently unimpressed.

Union, Mo., Mar. 26—George Collins alias Fred Lewis was hanged at 1:30 p.m. today. He was a participant in the murder of detective Schumacher near Swanton January 23, 1902. When the detective attempted to arrest Collins and Bill Eudolph for bank robbery.

Rudolph was found guilty this afternoon and his punishment will be death. The verdict was rendered an hour after the drop fell for Collins.

Just as the black cap was adjusted, the latter said "Cutter loose boys and make a good job of it."

Wilkes Barre, Pa., Mar. 26—A cage full of mine workers at the Dorrance colliery fell down the shaft today, and several are reported killed.

The rope broke and the cage dropped six hundred feet. Two dead bodies have been brought to the surface, and six or eight more are at its bottom. The shaft is blocked with wreckage.

It is known that four are dead, and probably a fifth victim will be found. The engineer failed to stop the car and it crossed into the the stoll wheel and fell back a thousand feet below the surface.

Five hundred miners, fearing an explosion, fled through the distant openings.

London, Mar. 26—In the race between the picked oarsmen of Cambridge and Oxford Universities today, Cambridge won by four lengths, in 22 minutes, 34 seconds, there was much interest in the event and the contest was witnessed by an immense throng of spectators, although, owing the court being in morning for the Duke of Cambridge, there were no royalties on the banks.

The races between Oxford and Cambridge date back to 1829, when they were rowed in tubs over the course from Westminster to Putney. Since 1846 the contesting oarsmen have swept the historic path along which the struggle today was waged—from Putney, to Mortlake,—but in the meantime the racing craft have evolved from crude, unwieldy skiffs into the keelless, outriggered shells that skim over the water like swallows. Sliding seats were used by the crews for the first time in 1872.

New York, Mar. 26—A serious fire started at noon in the basement of a building on Broadway occupied the Norris European Express Company. The flames spread to two adjoining buildings and in the Consolidated Stock Exchange opposite, business was suspended.

At one o'clock the fire was under control. There was much excitement because of the location in the heart of the financial district. Bankers and brokers removed their valuables and the big office building were emptied of people by order of the police.

The general offices of the Adams & Norris European and American express company were destroyed. The estimated loss is four million. Thousands of dollars worth of registered express bullion was carried out in suit cases and baskets through the rear of the burning building. The Well Fargo people hauling out over one hundred thousand in cash.

San Francisco, March 26—Jimmy Britt was given the decision over "Young Corbett," by referee Graney, last night, after twenty rounds of hard fighting without a knockout.

San Francisco Cal., Mar. 26—Little the worse for the terrific in which they engaged last night, Britt and Corbett are around today, one receiving the congratulations of friends the other condolences.

The latter is simply deluged with congratulations. He is suffering somewhat from the punishment particularly about the face and left eye.

The sentiment of many who last night agreed that Britt was entitled to the decision changed today and the belief is growing that a draw would have been a better verdict.

Corbett spent the night in a bath, his utter dejection preventing a good rest. When he arose this morning, his feeling that he had been given the worst of it by the referee was undiminished.

He is without a mark as a result of the fight save a slight cut over the left eye. His plans for the future are unsettled but it is likely he will remain here a week or so in the hope of being rematched with Britt.

Buffalo, N. Y., March 27—Jim Corbett said today: "I'll take Graney's decision as right regardless of how the rounds read. Corbett was stalled too much I'm afraid. It looks as though Britt was in better condition, and won in the last two rounds."

Berlin, Mar. 25—German troops have defeated the rebel Herreros at Omatako. Two Germans were killed and three wounded. Ten Herreros were killed. The Germans also captured Ormuramb together with several thousand head of cattle which had been plundered from the colonists.

Everett, Wash., March 25—Jack Lebro, a saloon keeper at Bryan, Wash., whose life has been threatened many times, was shot through the heart and instantly killed last night by an unknown person while he was locking up his saloon. His was the only saloon in town and a license was granted a short time ago in spite of a petition signed by nearly every citizen.

Denver, Colo., Mar. 25—Captain Wells, of troop A, has established a press censorship at Telluride not equalled by either Russians or Japanese.

Ten strikers' families Thursday. It is learned by mail, were ordered from their homes during a howling blizzard, marched to the depot, placed on the cars and ordered never to return. The exiles, some with small babies, reached Ridgeway almost frozen and destitute. They were taken care of by the Western Federation.

It is understood that Wells will today repeat the performance. The Captain is charged, in the injunction suit against the Telluride Citizens Alliance, with being the ring leader of the mob which drove out 25 unionist from town.

Ouray, Colo., Mar. 25—Eleven deported unionists from Telluride returned to that city on the noon train, on the advice of President Moyer of the Western Federation of miners. As soon as they arrive they will be "bull pened" by the military, when habeas corpus proceedings will be instituted.
