ALBANY TO TILLAMOOK.—The following item from the Astoria Pioneer indicates that there is at least a rumor in reference to building a railroad from Albany to Tillamook, and we arise to second the motion if there is a ghost of a chance for such a project, and to announce that Albany will stand in with Cass and the Chicago syndicate everytime. If W. S. Ladd goes to interfering we will bury him in his artesian well: "W. S. Ladd, of Portland has secured control of the only pass from Sheridan to Tillamook county, and has recently purchased nearly 3,000 acres of land along the proposed line of the narrow gauge railroad to run from Sheridan to Tillamook. It is also rumored that he is negotiating for land along the proposed line of the Astoria and Coast railroad. While the property is deeded to him it is generally believed that he is buying the land and secured the pass for Dundee Reed's narrow gauge road, so as to shut Cass and the Chicago syndicate out and prevent them from building from Albany to Tillamook."

LEBANON.—Miss McConnell is teaching a writing class in the public school building. She will also teach a class at Soda-ville.... Mr J G Eaton, living in the northern part of Lebanon, raised this year, on 3 1/4 acres of stumpy ground, 144 bushels per acre.... As young Mr Guire and mother were coming from Fox Valley to Jordan in a cart, at the grade the cart tipped over and cart, horse and passengers rolled down the hill about twenty yards. Mrs Guire and son were badly bruised up but not seriously hurt.—Cor.... On Tuesday last as Mr. W. A. Gleason was gathering apples on his farm on Hamilton creek, ten miles from town, he slipped and fell a distance of twelve feet, sustaining a dislocation of the shoulder blade and collar bone, besides receiving internal injuries to such an extent that he remained in an unconscious condition until the arrival of Dr Lambersen, some three hours after the accident. The doctor succeeded in resuscitating him and attending to his injuries, and at last accounts he was resting easy. Mr Gleason is 66 years of age and a good citizen.—Express.

ALBANY COLLEGE.—The Albany College will open on the 11th of September under very favorable circumstances. The number of new scholars promises to be larger than for several years, and the faculty will be better prepared to meet the demands of an increased attendance. The College building has undergone repairs and has been generally improved until it will be a place a student may be proud to spend a year in. The re-arrangement and decoration of the second story rooms has added wonderfully to their appearance. The chapel is now a pleasant room, with entrances from the two society rooms, and will be a much better place than before for holding entertainments. Our citizens should continue to support the College to the best of their means.

TWO SUITS.—Several Harrisburg people are in Albany to-day, being called here on account of two suits brought by Hon. J. P. Schoelling against Marion Hyde and Mr. Wyatt, in Justice Humphrey's court. We understand the latter was settled.

WIDE AWAKE.—At Albany the board of trade and citizens treated the traveling school teachers handsomely and were thanked in appropriate resolutions. Albany people are wide awake and up with the times.—Salem Journal.

A FORTNER.—Since the bridge has been built at Salem a small sized West Salem has been springing up across the river. Farms have been cut up into small tracts and the settlement is growing fast. This is one result of the bridge.

SEVERAL ARRESTS.—On complaint of Mr. J. A. Gross, of the Depot Hotel, Arthur Knoeller was arrested this morning for using profane language, taken before Recorder Henton and fined \$5 and costs. Young Knoeller had been working as a waiter at the hotel and had several quarrels with the other waiters, Mr Gross and people generally. He is a fresh looking, fiery little German, with a temper like that of a five dollar razor and flies to pieces like a bursted bomb. In a dispute with one waiter he tragically reached for his hip-pocket, when the waiter became frightened and rushed for the Marshal; but the Recorder properly refused to issue a warrant. Young Knoeller then had a quarrel with Mr Gross, in the course of which he was hit on the head. Thinking the circumstances did not justify an arrest both Recorder Henton and Justice Humphrey refused to issue a warrant. Justice Brink though wrote out the document and Mr Gross was duly arrested for assault and battery. The case has been set for 4 o'clock this afternoon, and will be tried before Mr Brink and a jury. Verily our citizens are on the arrest, and it seems to be getting epidemic.

PREVENTION OF PROFANITY.—Albany is so much like Salem in the matter of protruding nails that we publish the following from the Journal, hoping that it will be suggestive to some of our citizens: "J. B. Fithian, editor of the Vidette, was seen this morning with coat off and sleeves rolled up, diligently driving down the dangerous, protruding nails in the plank crossing on Liberty street. This was supposed to be an act of pure public spiritedness, but inquiry developed the fact that the motive was higher and grander than that. The Colonel has resolved himself into a society for the prevention of profanity. And since editorial and other toes have been stubbed times without number and at least one pair of brand new shoes wrecked on the sidewalk spikes, he determined to attempt to reduce the growing blueness of the lower stratum of the atmosphere by this labor of love."

MIGHTY FAST.—"For a long time Hank Delen, an engineer on the Short Line, waited for an opportunity to see how fast he could run an engine without breaking rules. The other day when George B. Markle came flying up country on a special, Hank Delen had the good fortune to take him over his run from Huntington to Glen's Ferry. When he struck the right place the engineer let the iron horse show his mettle and ran the special over sixty-five miles of the track in sixty minutes. This is probably the fastest time ever made in the Northwest."—Telegram.

FRUIT.—"L. Martin shipped a car load of Southern Oregon fruit to Helena and Butte, Montana, Tuesday morning," says the Tidings. The car load was made up of choice lots of pears, apples, plums, prunes and nectarines, and a nice shipment it made, too. Seeing car load lots of Southern Oregon fruit, with the boxes all handsomely labelled, going out from Ashland to distant points, is indeed encouraging to the interests." Mr. Martin was also trying to fill an order for a car load of pears for Chicago.

A LAWN SOCIAL.—Brightly shone the Chinese lanterns on Dr. J. L. Hill's lawn last evening, and brighter were the faces of the large gathering of people as they partook of the shingle lunch, and ice cream and lemonade, and talked and played games. It was a lawn social and was given by the Vineyard Laborers of the Baptist church. Such occasions leave a mellow spot in one's heart, and should be often repeated.

LUCKY FOR DAVIS.—It now appears that the chances are good for the recovery of Layton Tindle, the young man who was beaten over the head by William Davis, at Ballston, on Friday, the 10th inst. Yesterday he was perfectly conscious and was able to sit up for a short time. His skull was not crushed as was at first reported, and it is probable that he will entirely recover from the effects of the assault.—Statesman.
