JUTE SACKS.

The Herald quotes an article from the Tidings to show that the duty on jute sacks is a good thing for the farmer and people at large. The Herald approves what the Tidings says, for it calls the article a "truthful airing." The article pools, pools, and belittles the protest which farmers set up against the inexcusable folly and injustice of making them pay a tax of one cent on every bushel of grain to be shipped in sacks when the government does not need this tax, when there is but one jute mill on this coast to protect, and whose employees are largely Chinamen at that, and at a time when farmers find extreme difficulty in making both ends meet in raising grain to ship to a free trade country to find a market where they are compelled to compete with the cheapest pauper labor in all the world. In order to show the contemptuous manner and disdain with which the Tidings and Herald treat this important interest of the farmer, we quote what they say:

"The democratic papers have had a violent attack of sympathy for the American farmer, brought about by the discovery that a duty is imposed upon jute bags, amounting to two cents for a two-bushel sack. What a striking text for discourses upon the iniquity of the tariff and its robbery of the farmers! One cent upon every bushel of wheat stolen from the husbandman by our thieving protection government! Ten whole, big round, silver dollars on every thousand bushels of wheat the farmer must contribute to this system of protection to American industry! This is bad, very bad, indeed."

We have heretofore shown in these columns that the farmers of this county will ship over two million bushels of grain this year. The tax on the sacks necessary to ship this grain will amount to over twenty thousand dollars—nearly enough to pay the current expenses of Linn county for a whole year. And this burden on the farmers the Herald treats as a mere bagatelle, a mere trifle which farmers should quietly submit to without a protest, and when they do protest it treats them with ridicule and sarcasm as shown above. The Herald will find that the farmers are not fools about this tax which they are compelled to pay without reason or excuse. Every farmer knows that an advance of one cent per bushel on grain is a very material and important addition to the profits, (if there are any,) in wheat growing, and now, in view of the fact that for several years it has been a grave question whether grain growing can be made to sustain itself, they are in no humor to endure such ridicule as is extended to them in the above extract. The Herald will find it a difficult and burdensome task to make farmers believe that their financial condition is made better by taxing them one cent a bushel on their grain without the shadow of necessity, reason or justice.

E. H. Barker, Agent and Superintendent of the Cochran-Oler Ice Company, of Dresden, Maine, heretofore an influential Republican, believes in tariff reform, and will vote for Cleveland. W. Bradstreet, whose alleged conversion to Harrison and Morton has been made much of, says that he had voted the Republican ticket ever since that party came into power. He thinks the duty should be taken off sugar and necessities of life rather than whisky and tobacco.

The Connecticut Republicans not only nominated candidates for Governor and Lieutenant Governor, but they gulped down the Chicago platform, free whisky and all. To take the taste of free whisky out of their mouths, however, the members of the Connecticut Convention adopted a resolution favoring local option as a means of suppressing the evils of intemperance. The exigencies of Republican politics require some awful straddling this year, and the Connecticut Republicans are determined to be equal to the demands of the occasion.

During a Cleveland and Thurman meeting of over 100 iron moulders employed by Rathburne, Sard & Co., at Albany, N. Y., on Tuesday night, 14 members of a local Harrison and Morton club signed the roll in a body and announced their allegiance to the democratic cause amid the cheers of their associates.

W. M. Brown of Clermont, Ind., says: "I never have voted a democratic national ticket in my life, but shall vote for Cleveland and Thurman next November if the Lord spares my life."

Senator Vance says: "North Carolina is as safely democratic as any southern state, and our majority next autumn will not fall short of 15,000, if it does not greatly exceed it."

The Journal of Caldwell, Kan., for many years the leading Republican paper of Southern Kansas, made a sensation to-day by coming out flat-footed for Cleveland and Thurman and the entire Democratic ticket. In its leading editorial it charges that the Republican party has deviated from the paths of political rectitude and absolutely repudiated the various promises made in the past with reference to lightening the burdens of unjust taxation. It lauds the executive acts of President Cleveland and denounces as hypocrites those who accuse him of being a free-trader.

The Mills bill seems to have shut down one mill, for a time, at least, and every honest, truth-loving citizen has been rejoicing thereat. It is the "outrage mill" that for a time has been squelched. But, mark the prediction! Before this campaign is over, that "mill" will be run day and night with a double set of skilled workmen, such as republican leaders are always able to call into service, and the bloody shirt will flap in the breezes as loudly as in the palmy days of reconstruction.

Congressman Vance of Connecticut who has been at home for some time feeling the political pulse of Connecticut voters assures the national committee that it may depend upon an increased majority in that state over that of 1884.
