We have been informed that Frank Orabiree his purchased a 400-acre stock farm near Cottage Grove and will move onto the same this fall.


Mrs. M. Alexander was severely in-jured last Sunday by being thrown from a hack backwards, sustaining a fracture of the breast cone besides being badly bruised.

Wm. Savage returned home Saturday from Nome City, Alaska. He says be is home this time to stay, having secured all the gold he cares for.


