LOCAL RECORD.

MASON LONG.—This reformed gambler talked last evening to a crowded house at the W. C. T. U. Hall. Though a fine looking gentleman he has the appearance of one who has been through the mill. Uneducated, except by experience, he is a fluent speaker, eloquent at times, and holds his audience in close attention from the beginning. He talks facts and gives startling experiences, and there is nothing like speaking from experience in this world to command an influence. A certain class of newspapers, like the *Oregonian*, *Astoria Pioneer* and others, may sneer at the efforts of reformed men and declare that they are only working for the money there is in it; but, all the same, they are the "boys" that get down to the heart and open the eyes, and the truth is most of them are sincere as we believe Mr. Long is. He has been at it ten years and hasn't backslid yet and probably never will. We hope they all make some money at it, for a man who cannot draw well enough to command a few dimes in a collection or at the door is not the man to command an influence.

TOO NEAR HOME.—That distance lends enchantment to the view is as true about mines as other things, and that is the trouble about Linn county mines. They are too near home. Mr. G. A. Dyson, in the *Oregonian*, says: "Only a couple of weeks ago a young man of this city, (J. P. Coshaw, jr.) who had spent some months in Butte City, Montana, came home, and brought down some fine specimens of ore from those justly celebrated mines, and comparing these aforesaid specimens with some here, brought from Blue River, some people laughed at the idea of their resemblance, and yet careful comparison shows that the quality, color and grain of the quartz is exactly the same—the same colored and shaped sulphurets of iron, and the galena is the same."

LAWYERS TAKE NOTICE.—The following rule has been adopted by the Supreme Court: Ordered that rule 13 of the rules of this county as adopted Nov. 4th, 1885: Rule 13, the page of the printed brief must be eight and one-half inches in length, five and one-half inches in width, and the other blank margin of each page be one and one-half inches wide, and the points, or propositions of law with the authorities cited to sustain them, must be separately stated from the argument. The points and authorities must be first distinctly stated, and the argument set forth supplementary thereto. This rule shall take effect and be in force on the first day of the March term A. D. 1889.

CROOK COUNTY.—On Friday of last week while E. L. Schmeer was riding a colt on the Prineville race course, the animal took a run with him and plunged suddenly into a fence composed of a single barbed wire. Fortunately neither horse nor rider was seriously hurt. The animal received an ugly gash in the region of the throat, and Ed. got a slight cut below the knee. It is again our sad duty to chronicle the intelligence of death. Miss Octavia Carnical, aged 19 years, 3 months and 3 days, passed from earth at 10 o'clock on Monday morning of this week, Feb. 18th. Deceased was born at Sodaville, Linn county, this State, and came here with her parents several years ago.—*News.*

A RUMOR.—The *Corvallis Times*, which is always hitting the O. P., has discovered the following rumor somewhere: "It is quietly rumored, with some degree of authenticity, that there will soon be a change in the management of the *Oregon Pacific* railroad. The road will probably go into the hands of the Chicago & Northwestern, and be completed with money instead of red tape and law suits."

A MISTAKE SOMEWHERE.—"Complaint is made in the *DEMOCRAT* about the irregularity of the mails between Salem and Albany, and the non-receipt of that paper here. There is a mistake somewhere. ARRESTS.—During January and February there were 24 arrests made by the police of Albany, as follows: Vagrancy, 5; drunk and disorderly, 11; fighting, 4; loitering on streets, 4. Committed and ordered to work on streets, 15; dismissed, 3; fines paid, 5, \$25.

CURRENCY.

This is a little item with a hornet's nest in it, and shows how real estate has jumped up in Albany. The same property near Tacoma, though, would sell for probably ten times as much.

We predict that next Monday matters will go along just the same as they have been going on in Oregon for the past four years. No particular change in temperature is looked for, though there will be plenty of changes and soon plenty of men without "change."

An Astoria paper is boasting about a new curfew law and advises the boys to look out. We have a curfew law also; but it gets laid up in bed once in awhile. It would be a good thing for the boys of Albany if it were absolutely enforced.

Yesterday we saw a seven year old boy smoking a cigarette; probably a "hold over," as most, if not all, of our dealers are conscientiously respecting the law. The trouble will be in older boys buying the croppings for them. Had the law simply applied to cigarettes it would have covered the field practically, for that is what has always taken with the kids, whose white lips now testify to the habit.

WILL BE EXTENDED.—There is a pretty strongly reliable rumor afloat that the road will be extended to Sodaville this year. If so it will boom that popular watering place as well as Waterloo, for there is a tall to the rumor to the effect that the road will run directly into the vicinity of the Sweet Home coal mines. There is really as much fire smoke about this.
