## LOCAL RECORD.

**ANNUAL MEETING.**—At the regular annual business meeting of the W. C. T. U. some quite interesting reports were given. The Secretary's report showed a membership of near 100. Regular meetings have been held each alternate Tuesday, with an average attendance of 16. Financial report showed \$515.50 to have been received for the year and disbursements \$480.52; \$125 of indebtedness on hand has been paid, beside paying interest on the rest of debt. The following resolution was adopted:

Resolved, That the W. C. T. U. of Albany, in appreciation of the many favors shown them by the editors of our city papers, in inserting notices of our meetings free of charge, and in lending us a column of space each week, for the promulgation of temperance sentiment, hereby tender their generous members of the press a hearty vote of thanks for these courtesies.

The following officers were elected: President, Mrs. E. F. Sox; Vice Pres., Mrs. W. H. St. John; Recording Sec., Mrs. S. A. McAllister; Cor. Sec., Mrs. M. H. Ellis; Treas., Mrs. K. Althouse; Organist, Mrs. Lee. The next meeting of the union will be on Tuesday, April 16th, when the ladies will be glad to see all the members present.

**GONE ABROAD.**—Already the rapidity with which Albany raised the woolen mill subsidy has given it a reputation as an enterprising city. A Princeton paper says: "The people of Albany are always awake to their interest, and their purses are ever open to any enterprise that will help to build up the place. A short time ago a bonus of \$25,000 was asked to insure the moving of the Brownsville woolen mills to that place. The amount was raised in four days, and within six months Albany will have the best woolen mills in the state."

**FLOUR MILL BURNED.**—The flour mill of Thos. Samuels, at Monroe, was consumed by fire Monday night, caused by the explosion of a kerosene lamp. About 5000 bushels of wheat, 400 barrels of flour and considerable mill feed belonging to Mr. Samuels and several thousand bushels of wheat belonging to farmers, were burned. The entire loss is estimated at about \$20,000. Mr. Samuels carried \$10,000 insurance on his part of the property burned.

**A BIG HORSE.**—Probably the biggest horse in the world is in the city. He is 6 feet 10 inches tall, or 20½ hands, and weighs 2760 pounds more than two common horses. A tent has been pitched next to the Democrat office, and the horse can be seen beginning to-morrow for only 10 cents. Woman and children as well as men should see this wonderful animal.

## OLD OREGON.

Moscow, Idaho, March 28th, 1889.

Editors Democrat:

Leaving Walla Walla, and winding our way a little northeasterly, we pass through the same extensive stock and agricultural region that characterizes Eastern Oregon; passing the arm of the O. R. & N., that runs to Dayton, a prosperous town, laid out by Jesse Day, of Douglas county, Oregon, several years ago. Thence to Starbuck where another arm of this road extends to Pomeroy, another growing town. Thence to Riparia, or Texas Ferry where the railroad crosses Snake River and where a steel and iron bridge is being built for the same. This place in summer is the hottest place outside of the popular resort of the wicked. From this point small steam boats run to Lewiston. Thence the railroad runs to a point west of Cudicott, on the Palouse Junction road to Colfax, where this train is divided, one section goes to Moscow, Idaho the other to Rockford, W. T. This is the Palouse Center, the great attraction of the Northeast in richness of soil and productive ness. Colfax is the county seat, having two thousand population and a wealth of two millions. There are three banks, and every type of business is carried on here. This may become a railroad center and will if the railroad now running from Cheney to Davenport extends to Colfax, as contemplated by the citizens of Colfax. This will give a route from Portland to the Big Bend country direct and break the monopoly from which Colfax is suffering. As elsewhere property is looking up here. Upon the line to Moscow there are Pullman, Colton and one other station; these towns are flourishing. Moscow has fifteen hundred inhabitants and is a center of great future promise. It draws from the Palouse and Patlatch, two noted sections for rich, deep and productive soil. These towns are growing rapidly. Of this same class are: Spangle, Resalia, Oasdale, Belmont, Garfield, Uniontown, Genesee and Palouse City on the Spokane and Palouse road, and Farmington, Tokah and Lato on the O. R. & N. This Palouse belt of rich soil has no known equal in our country. Out of 95 per cent of cultivatable land only 15 per cent is used. The wheat production is incredible. The land produces from 24 to 70 bushels per acre. And the crop of 1887, was not removed until January, 1889, and now these two railroads are working on the wheat crop of 1888. Lands sell from \$5 to \$20 per acre, with an upward tendency. For and up to March 10th it was shown that fifty families came into one portion of the county of Whitman and during the entire month cars were filled with immigrants. It is a low estimate to say that one thousand immigrants have found homes in Whitman county, in this month. Immigrants seem to know where they are going and they soon take care of themselves. By turning up the sod simply, over twenty bushels of wheat per acre are harvested, so immigrants take hold at once, and go to work. Lato, terminus of the O. R. & N., twenty miles from Spokane, has 700 inhabitants, and nearly all these towns support newspapers. Even Spangle with three hundred inhabitants has its newspaper. Moscow is located near the Oregon line, and many Oregonians lead in business in the city. The Moscow bank has a Salemite for President, Mr. A. L. Gilbert. Mr. McConnell from Yamhill and once a member of the Oregon Legislature is one of the leading merchants. Mercantile stocks are enormous. The leading physician is Dr. Worthington, of Yamhill county and so on to the end of the chapter, they cannot do without Oregonians. This country has plenty of timber and water, and can sustain a large population. There is no part of the territory so well advertised as Whitman county, and Moscow gets the benefit of it. As the best portions are usually held as Indian reservations it may well be asked how this valuable belt extending from Idaho to Spokane was not given to the Indians. Immigrants are from Dakota, Kansas, Nebraska, etc., and they bring some means with them. There are plenty of banks all over this country and they watch over the producer with a fatherly care. It is nothing for a town to grow up in a few months in the Northeast. Eastern Oregon and Washington are receiving additions to population in every direction. Those familiar with the climate of the Willamette Valley will be astonished at this announcement. But there is not room for all in any one portion of the country, hence it is well that immigrants divide up. The winter in the sections described has been short and mild, hence fortunate for stock which owing to the extreme long hot season of last year, and want of grass, look very slim. But it will soon come out as the grass is coming on. Money is not plentiful owing to slow disposal of wheat. More railroad facilities are needed.

No WHERE ELSE.—"Note and Comment" in the Oregonian says it is a good thing to keep the state buildings together at one place so that they will be near the state officers, hence the reform school should be at Salem. New York, Pennsylvania and other Eastern states think differently, and even Washington is scattering them, which is the proper way to do. Albany is not very excited over the matter anyway. Can get along without it.

A BRICK AT SCIO.—Yesterday Mr. Ed Goin of Scio left an order for the Albany Iron Works for an iron for the new brick to be built at that city. It will have a frontage of twenty-seven feet and will be three stories high. Scio people are waking up with the rest of the valley and propose being up with the times.

AMUSEMENT TO-NIGHT.—This evening at 7 o'clock the fire boys will have a department drill on First Street under the supervision of Chief Stewart and his full corps of officers. The companies will parade up First Street from Lyon and an exhibition will be given of what would take place in case there was a fire.
