COUNTY COURT PROCEEDINGS.

(D. R. N. Blackburn, Judge; R. W. Cooper and G. W. Phillips, Commissioners.)

At the evening session of the county court the matter of bridges was taken up. The Stayton bridge was urged by the Linn committee, consisting of Hon Alex Downing, W. H. Queener, Henry Follis, Wm Daily, Ben Irvine and J. R. A. Irvine. A communication from the Marion county court was read to the effect that that court had appropriated one half of the estimated cost, \$7500, and Linn county was asked to do the same, the estimated cost being \$15000.

The contract for building fence around the Court House was let to O W Warren at 24 cents a foot, to be like fence around school house.

BROWNSVILLE.

BROWNSVILLE, June 4th, 1889.

Last week Messrs. James Blakeley and James Smith arrived here from Prineville. Messrs. Pat Moore and Bert Wilson began wool-sorting for the Eagle Woolen Mill Co. last Wednesday.

M. J. Titus, father of Mrs. C. H. Cable arrived here Friday from Lake county. He came by private conveyance and was just ten days on the road.

J. H. Winter our photographer is here for the summer. The presses for our newspaper and job office are now here and being put in place for work. Our paper will be called The Brownsville Times.

O. P. Coshaw and sons sold the property of Chas. H. Younger to J. D. Boyer, last Monday. Consideration, \$700.

Chas. H. Younger and family move to Albany this week and will make that place their future home.

Most of the stockholders of the Brownsville Woolen Mfg. Co. went to Albany Monday and while there will receive bids for the construction of their Woolen Mills buildings.

Dr. Vlah and family arrived here from Forrest Grove Monday, and have rented the residence of Wm Byers.

Friday we received our mail, the first and only mail of last week. Monday we receive another mail, but from appearances now (Tuesday) it is the last mail we will get for sometime over the Narrow Gauge. The men, if it be lawful to call them such, who have been running the train since the old hands quit were completely disgusted Monday and declared they would leave the train at Coburg. They run out of water before reaching Coburg, and the Narrow Gauge train now is standing in the middle of a field about two miles north of Coburg. The people along this road have become thoroughly tired of seeking accommodations and giving to this road and have about as small an opinion of men that will work on it as they entertain for the managers of it. The people at the north end of the line refused to let new employees have anything to eat, and the employees in addition to such hardships as this declare the new Superintendent and Receiver of the road positively lied to them in order to get them to take hold of the train; hence they felt justified in leaving the train at Coburg. They were from 7 a. m. to 6 p. m. coming from Ray's Landing to Brownsville. Our Postmaster sent the mail to Halsey this morning and we expect to get our mail from that point until matters are settled on this line.

Henry was chosen Marshal. Hon. J. P. Galbraith, Reader and Rev. R. Robe, Chaplain. The several committees are all at work and complete arrangements are being made for a grand good time.
