THE JEFFERSON BRIDGE.—The Salem Statesman, in its customary style, has the following to say about the Jefferson bridge, very unreasonably laying the matter at the feet of Albany, and forgetting that Salem first got a bridge of her own before she howled so much for other sections. Albany people are generally in favor of bridges all over the county, no county in Oregon spending more for that purpose, and our citizens would probably vote for a bridge at Jefferson; but it is a matter the County Court decides and not the city, as the narrow minded man on the Statesman seems to think.

A Statesman reporter had a conversation Friday evening with County Judge Blackburn, of Albany, in relation to what Linn county proposes to do in the matter of building a bridge across the Santiam river at Jefferson. The judge would not say positively how he felt about it himself, saying he would leave it entirely with the two commissioners, but he thought, while no final decision had been given, that the court would be opposed to it. The Linn county authorities do not feel exactly easy over the position in which they find themselves and would evade it if possible. Albany has, even without any bridge, enjoyed considerable Marion county trade from the vicinity of Jefferson and now that this city and county exhibit sufficient unselfishness to bear their share of the expense of a bridge, at a point eighteen miles from Salem and only about eight miles from Albany, the people of the latter place feel the awkwardness of their refusal to respond. The matter was allowed to pass over at this month's term of their county court without public note or comment, the members of the court being afraid to burn their fingers with it. It will probably come up at the February term, however, and then Linn county's ideas of public improvement will become apparent.

AN EMINENT ACTOR.—Daniel E. Bandmann, who is to appear as Othello Wednesday night is an actor of fine reputation. The November Harpers monthly magazine in an illustrated article on the Hamlets in America mentions Bandmann in a complimentary manner, speaking of his acting as effective and powerful and mentions him as one of the most eminent of the exotic actors in that character of this age in the United States. He is probably as good if not better as Othello. Our people should show their appreciation of the privilege of having a first-class troupe among us by giving Bandmann a big house. People not in the habit of attending the usual run of theatrical performances may well see Othello performed.

MISS COOTHWELL.—Miss Coothwell's second elocutionary entertainment was attended by a smaller audience Saturday evening, but it was a well pleased one. Her recitations were presented with great power. The local part of the program consisted of piano solos by Misses Anna Houch and Lora Vance, a duet by Mrs. C. O. Lee and Mr. Hart, and two vocal solos by Prof. Lee, all heartily applauded.

WITH OPEN EYES.—The Jefferson Review, G. A. Sanford, editor, has arrived. It will no doubt do honor to our thriving Marion county neighbor. He was one of two of the Examiner reporters who volunteered to rescue a fisherman from off a rock in the ocean directly opposite the life saving station. —Yamhill Reporter.

AN EXCITING ARREST.—This forenoon Marshal Hoffman received a communication from Eugene notifying that a warrant had been issued for W. F. Reed, and requesting him to arrest him at once. Reed was described as being about 5 feet 5 inches tall, with light mustache, and wearing slouch hat. He is one of the Seattle timber land swindlers who has been operating successfully around Junction City and other parts of Lane county. The modus operandi is to locate men on government land, charging fifty dollars for the operation. None of Reed's representations, it is said, were true, and the whole business was pronounced a fraud. Some of the victims applied for a warrant for Reed's arrest; but he had left that county. Marshal Hoffman found a man answering the description and attempted to arrest him near the Russ House, when he ran like a frightened deer, the Marshal after him together with a shot from his revolver to frighten him, and fifty or sixty citizens. The man ran under the wire works and hid somewhere, and could not be found. He was afterwards seen going Eastward. At the time of going to press he had not been captured. The affair caused considerable excitement for awhile.

MILL CITY.—Mill City has a population of 200 souls. This said not long since the census was taken and on summing it up it was found there was 198 persons living in the city, but early the next morning one of the citizens rushed into the presence of the census taker and exclaimed: "You will have to do your work over!" "Why?" says he. "Because, the old woman has twins, which makes just 200!" It has 32 dwellings, a saw mill that is the pride of the city and an honor to the country; it has three large circular saws, one pony saw; the capacity of which is 50,000 feet per day. Lath mill with 25,000 capacity per day. Shingle mill cutting 20,000 shingles per day; three planers and a gauge edger, which employs 20 men when in operation. 2 dry goods stores, 1 drug store, millinery store, 2 hotels, blacksmith shop, post office, telegraph office, jeweler shop and butcher shop, boot and shoe shop, and the inevitable of course, a saloon. —Cor. Silverton Appeal.

THAT R. R. SCHEME.—Saturday we mentioned a railroad scheme in connection with the Narrow Gauge. The following is from the Silverton paper, and shows that there is some fire in the matter:

Last Friday an Appeal reporter had the pleasure of meeting with Hon. J. B. Pengra and Col. T. I. Wallace, who arrived in this city. A part of the object of these gentlemen in visiting Silverton is to get information as to the best route from Silverton to Portland. There are several routes, and much will depend upon the inducements offered the company in the matter of right of way and land for depot buildings. The O. R. Y. will be changed to a standard gauge by the addition of a third rail, and substantial changes will be made in depot accommodations along the line. All questions as to the route Southward have been settled. The road will turn Eastward from Springfield, thence along the Pengra survey to a point on the line of the Central Pacific.

A PURE LIFE.—Rev. I. D. Driver besides delivering two sermons at the M. E. church, also spoke to a large audience of young men at the Y. M. C. A. Hall, Sunday afternoon. His subject was "A pure life," and he talked without gloves, giving facts and advice that anyone may well pause at and heed. Rev. Driver is one of the best read and ablest divines in the United States. His researches cover all fields, so that his addresses are always alive with vital facts of interest. He is peculiarly an aggressive talker.

WANTED AT EUGENE.—Last week a tramp in this city excited some attention on account of the large amount of small change in his possession. Inquiry along the road revealed the fact that he was probably the man who robbed a till at Eugene City. A warrant was issued at that city and Saturday, by orders from there, Marshal Hoffman arrested the man, and a Eugene official came to Albany to day and took him back.
