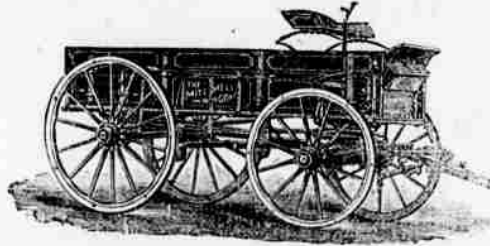

## It is a curious fact that the Samoan Treaty

framed by the two leading Protectionist nations of the world, China excepted, should provide almost unlimited free trade for this poor people. Heavy duties are laid on intoxicating liquors, tobacco, firearms and gunpowder, but general merchandise is subjected only to a 2 per cent revenue tariff. If Commissioners Phelps and Kasson had been true to their party they would have insisted upon free liquor and tobacco and a 47 per cent tariff on other merchandise for the Samoans, on the high moral ground that the tariff would tend to cheapen general merchandise and no tariff to enhance the price of whisky and cigars. But in truth, of course, Germany and the United States wanted as free a chance to trade with Samoa as possible, and England being naturally agreeable, the latter's economic policy triumphed.

James G Blaine, jr., who has been appointed clerk of the Committee on Foreign Affairs of the House of Representatives, has been educated for the position by a few inglorious weeks as a newspaper reporter, by close attention to the billiard cue and by a few months of service as a locomotive fireman. He is well fitted, therefore, to wear a dress suit in the evening and draw a salary of \$2,190 a year.

The new Chinese Minister at Washington is gradually becoming more sociable. He was very distant and unapproachable at first, but he has thawed somewhat. He will never be as popular as his predecessor, however.
