LOCAL RECORD

BOARD OF TRADE.—A special meeting of the Board of Trade was held last evening for the purpose of hearing the report of the committee on the united plan of advertising the valley. After consideration of the report the following committee was appointed to see how much could be raised in this city for the purpose, a two months trial first to be made: D. B. Monteith, J. H. Townsend and T. L. Wallace. This mode of united advertising has been the best plan adopted in many states, among others California, and if Albany men would see the whole valley grow together they should come to the front liberally. It is a scheme in which Albany is bound to get its share of the results. Only by building up the whole valley can each part receive a permanent benefit. Let the world find out that the Willamette is the finest, most productive, healthiest and best valley in the world for a home, and there will be no question but it will receive a boom. Make it as familiar as the Puget Sound to the world and immigration will be here instead of there. We have the country to back us and the natural resources on every hand, for farming, commerce, mining, manufacturing and business.

A PERILOUS RIDE.—Port Captain Thos Brown was the only Oregon City man who rode the rapids at the Cascades on Sunday when the Harvest Queen was run through, says the Enterprise. He says he left Oregon City with the intention of making the run and that he had to cast off the line and hold on to that dragged aboard. He describes the ride as a wild one in which the boat ran a mile a minute for five minutes. The total time consumed in making the run of five miles, of getting turned and started and making fast below the Cascade was but eight and one half minutes.

Mr. Holcomb says there is no other recourse for the mortgaged farmers of the New England states than to become tenants or go west, as he did himself.—Oregon City Courier.

WIDE-AWAKE ALBANY.

When she started she went with a rush; The world her market now; Her tributary territory as extensive as Rhode Island; Exceptional freight advantages; Recent mining discoveries indicate the existence of another Comstock in the mountains at her back; Forests of the finest timber in the world on adjacent rivers and mountains; Where Oregon's finest grain is raised; Fruit that equals or surpasses the best in the country; Manufactures and industries that have been started within the past few years; Climate and soil.

The above form the head lines to a three column article in Wednesday's San Francisco Examiner, on Albany. As we like to know what others say of Albany, we give a few extracts from the well-written article.

They call Albany the "gem of the Willamette," and never had a gem a finer setting. The towns and villages that surround it are Seho, Lebanon, Brownsville, Halsey, Shield, Tangent, Wells, and a number of other places immediately tributary to Albany. Wheat is of course the main product. The superior quality of the wheat raised in this neighborhood has made it famous in the grain markets of the world, assuring for it the highest price.

But agriculture and lumber are not by any means the only resources that Albany has to depend on. Linn county contains a rich mineral district. In the Cascade mountains there are many valuable mines which have been uncovered, some exceedingly rich with quartz. There is plenty of gold in these veins, and the people are sure that the silver ore will make the place a second Comstock.

There are many undeveloped mines in the region, the surface croppings of which indicate deposits more valuable than those that have been worked. It was in one of the mines of this section that galena was found which assayed \$200 per ton. Selected specimens carry as high as 500 ounces per ton, and one piece of almost solid galena assayed nearly \$800.

In general the quartz is rose-colored, carrying free gold and silver with galena pyrite and zinc blend, and occasionally antimony.

There are immense deposits of coal in the mountains of a quality exceeded by none in the northwest. Three miles from Lebanon, a neighboring town, are some fine soda springs, and to Sodaville go all the invalids of the northwest to tone up their systems with its medicinal waters.

Surely such resources with so many competing markets, all within reach, are enough to guarantee the future prosperity of any city, and well indeed is Albany redeeming her nature's promises. No stranger can look about the city without being struck with the life, activity and vigor with which business is carried on, and with the signs of prosperity everywhere manifest.

It was not until some three years ago that it became apparent that public interest was being neglected and public spirit smothered in the midst of grand possibilities. About that time a joint stock company was formed under the name of the Albany Building Association for the purpose of erecting an opera house, which was soon completed to the credit of the city and satisfaction of all. During the same year the spacious school building was erected at a cost of \$20,000, exclusive of the cost of securing the site, a coveted necessity and the pride of the city.

The advance is even beyond a local retail trade. The flouring mills are supplying a demand from the Sound, San Francisco, and elsewhere. The wire works are shipping their products to all parts of the state and into Washington Territory. The furniture factories, of which there are several, are sending their output abroad in considerable quantities. The iron foundries, two in number, go into the Portland market and compete successfully with the foundries of the metropolis and supply the demand coming from all parts of the state and adjoining territories.

Albany possesses a fine water power. This is furnished by the Albany and Santiam water ditch, or canal, with a capacity of 20,000 running feet per minute, from a point on the South Santiam, 14 miles away to the southeast of here.

STARCH FACTORY PROPOSITION.

The Board of Trade received this noon from the Tacoma Starch & Glucose Co., by E. L. Seannitt, Atty in fact, a formal proposition to locate the plant here and increase the capital stock to \$100,000. The reason for the Co. desiring to change its location is that our valley wheat produces 60 to 80 per cent of starch, where other varieties produce 40 to 50 per cent. A great advantage. The proposition is to establish a plant here with a capacity of five tons of starch and five tons of glucose a day, with a guarantee of a certain profit on the starch manufactured, a large one, 25 to 250 men would be employed, according to the demands of the business. Our citizens are asked to take \$50,000 of the \$100,000 stock, payable in cash to secure it. Our citizens have been declaring very properly that manufacturers are what we want. Here is a proposition from a reliable source, Mr. Seannitt being president of the Washington Bank at Tacoma, and the matter should be thoroughly investigated. A meeting of the Board of Trade will be held in the Council Chambers Monday evening for the purpose of taking action in reference to it.

PENNOYER AND WELLS.

These gentlemen spoke to a large and very enthusiastic audience at the court house this afternoon. The main points in the governor's speech were those made in his Lebanon speech published in the DEMOCRAT some days since. He held his audience bound to the closest attention for more than an hour. Both candidates made an excellent impression upon the minds of the voters. They bring the most cheering news from the south especially in Douglas and Lane where the enthusiasm among democrats is simply remarkable. Republicans everywhere come out to hear them.

BULL DOZING.

BROWNVILLE, May 22nd, 1890.
Last week's issue of the Brownsville Times stirred up quite a hornet's nest in our quiet little town. It, as well as all the other purely independent papers in this valley, has announced itself in favor of Oregon's favorite Governor, Sylvester Pennoyer. Several of its republican patrons took exception to this movement, but most all conceded that this is a free country and that one has the right to vote for whomsoever he sees fit. However one, W. R. Kirk, president of the Eagle Woolen Mills Co., determined to sit down on any such work. So with majestic stride and with blood in his eye he appeared at the Times office and demanded a retraction. On refusal he grew desperate in behalf of his chief, \$ Thompson, and ordered his paper stopped, and further ordered that the small ad. of the Eagle Woolen Mills be removed. Such are the methods adopted by Thompson and those actively engaged in his interest to secure his election. Mr. Kirk is desperate since he has found that he did not immediately succumb to his mandate and swears vengeance. To the credit of the Board of Directors of the Eagle Woolen Mills Co. be it stated, they very emphatically informed "boss" Kirk that the Woolen Mills were not a political machine in any one's interest, and as firmly set down on the would-be political boss. Republicans generally do not endorse his action, and many of them cannot endorse the man in whose behalf this attempted boycott was made. The Times still lives. FREEDOM OF THE PRESS.

FARM HOUSE BURNED.

This forenoon the large and handsome farm residence of Mr. E. G. Cox, six miles from this city, was discovered on fire by Mr. Jos. Bilyeu, who summoned the neighbors, and an effort was made to at least save some of the household goods; but only an organ and a sewing machine were gotten out, when the flames became too hot to get anything else. The building and everything else in it were entirely consumed. The large barn, though on fire several times, was saved by a hard effort. The house and contents were worth at least \$2000, the place being one of the best in the country. An insurance of \$1000 in the State of Salem, will partially cover the loss. At the time of the fire Mr. Cox and family were in Albany, having come in early in the morning. The fire, it was thought, started from the fire place, having probably communicated with the carpet, thence to the wood work.

ACTED AS INTERPRETER.—Recently a correspondent in the Lebanon Express gave an account of some trouble in the Evangelical Church at Sweet Home, and among others mentioned Mrs. Rinehart as a participant in the row that caused Rev. Yeast to leave the church. A son of Mrs. Rinehart told the DEMOCRAT that his mother had nothing to do with it more than to act as interpreter for John Spring, the leader in the trouble. As the DEMOCRAT copied the item it gives this side of the matter.

DROWNED IN A SPRING.—Wm Perkins, a citizen of Yamhill county, who lives near North Yamhill, met his death last Monday in a peculiar manner. He had been away from home visiting for the day and upon returning unhitched his horses and led them to the spring near by for water. While standing near the bank of the small pool of water he was taken with a fit, to which he was subject, and fell into the water. Before assistance could be rendered he was dead.
