

# Healthfulness & Water Supply OF MINTHORN.

In the selection of a residence location no element is so important as that of healthfulness, and no single element contributes so much to the healthfulness of a locality as water supply. In this respect Minthorn Springs is easily superior to any residence locality in the city of Portland. It is high, and drainage is complete. The water supply is from a spring capable of abundantly supplying 25,000 people with water. A distance from the river of one-half mile places it out of reach of malaria. A system of water works will at once be constructed, so that parties building will have a abundant supply of pure cold water direct from the springs.

Some Facts in Regard to Its Location in Reference to the Business and Employment Centers.

PORTLAND is the great manufacturing center of the Northwest. Portland's坐位 of power for manufacturing purposes is at the falls of the Willamette river at Oregon City. Already the manufacturing interests of Portland, mostly conducted at Oregon City, produce an income of \$20,000,000 annually. This is a most manufacturing center distant one-half mile from Minthorn Springs, while Portland, the great commercial metropolis and business center of the North Pacific coast, is 35 miles distant to the opposite direction. It requires no stretch of imagination to see that the country intervening between Portland and Oregon City [its base of power supply] is the natural residence location of the business men, and busy workers and wage earners who keep in motion the various enterprises, of the commercial and manufacturing interests of the North Pacific coast.

**NEW LAKE DISCOVERED.**—Capt. M. W. Hunt and the party he accompanied on the trip in the Cascades, returned last evening and report a most delightful trip. The lake has beautiful, gravelly shores and is not surrounded by the thick underbrush and scrub growth characteristic of almost all the mountain lakes. It is furnished by the snow water from old "Jack," is clear, cold and deep, and has no fish that the hunters could discover, but perhaps the fish heard them coming and concealed themselves. The party christened it Bowman lake, in honor of one of their number.—Salem Journal. The lake has undoubtedly been seen a great many times before, as the country has been explored in all directions.
