There are many nice things about getting married; but one of the drawbacks is for the people with youthful proclivities to immediately be treated as antediluvians and excluded from all the innocent enjoyments of life. Some people do not care. Those who do should not be made fossils. Association of married and unmarried people should be a benefit to both, and particularly the latter.

On Wednesday Mr Wheeler, in accordance with his contract with Lane county returned to sheriff Nolan the list of unassessed land in Junction precinct. He found that 115 town lots, improved and unimproved, and 6702 acres of land had not been assessed. As he completes a township he delivers the list to the sheriff.—Guard. Let Linn county consider what it is annually losing in taxes.

The bill permitting the Oregon Pacific to issue bonds has passed both houses of the Legislature. There are said to be strong grounds to believe that work will be pushed ahead. Already arrangements are being made to improve the road bed to the front. But, as yet, this is mostly guess work, the same as it has been, and was a year ago, and the Democrat doesn't believe anything is made by sailing false colors in such matters. The after effect is apt to be backacting. We are glad the indications are good for something being done this year.

Many newspapers in the state are pleading for support by legislation and otherwise in a very supplicating manner. The Pendleton E. O. gets down to business on the subject in the following manner, which the Democrat fully endorses: "The people do support the newspapers in just the proportion that the newspapers advocate the people's interests. The paper must first do its duty before it can expect the people's appreciation. The East Oregonian feels that it is talking from experience. It never had a better support than it is enjoying at the present time, and it never was so earnest in its defense of the people's rights. The people are grateful because they are intelligent. They never fail to respond to a worthy and deserving press. The press of Oregon should first serve the people of Oregon and the people will be quick to do their duty."

STATE LEGISLATURE.

SALEM, Or., Feb. 13.—President Simon signed the Australian ballot bill. Most anything seems to be able to pass the house. Bills submitting the re-location of the county seats of Coos and Grant counties easily passed that body, but in the senate were indefinitely postponed.

Rep. Jennings' new railroad commission bill provides for a commission of three members, one of whom shall act as clerk, at a salary of \$1500 each, except the member acting as clerk, who shall receive \$500 additional, for clerical services. This would make the railroad commission cost the people \$5,000 per year, when it now costs \$9,500.

In the house a bill providing that street railways may locate their lines on private property, failed to pass. Also a bill allowing suits against the state. Cresson's bill allowing the O P to issue bonds for more than 20 years, passed, having already passed the senate. Concurrent resolution for \$1500 for Indian war history, to be compiled by Mrs F F Victor, passed. Bill by Hall for a constitutional convention, passed. Bill by Starr for the prevention of lottery games passed.

In the senate a large number of house bills were read first time, including Henry's wagon road bill and Moore's World's fair bill. Senate joint memorial asking for \$25,000 for a salmon hatchery at headwaters of Columbia or Snake river, and for an expert to investigate the habits of salmon, were adopted.

A bill introduced by Fulton passed the senate, which prohibits anyone except citizens of the United States, or those who have declared their intention to become such one year previously, or citizens of another state who have resided six months in this state, from fishing for salmon or sturgeon in any of the waters of the state.

Under the reapportionment bill Linn county would get 3 representatives and only 1 senator. Marion would get 2 senators and Multnomah 5, all other counties 4 each. The bill making Portland a port of entry is an important one, and will become a law.

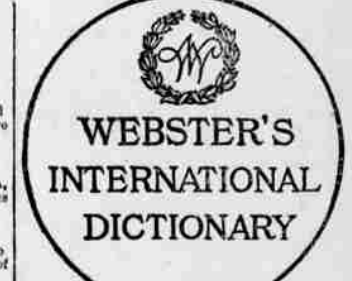
