LOCAL RECORD.

Albany, June 17, 1893.

A SMALL COLLISION.—When the overland arrived at Albany this morning two or three hours late, the freight train was on the main track, with the caboose opposite the baggage room. The engineer of the overland did not discover its presence until after passing the water tank, when he reversed the engine; but the air brakes refused to come to rest in good shape, and the train crashed into the freight at a moderate rate of speed, fast enough, though, to shake the passengers up and throw some of them over the seat in front of them. The caboose was elevated at an angle of about 45 degrees, and the two next cars derailed. The engine of the overland had its cowcatcher twisted somewhat. The fireman jumped from the engine and escaped uninjured. The engineer, who remained at his post, also escaped. Everybody escaped. The damage was not very serious, and in less than an hour the overland had left the depot.

A PECULIAR CASE.—A case was brought before the Lane County Medical Society, Monday, that puzzles all the physicians, and there is not a similar case on record. It is a child four years old living at Cottage Grove. One half of its body is larger than the other, the right side being the larger. The dividing line is through the center of the nose, and through the entire body exactly in the center. One eye is larger than the other, one side of the nose larger than the other side, one arm and one leg longer and larger than the other arm and leg. In addition to this peculiar growth is a tumor in the stomach, and by its growth the heart has been pushed up nearly into the throat, and the liver been pushed over to where the heart should be. The child has been in this condition since its birth, and as the doctors can do nothing for it life will be short, —Guard.

LIFE IN A PENITENTIARY is not and should not be a holiday affair; though some convicts seem to think it should be. The following from the Statesman is interesting, and it also brings in a name familiar to Albany people: J D Shepard got out of the penitentiary a few days ago, his sentence of two years having expired. He was sent up for larceny from the person—having stolen \$50 from a man in Umatilla county. He served twenty-one months. He came to the Statesman office yesterday to complain about the treatment of men at the penitentiary. He says the men don't get enough to eat, nor changes of clothing as often as they should. He said he had only two pairs of pants while he was there, and he complained of the suit of clothes he got when he left. He said he had to work when sick. He said a convict had to "stand in" with Dillon, the "con" tailor, to get new clothes, or "Doe" Saunders, "con" doctor, to get a lay-off when sick. These are both life men, Shepard said he was guilty of the crime of which he was convicted. He is evidently of the opinion that the penitentiary should be made a sort of pleasure resort—a pleasant place for the convicts temporarily exiled from society to spend their vacations. Shepard was raised in Salem.

DRUNK TURKEYS.—Many quaint and curious stories have recently been published in various sections of the state, and the Baker City Blade, which desires to keep up with the procession, tells of a lady of Haines, Baker county, who threw out some branded cherries which had spoiled. Soon after her little boy came in and told her their turkeys were all dead. She went out, and finding the birds lying stiff and still, plucked them to save the feathers and threw the bodies into a corner of the yard to be buried. In an hour or two the lady was horrified to look out and see the nude turkeys walking about, seeming much embarrassed.

PAPER MILLS.—According to the following from the Oregon City Courier paper mills must be paying institutions: A gentleman familiar with the paper business in the eastern states, says the mills there pay \$12 per ton for straw and sell the strawboard for \$35; here, on the other hand, the Crown mill pays \$4.50 per ton for straw and sells the board for \$50 in San Francisco. Wages, he says, are higher in the paper mills east than they are here. These facts go to show that the manufacture of straw paper at Oregon City is a booming success. There is room at our water power for more paper mills.
