LOCAL RECORD.
30,000 YEARS AHEAD OF THE SOUND.—Dr Henry W. Coe, formerly of Mandan, N. D., writing to a Denver paper, says: "The Willamette valley is the garden spot of the world. The yield here is simply enormous and never failing. This whole valley was no doubt at one time under water, the ocean water flowing back with the tides, and in time the wash of the hills gradually filled in the valley, making the soil what it is now. If we were to imagine Puget Sound in, say twenty or thirty thousand years from now, after it has been narrowed down to a stream into which the mountain brooks pour their contents and flow on to the ocean, we might perhaps see a country such as this valley of the Willamette. As I can't wait for that to occur, I shall have to remain in such a valley which is already formed."
This is closely settled in some spots, but as a whole it has not begun to be developed. It is strange to me to see other and less favored regions settled during the last twenty years and this region so neglected.
In one district in the valley, within a radius of six miles square—and this radius not half under the plow, probably not a quarter—last year there was paid in more than \$400,000 in gold for its crop of wheat. It does not take a large area to make a living on.

17 VERSUS 71.—This noon Mr. and Mrs. John Foster, of Corvallis, passed through Albany on their wedding trip, and a DEMOCRAT man had the great pleasure of witnessing the apparently happy couple as they were seated in the Portland train together, possessing many of the characteristics of a bride and groom, though the latter is old enough to be the grandfather, almost great grandfather, of the former, their respective ages being given as 17 and 71 years. Mr. John Foster and Miss Ida Dalepa were married at Corvallis yesterday, and this event was the absorbing topic of conversation there on account of the extreme difference in their ages. Mr. Foster's hair is white with age, while the bride, the daughter of a Corvallis restaurant man, is yet in her girlhood, a bright, pretty looking girl, too. The groom is a pioneer of Benton county, is worth about \$80,000, and is well known all over the state, being a prominent stock man. It is reported that there was a strong opposition to the marriage by the groom's children and relatives, but he thought himself old enough to use his own judgment, hence the marriage.

MYRTLE CREEK MINES.—Between 50 and 100 men are now at work at the Myrtle creek mines extending the water ditch to connect with the headwaters of the Umpqua river, when an abundant supply of water will be obtained. The four inch giant nozzle used at first has been changed for a six inch nozzle, which is kept running night and day. The stockholders are becoming more enthusiastic, if such a thing is possible. Another clean up will be made in three or four weeks.—Eugene Guard.

THE OREGON PACIFIC.

The Oregonian publishes from the New York Herald a two column article on the present difficulty about this road, which will be watched with great interest by our citizens. The Herald says: "The first gun was fired when Bondholders Joseph Wharton, Samuel S. Sands, John I. Blair, Alexander Brown and Dillwyn Parrish printed an advertisement calling upon all other men who held the company's bonds to join them in an effort to oust Receiver and ex-President T. E. Hogg and his associates from control of the enterprise. The advertisers claim that \$15,000,000 worth of bonds has been eaten up in the process of building and equipping less than one fourth of the railroad, whose total length shall be 600 miles and whose total cost was estimated not to exceed \$15,000,000. Receiver Hogg and his partners declare that the \$15,000,000 worth of bonds already issued under their administration has been legitimately used in building the road. Both sides have settled down for a long siege. Whoever wins will have control of a railroad that runs through a rich country and has no parallel road to fight."

It then gives a history of the road, the names of the kickers, and the advertisement. The directors are given as follows: John I. Blair, Blairstown, N. Y.; Osgood W. Blair, New York; Norman S. Bentley, third vice president, treasurer and assistant secretary, New York; H. C. Atwood, George S. Coe, president of the American Exchange National Bank, New York; K. S. Minturn, N. Y.; R. G. Hazard, Peacocks, R. I.; Alexander Brown, Baltimore; William M. Hoag, vice-president, Corvallis, Or.; T. E. Hogg, president; Wallis Nash, B. W. Wilson, Thomas Graham, Zephin Job, G. R. Farra, T. E. Cauton, B. R. Job, E. A. Abbey and A. Hackleman, of Corvallis, Or. Mr. Bentley makes a statement justifying the action of the O. P. managers, closing with the statement: "that some of the gentlemen who permitted their names to be used in connection with the advertisement have very large interests in other companies, which interests might be promoted by a sacrifice of their interest in the Oregon Pacific Railroad Company." Welsh had forgotten he was a director, Minturn said he had faith in the present management. Mr. Coe when asked about the \$11,000,000 over issue of bonds, said that was merely technical. He was merely a bondholder. Between \$7,000,000 and \$8,000,000 cash has been realized on the bonds, and \$10,000,000 cash has been spent. "Experts who have been over the line have reported to us," said a dissatisfied bondholder, "that the cost of building the 140 miles of road could not have cost more than \$4,000,000. Where, then, are the \$11,000,000 left over?"
