ORDINANCE NO. 217.

An ordinance authorizing a loan for a term of years; providing for the manner of issuing bonds therefor, and the time and manner of paying the same, and authorizing the sale thereof. The people of the city of Albany do ordain as follows: SECTION 1. That in order to provide funds to pay for the building, constructing and maintaining of a system of sewerage for the city, and to pay for the building, constructing and maintaining by the city, of a free wagon bridge across the Willamette river, at the northern terminus of Calapooia street, in the city of Albany, there be issued one hundred and fifty (150) negotiable interest bearing bonds, in the sum of five hundred dollars each, payable on the first day of September, 1911, with interest thereon at the rate of six per cent per annum, payable semi-annually, viz: On the first day of June and December of each year.

SECTION 2. The bonds mentioned in the foregoing section shall be numbered and entered in a book to be kept in the recorder's office, and shall contain a provision pledging the faith of the city to the full payment in United States gold coin of the principal and interest thereon, at the office of the city treasurer, at the time or times the same may become due, upon the surrender of such bonds or the coupons for the interest attached thereto.

SECTION 3. To each of said bonds shall be attached forty (40) paper coupons, bearing the same number as the bond and representing the interest thereon for each consecutive year, from the first day of September, 1891, to the first day of September, 1911, and payable on the date therein mentioned, at the place and in the manner provided by section two (2) of this ordinance.

SECTION 4. The bonds hereinbefore mentioned shall be signed by the mayor and attested by the recorder; and the recorder is hereby authorized to sign the coupons attached thereto. SECTION 5. The treasurer of the city is hereby authorized and empowered to advertise for, receive proposals and sell to the highest bidder at such times and in such amounts as he may deem advisable, all or any portion of the bonds to be issued under the provisions of this ordinance; Provided, that no bond shall be sold at less than par (interest off) without the consent and direction of the city council.

SECTION 6. Upon making a sale of any of said bonds, the treasurer shall notify the mayor of the terms and conditions of such sale, and upon receiving the purchase price thereof the treasurer shall give the purchaser a receipt therefor, which shall be sufficient authority to the mayor and recorder to sign and deliver the requisite number of bonds as provided in this ordinance.

SECTION 7. That of the entire amount arising from the sale of said bonds or any portion of the same, forty (40) per cent, thereof shall be set apart and be used by the city for no other purpose than to pay for the building, constructing and maintaining of a system of sewerage for the city, and the remainder thereof or sixty (60) per cent, of the entire amount arising from such sale of said bonds or any portion thereof shall be set apart and used by the city for no other purpose than to pay for the building, constructing and maintaining by the city of a free wagon bridge across the Willamette River at the northern terminus of Calapooia street in said city.

SECTION 8. This ordinance shall be in full force and effect from and after its approval by the mayor. Passed the council July 28, 1891. Approved July 29, 1891.

An ordinance authorizing and directing the Mayor and Recorder to enter into written articles of agreement with the Portland Bridge and Building Company, of Portland, Oregon, their associates and assigns, for the building and completion for the city of a high steel free wagon bridge across the Willamette River, at the northern terminus of Calapooia street, in the city of Albany. The people of the city of Albany do ordain as follows: SECTION 1. The Mayor and Recorder are hereby directed, authorized and empowered to enter into and sign on behalf of the city written articles of agreement with the Portland Bridge and Building Company of Portland, Oregon, its associates and assigns, for the building and completion by said company, its associate and assigns, for the city, of a high steel free wagon bridge across the Willamette River at the northern terminus of Calapooia street, in said city of Albany, at a cost not exceeding \$83,350. Such bridge to be completed within 4 months from the signing of such articles of agreement by said company and said Mayor and Recorder.
