LOCAL RECORD.

THE FIRST LOAD OF WHEAT.—It is always an interesting item to know who brings the first load of wheat to Albany. Bright and early yesterday morning Mr. H. D. Burkhardt appeared at the Red Crown Mills with the first load of the season, and since then a number of loads have been stored. Capt. Lanning informs the Democrat that it is of fine quality, weighing in every instance, so far, the best yet received weighing 60½ bushels. Last year the first load was brought by Mr. James Thompson on July 2nd, and Frank Ketchum's wheat averaged 28 bushels per acre. It is reported that N. Bridges has a 14 acre field that averaged 50 bushels per acre.

FATAL ACCIDENT.—Yesterday, near Lake, Peter Halfpenny was hitching a team to come to Albany when the team sprang forward, knocking him down and running over him with the wagon. After the first wheel had crossed his body he raised his head, getting a terrific blow from the cross bar, which fractured his skull, causing his almost instant death. Halfpenny and F. E. Main were in the hay business and were then at work on the farm of William Mospeil. The deceased was a steady, industrious man, about 40 years of age. He was brought to Albany where funeral services were held at the Catholic church.

MORE OF IT.—A dispatch from Cleveland, Ohio, says Judge Hamilton has decided the injunction case against the Evangelical association. He enjoined the board of publication from making up deficiencies in salaries of Bishops Escher and Bowman or paying money to Illinois, Des Moines, Oregon or Platte river conference. The court found that the suspension of Bishops Escher and Bowman was according to church discipline; that there was no evidence of prejudice or fraud on the part of trial conference. The decision is a decided victory for the minority faction.

A HORSE'S KICK.—On Sunday last Miss Frankie Rice received some severe kicks from a horse. Miss Rice had driven to the Harris school house, situated near Rowland, to attend meeting, and was attempting to hitch the horse, which, becoming frightened, kicked the young lady in the breast, and also fractured one rib. The many friends and school mates of Miss Frankie, who passed the winter at Brownsville attending our school, will sincerely sympathize with the sufferer. —Brownsville Times.

WILL BE CHANGED.—Beginning about Aug. 5 trains on the Oregon Pacific will leave Albany for the front at 10 o'clock p.m. instead of at 8:30 a.m. as now. They will remain at Gatesville until morning and arrive in Albany shortly after 11 o'clock. In fact the old time table will be established. Twice a week, Wednesdays and Saturdays, the train will go to Coe, remaining over night at Halstead. This is done at the request of a large number of residents along the line.

A LONG RIDE.—The Princeton News of last Saturday had the following: A messenger came to town yesterday morning for a doctor to treat Mrs. Bess of Buck creek, who is said to be ill with typhoid fever. A distance of 120 miles was covered by the messenger who came in twelve hours. The trip was made on horseback, with a change of horses five times, the last twenty miles covered in one hour and thirty-five minutes. The doctor's bill will be as long as the ride.

HUNTING A NAME.—A postoffice is soon to be established at the Santiam mines and just now creation is being ransacked for a name for the new office.
