GOOD EVENING.

WHOLESALE ARRESTS.—Yesterday morning City Marshal Sam Miller, H. A. Whitman, a jeweler, and Dick Falkner, all of Hubbard, took two teams and went to Battleville, where they obtained a crowd of white men opposed to Chinese hop pickers and returned to Hubbard at noon. They asked permission of the McKinney brothers, who have a large hop yard near Hubbard, to send away the Chinamen employed in their yard. The McKinneys told the mob that they had leased the yard to the Chinamen and had nothing to say as to whether they should remain or go away. Then Miller, Whitman and Falkner drove out to the hop yard and captured eighteen or nineteen Chinamen. They carted them to town and sent them away on the afternoon train—six being sent to Gervais, where it is understood they came from, and eleven or twelve to Portland. The full fare of each Chinaman was paid. Who put up the money for the fares is not known, but it is supposed the citizens of Hubbard contributed the cash. When Sheriff John Knight was in the hop country Tuesday he appointed L. D. Ehler and Byron D. Grimm deputy sheriffs. When the raid at the McKinney yard became known these deputies organized a strong posse of citizens and went after the rioters. It was a well-organized and efficient posse and so energetically did it work that soon eighteen of the agitators were under arrest and locked in the Hubbard armory. A telegram was sent to the sheriff and he immediately left for the scene of trouble, arriving there about 6 o'clock in the evening. Whitman was then arrested, making the nineteenth man. Four or five other prisoners, including the ring-leaders in the difficulty, are expected to be arrested and brought to Salem this morning.—Salemman.

THE WHEREFORE.—Referring to the postponement of the sale of the O. P., Mr. Mulcahy said to the Times man, of Corvallis: "There is no money now with which to buy a railroad. It is our object to sell the road for enough money to pay up all back indebtedness at 100 cents on the dollar. To sell the road now, when there is no money to be had, would force the claims against the road into the same distress that confronts the claims against many of suspended banks in the country, and no more than thirty, forty or fifty cents on the dollar would be realized. While in the east, our attorney, Mr. Geat, saw the bondholders and they expressed surprise and satisfaction at the showing the road is making in the face of the hard times. People in this country do not give us credit for what we have done. From the earnings of the road we have made more repairs to the bridges than have been made in the preceding eight years. Many large bridges, including the approaches to the Albany and Santiam bridges, have been completely renewed. All bridges east of Albany are good for five years to come. We have put nearly sixty thousand new ties into the track and repaired the rolling stock, which is now in first-class condition." With reference to the report that the O. P. would put on a line of steamers to Honolulu, Mr. Mulcahy declined to impart any information other than that the scheme was not ready for the public. "It involves another railroad," he said, "that would be a transcontinental line and would be a great help to the Oregon Pacific."

One of the facts learned during the last decade is that nine bonus propositions out of ten are fakes. In the haste to enterprising the people of the Pacific Coast particularly have been very glibly.

NEW YORK LETTER.

NEW YORK, September 1st, 1903.

A change for the better has certainly transpired during the past week, in the financial world. The stringency in currency has relaxed to quite an encouraging extent. There is no doubt that the action of the house in passing the repeal act of the Sherman silver law by so large a margin and a majority came as a stimulant to the distressed financial condition of the country. It is expected that when the senate has passed the repeal the discontinuance of silver purchasing will revive the lost confidence in money circles.

It is gratifying to know that the unruly and cowardly anarchists have failed or ceased in their attempt to urge the vast army of unemployed to use violence in the city. Perhaps the firm word of the law, as understood by the police department, has had its effect upon the restless and cowardly foreign element which caused so much trouble in instigating a riot at Wallhalla hall last week.

As September is rapidly approaching, activity among politicians is renewed and the prospects for an interesting and animating campaign are very bright. The democratic state committee has met and agreed upon Saratoga as the convention city and Oct. 4 as the date. All the state officers with the exception of governor and lieutenant governor will appear on the ticket this November. The republican state committee has not assembled as yet, but the convention of the g. o. p. will probably be held in Syracuse during the latter part of September. The importance of this year's election is recognized by both parties, as both branches of the legislature will be voted for, and the loss of either branch to the democrats would mean a curtailing of the already great power in the hands of the Tammany wing of the democracy. A constitutional commission to revise the state constitution will also be chosen.

Another great race was run on Tuesday at Sheepshead Bay, under the auspices of the Coney Island Jockey Club "The Futurity" for two year olds was the important event and not only was it a great race because of its value, which is \$60,000, but it will receive a prominent place in the chronicles of the American turf. The track was in a fair condition, considering the rain that fell the day before. The threatening weather kept the attendance down to 20,000, who will never forget the eventful day. The sun peered through the silver lined clouds as the twenty starters cantered to the post to battle for the great stake. The best two year olds of the season were among them and a fine picture they did present, resembling a rainbow, as they lined up before Starter Rowe. In the betting the Messrs. Keenes' unbeaten colt Domino was installed favorite, and Hydenabad, also a representative of the Keenes, was second choice, while Mr. Richard Croker's Dobbins was next fancied by the talent. The large field got off almost in a line, with Galilee slightly in front, and around they flew like phantoms. As they entered the stretch Galilee appeared in front with Dobbins and Domino close up. As they neared the last furlong pole Dobbins and Domino gained upon the leader and from there to the wire the jockeys rode as if their lives were at stake. By the grandest riding ever seen on this track, Haral brought Domino under the wire a winner by the shortest kind of a head, Galilee beating Dobbins for second place by a nose. The finish caused pandemonium to reign among the on-

He has proved himself to be the greatest two year old that ever faced the flag. The race also again demonstrated the fact that Fred Haral is the ablest rider on the American turf. It is the opinion of well informed racing men that Haral's finish when defeat seemed inevitable could not have been equaled by any other jockey. The honest little favorite received \$5000 for his services, and he surely earned every cent of it. After the race Mr. Dwyer, who, by the way, lost heavily on the downfall of the Tammany chieftain's colt, offered to bet \$25,000 that Dobbins can beat Domino. Mr. Keene has not decided whether he will accept his great colt. Such a race would arouse unlimited interest in racing circles. It was a game race, honest and without fault, and the greatest horse won. Foxhall and James R. Keene are certainly giving the public an opportunity to witness an honest race, in spite of the fact that there are so many dishonest races run at the eastern tracks since the retirement, by death, of such people as August Belmont, D. D. Withers and Senator Hearst.
