THE WILSON BILL IN THE HOUSE.

The votes already taken on the amendments to the Wilson bill indicate that it will pass substantially as reported or modified by the majority of the committee.

The democrats who are anxious to retain the McKinley abuse of protection for the benefit of the bounty-sharers in their districts, while anxious to have the reform apply everywhere else, mustered only three votes to reinforce the republicans on Monday. Most of those who will offer amendments in behalf of local interests have announced that they will vote for the bill even though it may not be acceptable in all particulars. In a word, the democratic bill has a united party back of it in the house. The pledge of the party will be redeemed, the mandate of the people will be executed, in that body.

This solidification is due primarily to the character of the bill. It is, as Mr Wilson said in reporting it, a moderate measure. It was framed with a sincere desire to deal justly with the whole country. It aimed to relieve industries and consumption of oppressive burdens without disturbing disastrously the conditions long fostered by the government. It therefore became, as its framers frankly admitted, a protective measure. It is a higher tariff than Henry Clay thought necessary for the protection of infant industries fifty years ago. It is higher than the Morrill tariff of 1862. It is nearly as high as the tariff of 1883. It is a less average reduction of a 50 per cent tariff than the republican tariff commission of 1882 recommended in a 40 per cent tariff. It is only in comparison with the McKinley monstrosity, which the people have twice condemned by more than 1,300,000 majority each time, that the Wilson bill seems a reform measure.

The democratic party is prepared to repeal McKinleyism, and the Wilson bill does it. It leaves to labor and to capital all the protection that they need. It deserves the united support of the party in congress. It will if enacted put the democracy in the way of another victory in 1896.—New York World.

The state republican central committee and the congressional committees for the first and second congressional districts are called to meet at Portland on Wednesday, January 31st, for the purpose of determining the time and place for holding the state republican nominating convention and also for the congressional conventions and for the further purpose of deciding upon the apportionment of delegates to these several conventions. The officers of the state committee are: W. L. Boise, chairman; E. P. McCormack, secretary; and F. M. Mulkey, assistant secretary. The member of the committee for Lane county is W. H. Abrams. T. H. Tongue, of Washington, is chairman of the committee for the first congressional district.

After 50 years of Republican high tariff and currency policies we have a bankrupt Treasury, stagnant trade and little money in actual circulation. There have been three severe panics and only a few years of general prosperity among the producing masses. Let us have a vote on the Wilson bill and a change. Thirty years more of Republican laws would ruin us.

The charge that McKinley has but one speech will no longer hold good. He fires the Northern heart by declaring that the Wilson bill was framed by rebel brigadiers, and then he informs the Southern people that the measure is designed to ruin their particular industries. This streak of versatility is a great innovation for McKinley.

It may seem strange, but there is little doubt that if the democrats should stay in office for five or six years longer Senator Hoar would be as much of an advocate of State's rights as the late Mr. Davis or as any member of the Hartford Convention.

A tax on legacies would go a long way towards meeting the deficit handed down as a legacy by the last Republican Administration.

Very naturally Uncle Sam thinks of the fifty-first congress every time he pokes his hand through the hole in his pocket.

The new issue of government bonds ought to be known as the republican deficiency debt.

WASTING MONEY

Pennsylvania manufacturers have learned so long on bounties that they are behind-hand in shrewdness. Their hogliness has waxed, but their invention has deteriorated. The Protective Tariff League is a literary bureau which supplies by the thousands and editorial for the Republican press, tracts, leaflets and appeals. The bureau began to be active in literary work just after the defeat of the Mills bill by the Republican Senate. The tariff reform cause has grown faster in the five years since 1888 than in the 25 years preceding. The Protective Tariff League has wasted enough paper and postage to have sent a Bible to every family in America. And as far as the record shows it has not made a vote for McKinleyism.

Its latest scheme is an inundation of paper slips which convey this appeal: "Send a postal card to your Congressman to-day urging him to vote against the Wilson free trade bill."

If the Protective Tariff League had not a fatty degeneration of the brain it would not spend thousands of dollars for such a purpose. An immense majority in the house of Congress and a safe working majority in the other are pledged to vote for a reform bill, and the only complaint the constituents of those majorities are making is that the Wilson bill is not free trade enough. That is the complaint about the bill, and the complaint about voting is that a vote has not already been taken. If every Republican voter should send on his postal card not a Congressman would pay any attention to the consensus. The Republican Congress would join his Democratic colleague in joking at it.

These millionaires who can throw away money so freely have made more trouble for labor, have made more cuts in wages and have had around them more distress than all the other employers of the country put together. Pennsylvania labor troubles are chronic. High tariffs do not prevent them and low tariffs do not aggravate them. They go on month in and month out—cut, space, quarrel, lockout, walkout, and sometimes bloodshed.

Such are the Pennsylvania backers of the Protective Tariff League. They are the men who hastened a panic by strangling trade and taxing the incomes of families; who by grinding labor made enough to pay for the car loads of leaflets which go impotently lying through the country. They are not half as wise as the home market they seek to gull. The home market has had enough of paying them a bonus for reducing the wages of labor. The home market is stocked up with undistributed wealth which it is trying to sell to other markets. It is not sending postal cards urging Congressmen to vote against trade and distribution. The home market would rather take the word of Carnegie to the effect that the Wilson bill is not going to hurt iron production, though it may cut down the profits of a few played out mills. It would rather listen to Macbeth or Pittsburg who says that American manufacturers can compete with Europe and sell in European trade centers.

The Wilson bill is here to be voted on, and the country wants a vote on the lines laid down at the election, and wants a vote before the spring opens.

Philadelphia's Protective Tariff League would better follow Carnegie's example—both in his acquiescence to the Wilson bill and his contribution of money to relieve the distress Republican legislation has caused.—St. Louis Republic.

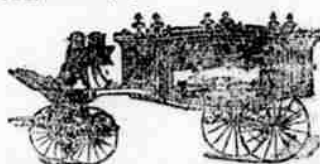
