A RIVERS BREAKS.—It is reported by several who have been there that at the point where the Santiam river is tapped for Mill creek the river has changed its channel for nearly a mile and at the first very high water is liable to break through its banks and pour its floods down the valley, via Turner and Salem, instead of pursuing its course where it now runs and empties into the Willamette at Jefferson. The mill companies at Salem will undoubtedly have the matter looked into. There is an old Indian tradition that the Santiam once flowed through the valley via Annville, Turner, and Salem, emptying into the Willamette at this point. In case of that event transpiring again, the course of Mill creek would be occupied by a magnificent blue mountain river and a large part of Salem would be penetrated by a navigable river.—Salem Journal.

AN ALBANY PATENT.—Mr. Martin Ludwig, with Matthews & Washburn, yesterday received a patent for a revolving chimney top invented by him that is undoubtedly the finest thing of the kind invented. The top, made of galvanized iron, consists of one piece, so arranged that it continually acts as a weather vane, protecting the flue from the elements, and yet ventilated and working so as to cause a steady and even draft, and permitting the smoke to escape unimpeded. Its utility is unquestioned, besides being a model of simplicity. Mr. Ludwig has a good thing in it. Several of them are already up, one on No. 2's engine house.

CITY COUNCIL

Tuesday Evening, Jan. 24.

Present.—Recorder, municipal assistant engineer and Councilmen Whitney, Schell, Pfeiffer, Burkhardt, Marshall and Walters.

The following bills were ordered paid: Frank Wheeler, \$3.00; A. Saylor & Co., \$1.50; W. W. Howell, \$1.25; Mrs. M. Fennell, \$2.20; F. P. Blount, 2.30; F. P. Blount, \$1.24; J. A. McLeron, \$66.20; M. Knox, \$3.80; Mr. Hoffman, \$2.25; W. D. Morris, \$1.00; N. J. Henton, \$47.65; Electric Light Co., \$129.00; Samuel Conn, \$12.00; Mrs. Purdon, \$12.50; council and mayor, \$47.40.

Committee on fire and water reported against moving No. 1's engine to No. 2's, that the cost of running the engine will only be about \$126 a year; that only one team be kept, which will not be paid extra for day service; that the city marshal be paid extra for keeping the same ready for service, or competent engineer and policeman be hired. Laid on table, by vote of 3 to 2, aye, Whitney, Marshall, Walters; no, Pfeiffer, Schell.

Chairman on streets and public property stated that the committee had no streets to report on.

Petition of G. W. Maston and 140 others asked that John Jones be reinstated as engineer and nightwatch. Filed.

Ordinance bill No. 255, fixing the salary of the city treasurer at \$100 per annum was read and passed unanimously.

Ordinance bill No. 286 providing for allowances for fire department. No. 1's and 2's, each \$15 per quarter; H & L Co. and board fire delegates, each \$5 per quarter.

Ordinance 287 providing for licensing agents, canvassers, solicitors and peddlers, and all people soliciting trade except druggists, gardeners, certain book agents and newspaper vendors, was passed. Rates, with two horses, \$7 per day, \$50 per month, \$100 per quarter; with one horse, \$5, \$40, and \$80; on foot \$5, \$30 and \$60. All circuits, \$50 per day.

Ordinance bill No. 288 providing for licensing steam wood saws \$5 per quarter, was read twice and continued.

Ordinance bill No. 289 was read and passed. It provides that all taxes and licenses shall be paid in money, except for present delinquent taxes. All warrants drawn after Jan. 1, 1894, shall be paid in the order in which they are numbered, except warrants for interest on bonds, and warrants for payment of police force which shall be paid first. All overplus at end of year after paying current expenses, shall be applied in paying old warrants in the order of their numbers.

Resolution providing that tax levy be \$5 mills was read and the recorder was directed to notify the county clerk before Feb. 1.

Salem bond of W. W. Howell was approved, also of Henry Taylor.

Contract for doing city printing was let to the Herald at 10 cents per inch first insertion, and 4 cents for subsequent insertions. Bid of Democrat, 10 cts; Telescope, 7 cts.

Contract for printing posters was let to C. W. Watts at 10 cents per job.

Bridge near Hub Bryants was reported repaired at a cost of \$25.

The matter of the removal of No. 1's engine to No. 2's house was discussed, Pfeiffer and Schell taking a very commendatory stand in favor of keeping No. 1's engine where it is. Walters wanted the business men around No. 1's to chip in and help hire an engineer, forgetting they already pay their share of the taxes as much as people around No. 2's. A motion to reconsider previous report was lost, aye, Pfeiffer, Schell, Walters; no, Whitney, Marshall, Burkhardt.

AT OAKVILLE.—A correspondent writing from Oakville says there is no one there sick or hungry; that the Populists met Saturday and organized ready for "biz." They will shoot their first gun tomorrow night, and challenge democrats and republicans to meet them in open debate. Robert Smith is president, and there are some able debaters in the club. The Populists also cut quite a figure, and a woman's rights party is looked for. The water made the roads pretty rough between Oakville and Corvallis, and did some damage. The correspondent says: "We see that the city wants to saddle the bridge on the county. It is no more than could be expected. We have to pay ferriage to get to Benton; it is no more than right Benton should do the same to come to Albany. Why should we pay for them to cross any more than for them to pay for us to cross?"

DON'T DO IT.—Our citizens are united in their opposition to the removal of No. 1's engine to No. 2's house, and in this respect they are warmly supported by Councilmen Pfeiffer and Schell, and partially by Mr. Walters. The action of the council last night means that the engine must be moved. This is an open disregard of the wishes of the people and an injustice to property owners that is being resented in a very live manner. For \$10 more a month there can be an engineer and night watchman appointed, and the special done away with. One of the men can keep his engine ready for work, and do all the special besides, go to the trains, and visit the outskirts; if a fire occurs, the other engine can do service first and the second one be on hand later if needed. This is the proper program.

AN INTERESTING LETTER

The following letter was received on Saturday and read Sunday to the Junior society of the Baptist church. It is from Mrs. Rev. H. H. and is very readable:

SHANGHAI, China, Dec 27th, 1893.

My dear Juniors:

I wonder if you would like to hear of a visit I made, while in Japan, to a real little missionary Sunday School? Well, it was on this wise.

Three or four of our party accepted an invitation from Miss Case, a missionary lady, to attend this school with her, on Sunday afternoon. We were then in Yokohama, and our road led us through a fine little valley—where the rice fields lay on one side of the road and the hills, covered with bamboo and other queer trees on the other. After a delightful walk of two miles we came to a real Japanese village, with its winding, narrow streets and odd little houses, and thronging people. You never saw so many babies as there are in Japan. The women carry them on their backs, and the little girls too. Indeed it was rare to see a little girl, without a baby on her back. That is the way they take care of them for their mother.

Well, pretty soon we stopped at one of the houses and were invited in very politely, and here a queer sight met our eyes. But no, before we went in, we were given a rag with which to wipe off our shoes. The natives all take off their sandals before entering a house, but they don't require this of foreigners. So after our shoes were well wiped off, we entered and stepped up on to the raised floor within. Our missionary friend then stepped over to where an old lady was sitting, and prostrated herself three times before her. This is always done in honor of old age. The old woman returned the salutation and looked much pleased. About forty dirty little children were sitting on the floor in three close rows on one side of the room and singing "When the Corneth I make up His Jewels" in their own language. We were taken over in front of them and invited to sit down. As there was not a chair to be seen, on which to sit, of course we seated ourselves on the floor in true Japanese fashion. I assure you it got very tiresome before the hour was over. I wish, however, you could all have been there and seen with what interest the little black eyes followed the teacher, and how eagerly they listened to all she said. I never saw any little folks in Albany so set quite so still as did these little folks in Japan. Some little girls were there, about as large as Fauna and Alta, with heavy babies on their backs. When the babies cried, the little girls hopped up and down on their toes to quiet them. We did not understand anything that was said, but we did comprehend very well what was being done. The lesson was taught them by a young native woman, and then a native young man addressed them a little while, after which the teacher, each one of the boys shouting his lesson, a little louder than his neighbor in true American fashion. When the prayer was made, every little body was bowed to the floor, and remained perfectly still until the end. I wish that all of my little friends at home could have seen them; I am sure they would never feel like moving around, with open eyes, again, while a prayer was being offered. After several more familiar songs, and the distribution of some pretty cards to each one, these queer little children slipped out and ran to their homes, looking very happy. These little Sunday schools are being held in a great many towns and villages as well as large cities in this heathen world. Through the children, a hold is gotten upon the parents, and thus the word of God is being spread abroad. It has been a great pleasure to us, to attend service in the native churches, and to see the earnest Christian worshippers there, worshipping our God, in the midst of all the superstitions about them.

Now, I must close for this time. We have been most prospered, thus far on our journey. On Saturday, Dec. 28th, we will start on our trip up the great river, reaching Ichang in about two weeks, at which point we will transfer to house boats, and journey several weeks longer, before reaching our destination, Lunan.

I want the Juniors to remember that I am greatly interested in you still, and shall not soon forget our pleasant meetings together. With love and prayers for the prosperity of your society, I am your friend.
