PUBLIC OPINION. Salem Journal: Congressman Dill. of Washington, recently sent a list of questions to his constituents, who live in Spokane and in the regionround about. About 12,500 answers were received. Of these 6412 were for doubling the army and navy appropriations. But this sentiment was not uniform. The city of Spokarle voted in the proportion of 3 to 2 for the increase, while the outlying districts voted nearly 3 to 2 against it Of seven rural counties only one voted for the increase. Even in Spokane county the farmers gave a "no" majority.

In his second and third questions Congressman Dill asked for light on President Wilson's Mexican and European policies-both, whatever their weaknesses, being manifestly at-tempts to keep the peace. Here city and country roughly agreed; the vote favoring the present Mexican policy was more than 3 to 1, and that favoring the European policy a little


