MOUNTAIN CLIMBERS HAD REMARKABLE STORM EXPERIENCE

While Up Three Sisters Were in the Midst of Electrical Currents Pranks.

A striking experience recently was that of fifty-two members of the Mazamas being caught in an electrical storm on one of the Three Sisters. Prof. Warren D. Smith, of the U. O., a member of the party, tells about it in the Register as follows:

"We left camp at 6:45 a. m., reached the summit before 12, where we ate a light lunch. Our view was cut off by the clouds, and we had a limited view of the glaciers on the south of the mountain.

"We could see the storm approaching after reaching the top and started on our descent in an effort to beat it to camp. The first thing that attracted our attention and intimidated that we were in an electrical storm was the fact that the women's loose hair ends were standing straight out on their heads. The men became interested, and by running their hands through their hair noticed a distinct crackling sound similar to that of ruffling a car's back in the wrong direction.

"It was not long before the popping, crackling of the electricity when held up and Alpine stocks reminded one of a wireless station.

"A hard hail storm that was uncomfortable owing to the size of the stones soon overtook us and those that could found shelter behind the large boulders.

"The storm was in the valley largely and we found that the snow was beginning to freeze and knew we must make our way down as soon as possible as it is difficult and dangerous traveling over the snow when frozen. We slid much of the way and down slopes that we would not otherwise have attempted.

"When we reached camp we found that the lightning had visited there too, the cook having received a slight shock while taking a pot off the stove in the cook tent. Our bedding was soaked from the rain, and from 3 o'clock on 12 large bonfires were used to dry us out. We made the trip in two or three hours shorter time than usual, owing to the storm.

NAVAL PREPAREDNESS.

2,500 Rookies Leave for the Sea to Secure Experience in Naval Affairs.

Washington, August 15.—Two thousand five hundred potential sailors—erstwhile private citizens of the United States, whose naval experience heretofore has been nil, started out from western seaports today for a four weeks' cruise in the interest of naval preparedness, a sort of Naval Plattsburg personally conducted by the Navy Department.

The cruise is the first of its sort, for citizens who want to learn navy ways. The men will do just what the Annapolis men do on their cruises: learn how to work a ship and fire guns; and, incidentally, how to keep the brasswork shiny.

Many of the sailors are university men, others are mechanics, radio and telegraph operators, men with and without sea experience. They range in years from a hoisted 19 to an admitted 45, and in wealth from \$4 a week to \$4 a minute.

As planned by the Navy, the cruise will provide a naval reserve—apart from the naval militia—that will be available in time of war. Eight ships are doing the work of carrying the recruits:

The Kearsarge, sailing from Portland, Me., with about 80 recruits; the Virginia, from Boston, with about 463; and from Newport with about 28; the Maine and Kentucky with about 943; the Rhode Island, from Philadelphia, with about 379; the Illinois, from Norfolk, with about 461, and the Alabama, from Charleston, with about 107 men.

PRESIDENT WILSON'S ISSUES.

Secretary Baker Outlines Campaign, Which Will Have Peace as Principal Issue.

Cleveland, Aug. 14.—The issues upon which President Wilson will base his fight for re-election, were outlined by Secretary of War Baker to members of the Democratic county committee at their convention here tonight. He specified that "we are at peace" is the greatest argument they could advance in behalf of the president.

The war secretary's speech followed his reelection as chairman of both the central and executive committee.

Keeping the United States out of the war is to be the principal claim of President Wilson for reelection, according to Baker. He declared "the fact we are at peace" to be the greatest argument of all for President Wilson. The other issues are composed for the most part of the Democratic legislative accomplishments. As outlined by Baker they are: The federal reserve bank act; the rural credit bill; amendment to the ship registry act; the Underwood tariff bill; preparedness policy; the child labor bill, now pending in congress.

The motion picture editor of the Democrat feels a sense of guilt. Yesterday he advised Manager Myers, of the Globe theatre that it was good business to use over half a page in a display ad telling the people of Albany of the importance of the engagement of Mary Pickford at the Globe and assuring him that he would have a packed house. Did he? He did not. And why, is the subject of this story.

It was not the fault of the ad, that the house was not packed. People in all parts of the city knew that Mary Pickford was billed at the Globe for last night and tonight. Ordinarily, if such space were used on Charlie Chaplin, Theda Bara, or some show that was known to be risqué, the capacity of the theatre would not have been sufficient to hold the people. Just note that and watch the crowd that went out to Charlie Chaplin a week from today and to Theda Bara a week from tomorrow.

The real reason we are unable to discover that Mary Pickford never has been a drawing card here. This is doubly hard to understand when, by all odds, all over the country, Mary Pickford is voted the most popular motion picture actress in the world. Her plays are always modest, not too bold or grotesque or loud or loud in any sense. They are plays that mothers delight in taking their children to and plays that young and old enjoy. No matter how weak the plot Mary Pickford, by her incomparable art, always pulls the story through and leaves the observer with a sense of having seen a masterpiece. Her art is by art concealed. She is sweet and innocent looking, and captivates the audience. It will be three months before her next play, "Hulda from Holland," will be shown here, unless some of her older releases are exhibited in the meantime, so if Albany people want to acquire the habit of being Pickford fans tonight will be the last opportunity for a long time.

In "Poor Little Peppina," Miss Pickford does the best work of her screen stage career. Her role thru most of the play is in boys clothes and she takes the part beautifully. As the little American girl brought up in Italian surroundings she handles the difficult role of being an American and acting Italian to perfection. And in the last act she is seen as the
