Tonight and Thursday Fair Continued Cold

ARMORY TO BE A BOWER OF BEAUTY DURING ANNUAL AUTO EXPOSITION

Huge Building to be Decorated in Manner New to Linn County by Experts From Seattle.

SHOW IS LENGTHENED

Three Days to be Given Over to Exhibits and Admission Charge Will be Made; Fine Programs are Planned.

The second annual automobile, truck and tractor exhibit of the Albany Automobile Dealers Association will be even better than was at first planned, and several changes were made in the arrangements at the meeting of the dealers held last evening at the Albany hotel.

The association voted to turn the decoration of the armory over to Jos. M. Riegl, who has been identified with Portland and Seattle and other automobile shows of the northwest for several years and who is capable of making the exposition a success.

In addition it has been decided to add to the entertainment part of the program and some of the best talent obtainable will be employed to keep something going on for the amusement of visitors.

The show has been extended to cover a three day period and an admission charge will be made.

BAKER APPROVES NEW MILITARY PLAN

Compulsory Training and one Large Army Provided in Bill

WASHINGTON, Jan. 21—A. P.—Secretary of War Baker today endorsed the army reorganization bill drafted by the Senate sub-committee. It provides for compulsory military training, the formation of one big army to be divided into citizens' reserve, regular army and national guard.

FAIR BOARD TO ASSIST RACING

Suitable Purses to be Offered for County Fair; Annual Meeting is Held

Future plans and policies of the Linn county Fair was discussed in the first meeting of the new board here yesterday and officers for the ensuing year elected.

A resolution was passed to file an amended articles of incorporation changing the place of holding the fair from Scio to Albany and for providing a board of directors of 30 men. No definite action will probably be taken in making final arrangements for the fair until the complete board of 30 men are secured.

F. H. Pfeiffer was elected president, W. R. Scott, vice president, A. C. Schmitt, secretary, and P. A. Young, treasurer.

Wayne Stewart, who has been identified with the racing program of the fair at Scio, several years was present and proposed a racing program to consist of both harness and running races with purses offered to the amount of from \$2500 to \$3000. An up to date track will probably be built at the old round up grounds.

The matter of permanent buildings to be built and placed under the supervision of the woman's auxiliary that is expected to be organized here in the near future was discussed.

The exhibit of the schools of the county which in times past, has been one of the leading features of the county fair is expected to aid in making a creditable exhibit as the conveniences will be greater than ever before. The grand stand and fence is to be repaired and a base ball diamond in the center of the race track arranged for.

SIXTEEN MORE BLUE PENCIL MARKS ADDED TO LIST OF VETOES ANNOUNCED YESTERDAY; MANY ROAD MEASURES ARE KILLED; EMERGENCY MEASURES COLDLY DEALT WITH.

SALEM, Ore., Jan. 2—By Associated Press.—Governor Olcott vetoed 16 bills today, besides the 16 he vetoed yesterday. Most of the cases were emergency measures. The governor said he saw no necessity for them as no emergency exists.

The straight party bill and many road bills were vetoed, including those in Benton, Jackson, Coos, Klamath, Clatsop and Douglas counties. Bills vetoed today were S. B. No. 7, by Ruston, Multnomah County, changing the conduct of kindergartens; S. B. 30, by the Road & Highway

SIMS REBUKED IN RESOLUTION

Montana Senator Condemns Naval Chief for Making Information Public

WASHINGTON, Jan. 21—By A. P.—A resolution declaring the action of Rear Admiral Sims in making public "official instructions of the most confidential character" affecting international relations, deserved the condemnation of all Americans, was introduced by Senator Walsh, democrat, member of the Naval Affairs Committee today.

Senator Lodge, republican leader, objected to his request for immediate consideration, causing it to be put over.

N. A. BLODGETT CALLED BY DEATH

Well Known Pioneer Resident of Albany Dies at Age of 86

Newton A. Blodgett, one of Albany's oldest and best known residents, died Thursday night at his home at 9th and Washington Streets, where he had lived for the last 35 years. He was 86 years old.

Mr. Blodgett was born in New York December 20, 1833. He came west in 1858, settling in eastern Oregon where he conducted a sheep ranch for several years. He came to the Willamette Valley about 40 years ago and took up his old trade as a miller, operating flour mills at Independence, Harrisburg and Albany.

He was of the sturdy pioneer type and maintained his robust health up to a short time ago. He was widely known and leaves a large circle of friends to mourn his death.

He is survived by his wife and three children, Mrs. J. O. Lee, F. A. Blodgett, of Albany, and Mrs. J. F. Altermatt, of Olinda, Cal. Mrs. Altermatt is expected to arrive in the city tomorrow.

The funeral will be held from the family home Friday at 2 p. m.

The trio were arrested last week at Idanha, two charged with having venison unlawfully and one with killing quail out of season. They pleaded not guilty at their preliminary hearing and their trial was set for January 22.

INAUGURAL TO BE GREAT EVENT OF COLLEGE YEAR ON TUESDAY, JAN. 27

Induction of Rev. A. M. Williams Into Office to be Marked by Appropriate Ceremonies.

MANY VISITORS COMING

Speakers to Attend From all Over Coast; San Francisco Men to Install; Alumni Plan for Big Occasion.

"No more distinguished group of men and women ever gathered in Albany than that which is to be here in connection with the inauguration of Rev. A. M. Williams as president of Albany College next Tuesday," is the way one of the local trustees expressed himself today.

Dr. Howard Agnew Johnson, of Chicago, who is to deliver the principal address of the inauguration ceremonies at the First Presbyterian Church at 2:30 Tuesday afternoon, is a traveler, author, lecturer and preacher. His books are considered scholarly and authoritative on the subjects he has presented, one of which is "Science and Faith," published by Doran & Company.

Board Representative Coming Dr. Warren H. Lanron, of San Francisco Theological Seminary is to be the official representative of the General Board of Education of New York City, of which Dr. Landon is a member. Dr. Landon is to propose the inaugural questions to President Williams and is to induct him into office in the name of the Presbyterian Church in the United States of America.

Collector Miller Sends Forty-five Thousand Letters

Forty-five thousand letters from Collector Miller's office up to last Saturday night, calling upon people of the state to pay their income tax for last year has been sent out. The first payment of the tax is now due and must be paid on or before March 15 or become delinquent and be subject to a heavy penalty. The Federal income tax reports for next year are also to be made out as soon as the proper blanks can be secured. The tax is to be placed on all single or married persons having no dependents with a gross income of more than one thousand dollars each with two hundred dollars for each dependent as an exemption.
