Officers and court officials are instructed to act reasonable in the matter, that is, an officer should not intercept a person unless he has rea-sonable suspicion of him and the reasonable discretion in such cases. 


WAS REQUESTED BECAUSE **OF RECENT ACCIDENT**

Superintendent A. J. Davidson of he Oregon Electric railway has sent out a general notice in the interests out a general notice in the interests of public service and the accommoda-tion of the traveling public, to the ef-fect that parties who desire to blast near the right of way of the road would first take the trouble to notify the railway officials through the agents at any of the stations. In ad-vance of such work the proper pre-catifion will be promptly taken to safeguard the transmission lines in case of accidental disruption. 
